A RESOLUTION TO APPROVE REDUCED-RATE RECREATION FEES FOR ACTIVE MILITARY PERSONNEL

THIS RESOLUTION duly adopted upon this 19 day of June, 2012 by the following vote:



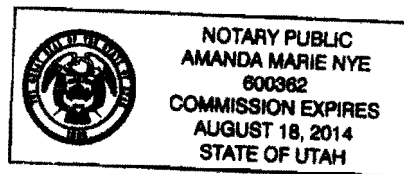
