



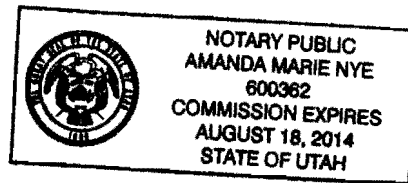

**Logan Municipal Council**

The Municipal Council of the City of Logan, Utah will hold a public hearing to consider an adjustment to the FY 2012-13 budget, appropriating: For the purpose of Union Pacific properties \$681,978 with impact fees and \$82,180 with road funds; \$7,200 for a State grant to upgrade equipment at the Justice Court; \$11,000 for the awarded EMPG Grant; \$100,000 for the awarded JAG Grant; \$193,000 for the Youth Connections Grant.
