Resolution No. 17-51 RDA A Resolution Approving Agency Assistance in the Bear River Association of Governments' Business Expansion & Retention Program

WHEREAS, since 2011, Bear River Association of Governments (hereinafter "BRAG") has administered its Business Expansion and Retention program (hereinafter "BEAR program") in Cache County in cooperation with other regional economic development partners, including the City of Logan and its Redevelopment Agency (hereinafter "Agency"), the goals of which include: 1) retention of skilled, high-wage employment in targeted industry sectors; 2) expansion of existing businesses; 3) fostering new entrepreneurial growth; and 4) creation of a better working relationship between the private sector and public service providers; and

WHEREAS, the BEAR program, utilizing trained business outreach specialists, surveys local employers and entrepreneurs to identify both individual and collective business needs and opportunities, communicating that information to its economic development partners, including the Agency, and thereby facilitating the implementation of appropriate actions and/or programs to assist businesses and ultimately assisting in the realization of the BEAR program goals; and

WHEREAS, many of the surveyed businesses are located in Logan; and

WHEREAS, the Economic Development Committee has reviewed the requested assistance and recommends its approval,

NOW THEREFORE BE IT RESOLVED, that the Agency does hereby approve a grant from the Agency's administrative funds to BRAG, in an amount not to exceed \$5,000, to provide funding for the BEAR program which BRAG administers.

BE IT FURTHER RESOLVED, that the Redevelopment Agency authorizes the Mayor/Chief Administrative Officer to execute the necessary documentation to accomplish the intent of this resolution.
