

RESOLUTION NO. 17-55

**A RESOLUTION APPROVING A NONMONETARY DONATION
TO THE STOKES NATURE CENTER**

WHEREAS, the City of Logan (“City”) is authorized by Utah Code Ann. §10-8-2 to provide nonmonetary assistance to nonprofit entities;

WHEREAS, the Stokes Nature Center (“SNC”) is a nonprofit entity that serves the interests of the citizens;

WHEREAS, the City owns two (2) residential structures and two (2) sheds (collectively “Structures”) located at Second Dam, 3686 U.S. Hwy 89, in Logan Canyon;

WHEREAS, the United States Federal Energy Regulatory Commission (“FERC”) has issued a license to the City authorizing the City to utilize the real property where the Structures are located;

WHEREAS, the United States Forest Service manages the Second Dam property, including the property where the Structures are located;

WHEREAS, the SNC has a need for the Structures and a portion of the real property where the Structures are located;

WHEREAS, FERC and the U.S. Forest Service support the donation of the Structures and assignment of the License to the SNC; and

WHEREAS, the City finds that it is in the best interests of the citizens of Logan for the City to donate said Structures and assign the License to the SNC.

BE IT THEREFORE RESOLVED, that the City does hereby approve the transfer of a _____ to the Stokes Nature Center and authorizes the Mayor to execute the necessary documentation to accomplish the intent of this resolution.
