CITY OF LOGAN, UTAH RESOLUTION 13 -12

A RESOLUTION CALLING FOR A BOUNDARY CHANGE WITH NORTH LOGAN CITY

WHEREAS, the City of Logan and North Logan City have determined that it is in the best interests of the said cities that certain common boundaries between the two cities be adjusted, thus requiring a boundary change to do so; and

WHEREAS, Utah Code Annotated §10-2-419 Boundary Adjustment, allows for such boundary change when conditions stated therein are met.

NOW THEREFORE be it resolved by the Logan Municipal Council that it is their intent to adjust the common boundary of North Logan and Logan as follows:

- 1. The boundary between North Logan City and Logan City, from approximately 550 West to 200 West, shall move south approximately 1,968 feet; and from approximately 200 West to the west boundary of the Main Street right-of-way, the boundary shall move south approximately 3,280 feet. The new boundary shall run along the north property line of property parcels: 04-079-0013 and 04-080-0021, a distance of approximately 2,421 feet, thence along the west property line of property parcel 04-080-0015, a distance of approximately 666 feet, and thence along the north property line of property parcels: 04-080-0044 and 04-080-0045. a distance of approximately 1,242 feet.
- 2. The boundary between North Logan City and Logan City, from approximately 1655 North to 1885 North, shall move east to the west boundary of the Main Street right-of-way. The new boundary shall run along the frontage of the following property parcels: 04-082-0015, 04-177-0006, 04-177-0001, 04-177-0002, 04-082-0013, 04-082-0012, 04-080-0036, 04-080-0025, 04-080-0022, and 04-080-0023, a distance of approximately 1688 feet.

BE IT FURTHER RESOLVED that a public hearing be conducted by the Municipal Council, no less than sixty (60) days from the passage of this resolution, to receive public input regarding this proposed boundary change.

Logan-North Logan Parcel Exchange February 2013

The cities of Logan and North Logan began discussing potential boundary realignment along North Main Street about three years ago. The discussion was initiated by Then-North Logan Mayor, Cary Watkins, and continued between Logan Mayor Randy Watts and Watkins' successor, Lloyd Berentzen, along with members of both administrations and certain council members.

Resulting from these discussions and negotiations, a parcel exchange proposal, depicted by the attached map and database, has been informally consented to by the North Logan City Council and Administration. The intent is to workshop the proposal at the February 19th Logan City Council meeting. Should the Logan City Council consent to move forward, both councils would then simultaneously draft resolutions for their respective cities calling for the realignment. Noticing and public hearings would then follow.

As can be seen in the attachments, Logan would net a loss of 146 acres having a total assessed property value of \$2.5 million, while gaining approximately \$13k in tax revenue annually, based upon current revenue streams.

There are obviously certain infrastructure challenges, as there would be even without realignment. Should you wish to discuss these, contact the appropriate city department.

The value in this proposition, from the Logan standpoint, is primarily the enhanced development potential of land fronting Main Street, given the resulting land depth within a single municipality off of this highway. Further, the boundary realignment along Main Street simplifies the number of transitions from one city to the other, from three down to one. Also, much needed sidewalk improvements along West 1800 North could be installed without an interlocal agreement.


