ResolutionA RESOLUTION APPROVING AGENCY ASSISTANCENo. 13-21 RDAFOR A FAÇADE IMPROVEMENT PROGRAM IN THE
DOWNTOWN REDEVELOPMENT AREA (RDA)

WHEREAS, the City of Logan has adopted policies for assistance in projects and improvements in Redevelopment and Economic Development Project Areas; and

WHEREAS, the City of Logan has adopted principles within its General Plan to preserve Logan's distinctive character and to preserve and improve its Historic Downtown; and

WHEREAS, the City of Logan has adopted the Downtown Logan Specific Plan which encourages the creation of a commercial façade improvement program as part of its accompanying Implementation Plan; and

WHEREAS, the Logan Downtown Façade Program ("Program") encourages, through the use of incentives to be determined by the City's Economic Development Committee, exterior improvements to buildings and building facades in the downtown area bounded by 500 North, 300 South, 100 East and 100 West, which area includes properties fronting both sides of these roads (see attached map); and

WHEREAS, the Logan Redevelopment Agency ("Agency") appropriated \$30,000 annually for fiscal years 2013 and 2014 for the "Program" (Resolution #12-33 RDA); and

WHEREAS, there is currently a "Program" residual balance of \$28,850 for 2013; and

WHEREAS, a carry-forward of these unused 2013 funds would provide greater incentive potential for exterior improvement projects for 2014, allowing the program to have greater impact on the physical and visual characteristics of Downtown Logan; and

WHEREAS, the "Program" encourages further economic development in Downtown Logan; and

WHEREAS, the Economic Development Committee has reviewed the proposed investment and recommends its approval;

NOW THEREFORE BE IT RESOLVED, that the Redevelopment Agency of the City of Logan does hereby resolve to appropriate an additional \$28,850 for the "Program" for fiscal year 2014 for the "Program" to assist eligible building and storefront rehabilitation projects lying within the Downtown RDA boundaries, a subdivision of the broader "Program" area.

Additionally, the Redevelopment Agency encourages property owners to utilize local contractors and vendors whenever possible.




