

**CITY OF LOGAN
RESOLUTION NO. 13-36**

**A RESOLUTION PROVIDING FOR THE FEE STRUCTURE OF TITLE 5 OF
THE LOGAN MUNICIPAL CODE.**

SECTION I: The Municipal Council of the City of Logan finds and declares as follows:

- A. The City is authorized to regulate business activities; and
- B. The Municipal Council is authorized to establish business license fees by resolution.

**THE MUNICIPAL COUNCIL OF THE CITY OF LOGAN, UTAH, HEREBY RESOLVES
AS FOLLOWS:**

SECTION II: The fee structure for Title 5 of the Logan Municipal Code shall be established by resolution as follows:


Code	License Categories	Application Fee	Renewal Fee
ALC	Alcohol License/Consent (Includes consent and business)	\$300	\$250
C-1	Commercial – Level 1 (Under 10,000 sq. ft.)	\$150	\$100
C-2	Commercial – Level 2 (greater than 10,000 sq. ft.)	\$250	\$200
M-1	Minor (Home Occupation, Independent, no location, Seasonal)	\$75	\$50
E-1	Special Event	\$75	n/a
L-1	Landlord – Level 1 (Good Landlord Certified)	\$10	\$10
L-2	Landlord – Level 2 (Good Landlord Non-Participant)	\$50	\$50

SECTION III: Penalties for late payment will be as follows: 30 days - 25 percent, 60 days – 50 percent, and 90 days – 100 percent.


SECTION IV: Effective date. This resolution shall take effect immediately.



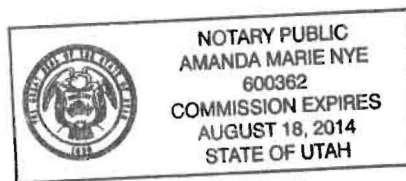
