**A RESOLUTION BY THE LOGAN MUNICIPAL COUNCIL
APPROVING AN ADJUSTMENT OF COMPOST FACILITY PRODUCTS**

WHEREAS, the Council recognizes the need to adjust the compost facility rates to address increasing fuel and equipment cost.

WHEREAS, the Council supports the need to save monies for a equipment and rolling stock purchase

WHEREAS, the Council encourages composting, recycling and increased diversion rates from the landfill

WHEREAS, the Council understands the need to adjust the rates due to increase in inflation and growth in equipment needed, and that the last significant rate adjustment occurred in 2006.

BE IT RESOLVED by the City of Logan Council as follows:

Green Waste (Compost) Facility Product Pricing

Finished Compost	\$20.00/Yd
Finished Compost	\$1.50/Bag
Medium Wood Chips	\$12.00/Yd
Premium Wood Chips	\$15.00/Yd
Firewood	\$10.00/Cord
Colored Wood Chips	\$30.00/Yd

The effective date of this resolution shall be January 1st 2014.

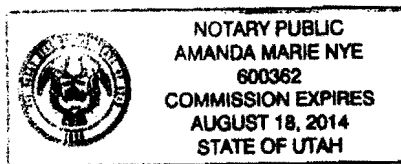
