



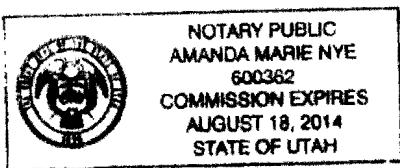

Logan Municipal Council

The Municipal Council of the City of Logan, Utah, will hold public hearings to consider the following:

An adjustment to the FY 2013-2014 budget appropriating: \$3,000,000 for Transportation Sales Tax sent directly to the Cache Valley Transit District that is levied by Logan City; \$4,591 for the Logan City Library to buy equipment for a digital media lab; \$488,000 from equipment reserves to pay off Fire Quint Capital Lease; \$475,000 to call the 2002A Water, Sewer and Solid Waste Bonds which will save approximately 7%.

An adjustment to the FY 2013-2014 budget appropriating: \$1,750,000 from Capital Project Reserve Funds as a loan to complete Parks & Recreation Trails.

Said public hearings will be held Tuesday, October 1, 2013, not before 5:30 p.m. in the Logan Municipal Council Chambers, 290 North 100 West, Logan UT.
