



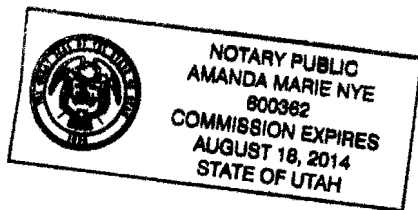

Logan Municipal Council

The Municipal Council of the City of Logan, Utah will hold public hearings to consider the following:
