**A RESOLUTION SUPPORTING LONG-TERM EVALUATION OF
ONE-WAY COUPLETS**

WHEREAS, the City of Logan and the Cache Metropolitan Planning Organization (CMPO) has performed a feasibility study of one-way couplets in Logan; and

WHEREAS, the study recommends a one-way couplet system may be beneficial in moving traffic through Logan in the future; and

WHEREAS, the implementation of a one-way couplet system requires regional coordination with the Utah Department of Transportation and other cities; and

WHEREAS, the implementation of 100 East and 200 East as a one-way couplet does not provide mobility advantages over a roundabout at 500 North for the next 15 to 20 years;

NOW THEREFORE, BE IT RESOLVED by the Logan Municipal Council that the one-way couplet system should be evaluated further through the CMPO long range planning process in the future and the proposed roundabout at 500 North should be implemented as part of the 200 East project.



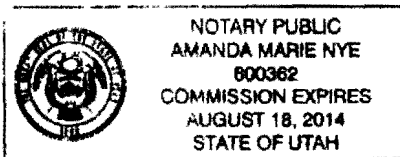
