

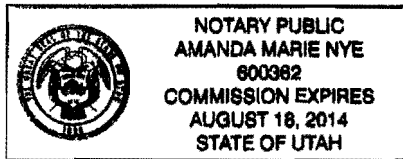

Logan Municipal Council**

The Municipal Council of the City of Logan, Utah will hold public hearings to consider the following:

An adjustment to the FY 2014-2015 budget appropriating: \$1,700 donated funds for the City Santa Program; \$2,800 donated funds for the Employee Program; \$11,000 for the Emergency Management Performance Grant (EMPG); \$400,000 for the purchase of two large bucket trucks for the Light & Power Department.

An adjustment to the FY 2014-2015 budget appropriating: \$43,834 for the Logan/Cache Airport Parking Lot (1/3 funding coming from Logan City, Cache County and Airport reserves).

Said public hearings will be held Tuesday, August 19, 2014, not before 5:30 p.m. in the Logan Municipal Council Chambers, 290 North 100 West, Logan UT.
