The Municipal Council of the City of Logan, Utah will hold public hearings to consider the following:

Consideration of a proposed resolution authorizing and approving a capital contribution by the City of Logan, Utah in respect to bonds to be issued by Utah Associated Municipal Power Systems (UAMPS) pursuant to the Veyo Heat Recovery Project Power Sales Contract and related matters.

An adjustment to the FY 2014-2015 budget appropriating: \$16,664 additional funds for the 21st Century Grant; \$3,500,000 for Veyo Project expenses from the Electric Fund.
