SUBJECT: JUSTIFICATION TO PURCHASE WHEEL LOADER

Our John Deere # 1037 wheel loader has an issue with transmission fluid leaking into cavities containing hydraulie fluids. Our lead mechanic Steve Stocks and I believe that the main seal on the transmission has a potential to fail at any time. Quotes from heavy equipment dealers for replacement of the transmission have been in the ball park of \$50,000 dollars. A repair of this magnitude on the John Deere which already has 19,215 hours and is a 1999 model machine may not be an effective use of our money. Most of our equipment is traded at 10,000 to 15,000 hours of run time. If we should keep this machine and replace the transmission there is also the possibility that it will need an engine overhaul costing a similar quantity of money in the near future.

We have found this machine to be very helpful in the green waste and landfill areas as both a back-up machine and also as a front line machine when we have a full staff on site. Most of the time when we are operating the grinder or performing tasks at the green waste and landfill areas simultaneously we need to have both of our wheel loaders.

Due to these observations we consider it prudent to request a mid-year budget adjustment to purchase a used wheel loader to replace our current machine. The wheel loader that we would like to buy is a 2012 Case 1021F which is of similar size to the John Decre. It is offered by Century Equipment at \$210,000 with a trade in value of \$32,000 on the John Deere. It is near new with only 890 hours, and has been used almost exclusively as a demonstration and training model. The total budget adjustment we are asking is \$178,000.
