A RESOLUTION TO APPROVE AN INCREASE IN THE TOURNAMENT ROOM RENTAL FEE AT THE LOGAN RIVER GOLF COURSE

WHEREAS, the Logan River Golf Course is owned and operated by the City of Logan and is maintained by the Parks and Recreation Department; and

WHEREAS, the Logan River Golf Course offers a room space to the general public for gatherings for a fee that is organized by reservation; and

WHEREAS, the Logan River Golf Course charges fees for room reservations in what is known as the Tournament Room; and

WHEREAS, fees charged for services help to offset direct costs related to the use of the Tournament Room at the Logan River Golf.

NOW, THEREFORE, BE IT RESOLVED BY THE LOGAN MUNICIPAL COUNCIL, that the Tournament Room rental fee at the Logan River Golf Course is increased by fifty (\$50.00) dollars for the 3-to-5 hour reservation to the amount of five-hundred (\$500.00) dollars, and that the new fee shall become effective beginning April 1, 2015.

Introduction
