Logan Municipal Council

The Municipal Council of the City of Logan, Utah will hold a public hearing to consider the following:

Consideration of a proposed adjustment to the FY 2014-2015 budget appropriating: \$600,000 for a grant received from the State of Utah to be used for continued improvements and restoration of the Logan River; \$54,400 for a grant received from the State of Utah to forward to the Willow Park Zoo; \$34,460 for a road refund from UDOT for traffic signal coordination for future road projects; \$65,000 funds from the Logan City Cemetery Perpetual Care Fund for the Cemetery Pump House relocation project; \$5,500 funds from the sale of a Parks & Recreation mower, toward the purchase of a replacement mower.

Said public hearing will be held Tuesday, April 21, 2015, not before 5:30 p.m. in the Logan Municipal Council Chambers, 290 North 100 West, Logan UT.
