Consideration of a proposed adjustment to the FY 2015-2016 budget appropriating: \$88,000 for the State Task Force Grants; \$14,000 for two State Asset Forfeiture Grants; \$2,500 funds from State Asset Forfeiture Grants for police department body cameras; \$18,019 restricted general Library Trusts Funds for the replacement of a Library compressor; \$20,530 restricted general Library Trust Funds for data migration and hosting of Library database; \$10,000 for a grant the police department was awarded from the Internet Crimes Against Children.

Consideration of a proposed ordinance Prohibiting the Unauthorized Feeding of Deer.
