**A RESOLUTION ADOPTING AN AMENDMENT TO THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM YEAR 2019 (PY2019) ANNUAL ACTION PLAN (AAP)**

**WHEREAS**, the PY2019 AAP, which identifies the CDBG funding allocations for PY2019, was adopted by the Municipal Council and was approved by the U.S. Department of Housing and Urban Development (HUD); and

**WHEREAS**, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) was adopted by the U.S. Congress and signed by President Trump on March 27, 2020 to respond to the growing effects of the coronavirus pandemic; and

**WHEREAS**, the U.S. Department of Housing and Urban Development (HUD) has awarded Logan City a second allocation of CDBG-CV funds to be used to prevent, prepare for, and respond to the coronavirus pandemic; and

**WHEREAS**, HUD has authorized Logan City to amend PY2019 AAP to allocate this CDBG-CV funding in response to the coronavirus pandemic; and

**WHEREAS**, the City of Logan CDBG 2019 Citizen Participation Plan was amended to reflect a modified public involvement process including reduced public comment periods, virtual public hearings, and the use of alternative methods for accepting public comments; and


**WHEREAS**, notice of this amendment has been published and made available for public comment.

## **EXHIBIT A**

### **LOGAN CITY CDBG PROGRAM PROGRAM YEAR 2019 (PY2019) ANNUAL ACTION PLAN (AAP) AMENDMENT 1**

#### **Summary**

The purpose of this amendment is to specify funding alternatives authorized under the CARES Act and CDBG-CV guidance in response to the coronavirus pandemic and include those in Logan City's PY2019 Annual Action Plan (APP). The proposed changes to the PY2019 AAP include utilizing the second allocation of CDBG-CV funding \$207,849 as follows:

- Allocate \$207,849 to the Logan City Fire Department and the Bear River Health Department for a Community Coronavirus Vaccination Clinic program.
- Designate the Little Lambs, Cache Food Pantry, and the Non-Profit Assistance Grant Program as the designed receiver projects for funding reallocations from completed projects, cancelled projects, or recaptured funds.

These funding alternatives reflect Logan City's strategies for distributing the supplemental funding of CDBG-CV funds in response to the impacts and demands of COVID-19 on Logan residents.

Notice is hereby given that Logan Municipal Council will hold a public hearing on Community Development Block Grant (CDBG) Program funds HUD has allocated to Logan City in the amount of \$209,849 as authorized by the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Public Law 116-136. These special CDBG-CV funds are to be used to prevent, prepare for, and respond to the coronavirus pandemic (COVID-19) and to mitigate the impacts of COVID-19 in Logan City. Logan City will consider an amendment to the 2019 AAP in order to use the CDBG-CV funds to address urgent needs related to the prevention of, preparation for, or response to coronavirus for low/moderate income residents of Logan. Activities considered may include: financial assistance to food banks, meal delivery programs, and other food assistance programs serving LMI clients in need due to the Coronavirus; financial assistance for non-profit entities serving LMI persons financially impacted by the Coronavirus; financial assistance to help provide emergency shelters for LMI residents who are victims of domestic violence; financial assistance (for qualifying expenses) to LMI families who are at risk of or have recently become homeless due to the Coronavirus; acquisition, construction, reconstruction, or installation of public works, facilities, and site or other improvements, or the rehabilitation of buildings and improvements; planning, capacity building, technical assistance, and administrative services to prevent the spread and assist with the response and recovery of COVID-19.

### **Amendment Summary**

In response to the Coronavirus Pandemic (COVID-19) the U.S. Department of Housing and Urban Development (HUD) awarded Logan City a second allocation of Community Development block Grant Coronavirus (CDBG-CV) funds to be used to *prevent, prepare for, and respond to* the coronavirus pandemic (COVID-19). This second allocation of **\$207,849** was authorized by the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Public Law 116-136, which was signed by President Trump on March 27, 2020, to respond to the growing effects of this historic public health crisis.

The City was awarded the first CDBG-CV allocation of \$299,912 in early 2020. On May 5, 2020, the Municipal Council reviewed amendments to the 2019 Annual Action Plan (AAP) on the funding proposals as well as amendments to the 2019 Citizen Participation Plan adopting a modified public review process during the pandemic. We received formal notification of the second allocation in September.

In planning for the utilization of these Covid-19 funds, the City prioritized the needs of low and moderate-income residents and the development of partnerships in both the private for-profit and non-profit sectors. Here is a brief summary of Amendment #1 (Round 1) funding.

### **Summary - PY 2019 Annual Action Plan Amendment #1**

#### ***CDBG-CV \$299,912***

During the first round of allocation, the City looked at the impacts of the Coronavirus pandemic to Logan City and its residents. At that time, the rate of infection and hospital utilization were relatively low and were not taxing our local health care system. The most significant impacts of the pandemic had been economic impacts due to job losses, job reductions, wage reductions, loss of income, business & event closures along with the mental health impacts resulting in greater demand on social services. We also saw a significant shift in how entities responded to their clients' needs through virtual methods as well as an immediate need to keep people safe through an investment in Personal Protection Equipment.

With the first allocation, the City funded emergency food and shelter, rental assistance, PPE's, telehealth systems, and non-profit operational support. We did try targeting small businesses,

restaurants, LMI residents, and assisting with quarantine housing, but since these did not generate any significant demand, these funds have since been repurposed.

Both the Food Pantry emergency food distribution program, CAPSA emergency shelter program, and general non-profit assistance were designated as receiver projects, meaning money not spent in other programs were redirected to one of these three programs. There is approximately \$93,253 from the first allocation that remains unspent, and at some point, if these funds don't get spent, we will redirect them towards another program that is able to use the funds to support the initial CDBG-CV purpose statement: **prevent, prepare for, and respond to** the coronavirus pandemic (COVID-19).

## PY 2019 Annual Action Plan Amendment #2

### CDBG-CV \$207,849

We received the formal notification of round #2 funding in September and put out a call for round 2 funding applications in October. Based on the responses we received as well as the evolution of the pandemic, we decided to delay the process until the first of the year to determine if any of the conditions surrounding the coronavirus had changed, e.g., infection rates, community impacts, closures, job losses, vaccines, etc. We then issued another call for round 2 applications in January. The applications in front of the Council reflect both application periods.

To be considered for CDBG-CV funding, eligible activities supporting COVID-19 response include the following:

- a. Food Assistance Program - Financial assistance to food banks, meal delivery programs, and other food assistance programs that are serving LMI clients in need of these services because of the Coronavirus.
- b. Non-Profit Assistance Program – Financial assistance for non-profit entities serving LMI persons that have been financially impacted by the Coronavirus. The non-profit must be able to prove financial hardship due to the Coronavirus.
- c. Emergency Shelter Assistance Program – Financial assistance to help provide emergency shelters for LMI residents who are victims of domestic violence.
- d. Homeless Prevention Assistance Program – Financial assistance Resource and financial assistance (for qualifying expenses) to LMI families who are at risk of or have recently become homeless due to the Coronavirus.
- e. Acquisition, construction, reconstruction, or installation of public works, facilities, and site or other improvements, or the rehabilitation of buildings and improvements.
- f. Planning, capacity building, and technical assistance.
- g. Any other activity allowed under current CDBG regulations that prepares for, responds to, or prevents the coronavirus.

Under the typical CDBG processes, we generally hold a workshop(s) with the CDBG steering committee followed up by a public hearing. The CDBG-CV funds are administered a little differently with a condensed public input and public hearing cycle due to the immediacy of the need. I have summarized the requests for Round 2 of CDBG-CV funding along with our recommendation for allocation of funds (applications are attached).

Our overall recommendation for this funding is to fully fund the LCFD/BRHD proposed Community Coronavirus Vaccination Program with the full grant amount of \$207,849 as this activity is directly tied to Covid-19, and designate Little Lambs, Food Pantry, CAPSA, and the general category “non-profit assistance” as the receiver projects for any unspent funds.

**Applicant:** Logan City Fire Department & Bear River Health Department

**Proposal:** Establish a series of Community Coronavirus Vaccine Clinics in the City’s fire stations utilizing LCFD personnel to staff the clinics and administer vaccines. Put together a mobile vaccination unit to reach those homebound Logan residents who are unable to get to a vaccine site. This work would happen outside the LCFD’s normal personnel schedules and will utilize both off-duty personnel and/or part time or temporary personnel. BRHD will provide their staff to manage the administrative side of the vaccine program and which is not included in this grant request.

**Amount Requested:** \$200,000

**Notes:** This responds to an immediate need to provide Covid-19 vaccines, clearly fits the purpose of CDBG-CV funding, will help BRHD facilitate the administration of vaccines into Logan residents, and is capable of mobilizing almost immediately in response to increased supplies of vaccines.

**Recommendation:** Fund this program with the full grant amount of \$207,849.

**Applicant:** Little Lambs

**Proposal:** Provide emergency diaper and hygiene kits for low/moderate income residents affected by Covid-19.

**Amount Requested:** \$29,513.52

**Notes:** We provided \$25,883 in round #1 funding to Little Lambs and they have spent the entire amount. This need can be tied to Covid-19 and is also something that can be funded through traditional CDBG funds.

**Recommendation:** Designate as a "Receiver Activity" and reallocate any unspent funds here, up to the requested amount of \$29,513.52.

**Applicant:** Cache Community Food Pantry

**Proposal:** Provide emergency food distribution for low/moderate income residents affected by Covid-19.

**Amount Requested:** \$50,000

**Notes:** We provided \$97,638 in round #1 funding to the Cache Community Food Pantry for both emergency food distribution and cooler replacements. This need can be tied to Covid-19 and is also something that can be funded through traditional CDBG funds.

**Recommendation:** Designate as a "Receiver Activity" and reallocate any unspent funds here, up to the requested amount of \$50,000.

**Applicant:** Cache Community Food Pantry

**Proposal:** Construct new warehouse.

**Amount Requested:** \$50,000

**Notes:** We provided \$97,638 in round #1 funding to the Cache Community Food Pantry for both emergency food distribution and cooler replacements. I think we could make the case that using CDBG-CV funds to expand warehouse/storage space for the food pantry is an appropriate use of these specific funds; however, there are so many other immediate needs combined with the fact that this specific request could be funded through normal CDBG funds, we are recommending that this not be considered under this funding source.

**Recommendation:** Do not fund this request.

**Applicant:** CAPSA

**Proposal:** Provide emergency shelter in local hotels for victims of domestic abuse; purchase PPE, telehealth technology, professional cleaning services, cleaning supplies.

**Amount Requested:** \$30,000 (\$20,000/Shelter & \$10,000PPE/Cleaning)

**Notes:** We provided \$75,500 in round #1 funding to CAPSA for emergency shelter assistance, rental assistance, and operating costs. Approximately \$37,431 of that funding remains unspent. This need can be tied to Covid-19 impacts and is also something that can be funded through traditional CDBG funds.

**Recommendation:** Do not fund this request due to large, unspent balance of CDBG-CV #1 funds.

**Applicant:** English Language Center of Cache Valley

**Proposal:** Technology to facilitate online classes including a color copy machine, webcams, classroom microphones, and a wifi amplifier.

**Amount Requested:** \$11,000

**Notes:** We provided \$6,600 in round #1 funding to the Cache Community Food Pantry for operational expenses as they had been unable to hold primary fundraising events due to Covid-19. In our discussions with HUD, the types of equipment purchases being requested under this application are not appropriate for funding under CDBG-CV as the need and use of these items goes beyond just coronavirus impacts.

**Recommendation:** Do not fund this request.

**Applicant:** Common Ground Outdoor Adventures

**Proposal:** Request to purchase PPE materials, provide assistance with utilities, and purchase materials

& supplies for use in both virtual and in-person activities.

**Amount Requested:** \$16,684

**Notes:** We provided \$7,787 in round #1 funding to the Cache Community Food Pantry for operational assistance. One of the problems with the current request is that they have included their Beaver Mountain facility in this request which is something the City cannot fund. This need can be tied to Covid-19 and is also something that can be funded through traditional CDBG funds.

**Recommendation:** Do not fund this request.

**Applicant:** USU – Cache Community Gleaning Team

**Proposal:** Purchase a vehicle for use in their food gleaning project and SNAC pantry.

**Amount Requested:** \$5,000

**Notes:** This group picks up surplus produce throughout the valley and distributes it to low/moderate income residents through their SNAC pantry and in conjunction with the Cache Community Food Pantry. We have discussed this with HUD and their recommendation is to avoid using CDBG funds to purchase vehicles, especially the CDBG-CV funds.

**Recommendation:** Do not fund this request.

**Applicant:** Family Place

**Proposal:** Employee Communication Stipend. Provide a monthly communications stipend for employees forced to work from home due to the coronavirus pandemic.

**Amount Requested:** \$38,520

**Notes:** We provided \$17,777 in round #1 funding to the Family Place for PPE and technology supplies. All of this funding remains unspent. While the need to accommodate employees forced to work at home due to the pandemic is real, according to HUD, this is treated like “cash” and is not permitted under HUD guidelines.

**Recommendation:** Do not fund this request.

In generating this preliminary list of funding alternatives, staff reached out to all of the local non-profits and service providers through the Cache Interagency Council to determine any of their specific needs relative to COVID-19. We also notified them again when we issued the public notice for this Council hearing, so you may receive some additional suggestions. During this public hearing, the Municipal Council can consider other funding alternatives provided they meet the CARES Act mandate: CDBG-CV is to be used to prevent, prepare for, and respond to the coronavirus (COVID-19).

It is important for the Council to designate a couple of Receiver Activities for funding reallocations from completed projects, cancelled projects, or recaptured funds. It is also important to note that these funds cannot duplicate other funds that are potentially available to meet a specific need.

The CARES Act provides procedural flexibility for the CDBG-CV grant. It authorizes the HUD Secretary to grant waivers and alternative requirements to meet existing statutes and regulations that are administered in connection with the use of these funds. To expedite and facilitate the use of the CDBG-CV funds, Logan City will, as necessary, avail itself of the additional flexibility being provided and request the appropriate available waivers through HUD.

Further guidance defining what qualifies as a CDBG-CV response, and other information, is still forthcoming from HUD, especially as vaccines are rolling out.

All eligible CDBG activities must meet one of the national objectives which are: (1) Benefit to low and moderate-income (LMI) residents; (2) Aid in the prevention of slums or blight; and (3) Meet a need having a particular urgency. Logan City may undertake CDBG eligible activities to meet needs resulting from declared disasters or emergencies under any one of the three national objectives. The proposals meet this condition.
