A RESOLUTION REVISING PARKING VIOLATION CIVIL PENALTIES

BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF LOGAN, UTAH THAT:


WHEREAS, Logan City Police Department is the primary enforcement agency for all parking enforcement issues within Logan City. Logan City parking civil penalties have not been adjusted since 2012. As such, Logan Police is proposing an increase and revision to civil penalties for parking violation to be in line revenues. Cost increases over the past nine years have gone up steadily. Additionally, we have need of changing our software and software vendor for parking enforcement. Logan Police Department will continue to strive for revenue neutrality of parking enforcement costs and revenue generated while providing a quality and responsible service to citizens and community businesses alike.

NOW THEREFORE, BE IT RESOLVED by the Logan Municipal Council, that the revised Civil Penalty Schedule attached hereto shall take effect when the new software vendor comes online.
