As the rightful owner of the previously described weapons(s) I understand pursuant to Utah Code Section 76-10-503 (8) that any person who sells, transfers, or otherwise disposes of any firearm or dangerous weapon to any person, knowing that the recipient is restricted, commits a crime, punishable by up to one to fifteen years in the Utah State Prison and also may violate federal law, punishable by up to ten years in a Federal Penitentiary
