A Special Meeting of the Council of the City of Manassas, Virginia was held in the Second Floor Conference Room at City Hall on the above date with the following present: Vice Mayor Andrew L. Harrover, Council Members Marc T. Aveni, Ian T. Lovejoy, J. Steven Randolph, Jonathan L. Way, and Mark D. Wolfe; City Manager W. Patrick Pate, Finance and Administration Director Paul York, Budget Manager Diane V. Bergeron, Public Works and Utilities Director Mike C. Moon, Utilities Finance Manager Glenn Simpson, and Airport Director Juan Rivera.

Absent was Mayor Harry J. Parrish II.

Members of the Manassas City School Board were present.

Vice Mayor Harrover called the meeting to order at 5:30 p.m. and appointed the Budget Manager the Acting City Clerk.

The Acting City Clerk reported that the news media had been notified of the Special Meeting in accordance with the Freedom of Information Act.

The Acting City Clerk read the Notice of Special Meeting acknowledged by all Council Members stating that the Special Meeting was called for the following purposes:

1. As per the attached agenda dated March 19, 2014;
2. Other pertinent business for the operation of the City.

Item 1 of the Agenda: Work Session on the Proposed Fiscal Year 2015 Budget: Enterprise Funds and Other Funds.

The City Council, Mr. Pate and staff discussed the Fiscal Year 2015 Budget as it impacts the Enterprise and Other Funds.

The City Council discussed the tax rate it would like to advertise.

COUNCIL MEMBER RANDOLPH MOVED that the tax rate be advertised at \$1.383. Seconded by Vice Mayor Harrover. Roll call vote: AYES - Harrover and Randolph. NAYS - Aveni, Lovejoy, Way and Wolfe. **MOTION DENIED.**

COUNCIL MEMBER AVENI MOVED that the tax rate be advertised at \$1.358. **MOTION FAILED DUE TO THE LACK OF A SECOND.**

COUNCIL MEMBER WOLFE MOVED that the tax rate be advertised at \$1.393. **MOTION FAILED DUE TO THE LACK OF A SECOND.**

COUNCIL MEMBER WAY MOVED that the tax rate be advertised at \$1.375. Seconded by Council Member Aveni. Roll call vote: AYES - Aveni, Lovejoy and Way. NAYS - Harrover, Randolph and Wolfe. **MOTION FAILED AS A RESULT OF A TIE.**

COUNCIL MEMBER WOLFE MOVED that the tax rate be advertised at \$1.383. Seconded by Vice Mayor Harrover. Roll call vote: AYES - Harrover, Randolph, Way and Wolfe. NAYS - Aveni and Lovejoy. **MOTION CARRIED.**

Motion was duly made, seconded and **CARRIED UNANIMOUSLY** to adjourn the meeting.
