

COUNCIL WORK SESSION – JANUARY 21, 2014

The work session of the Common Council of the City of Marshall was held on January 21, 2014 in the Community Room at the Marshall-Lyon County Library. **PRESENTATION OF LOCAL WORKFORCE DEVELOPMENT AND INITIATIVES UNDERWAY:**

Ben Martig, City Administrator, introduced the first agenda item which was a discussion on the Local Workforce Development Needs and Initiatives Underway.

Connie Gores, SMSU President, provided a power point on Charting the Future for a Prosperous Minnesota.

Cliff Carmody, Southwest/West Central Services Cooperative followed up with a presentation on the Workforce Development: K-12 Pathways to Post Secondary Education.

**PRESENTATION AND DISCUSSION OF THE LIQUOR STORE NEW CONSTRUCTION SCHEMATIC DESIGN PHASE:**

Ben Martig, City Administrator, provided a power point presentation on the Liquor Store Schematic Design Phase. Mr. Martig reviewed two options which included a free standing liquor store layout and an alternate option that would include the addition of a leased space.


**PRESENTATION AND DISCUSSION OF THE CITY HALL FACILITY:**
