Authorization is hereby granted for movement described in this permit using County Roads contingent upon meeting the conditions in this permit and subject to compliance with the Minnesota Traffic Regulations Act and the provisions listed below.

SPECIAL PROVISIONS

- > Travel is allowed on county roads only. Other roads may require a separate permit from each road authority.
- > Valid for a single trip only.
- > At night, signs, when required, must be lighted plus load and vehicle unit(s) must be outlined every 20 feet in amber lights with red lights at rearmost point(s). Lead and rear escort required at night when over 10 foot wide or when combo is over 85 feet long.
- > Movement is not authorized when weather or road conditions are hazardous. These include slippery roads due to ice, moderate to heavy snow or rain, when visibility is less than 500 feet or when wind gusts are strong enough that vehicle can not stay within its travel lane. It is the responsibility of the driver to monitor local weather reports and 511 for real time weather and road condition reports which may be used to determine whether road conditions are adverse.
- > It is the responsibility of the permittee of any oversized loads to drive the route prior to the move and make arrangements for any signs or utilities that need to be moved
- > The hauling equipment must be within legal limits unless specifically noted on this permit.
- > This permit is VOID if load item(s) can be reduced to smaller size or weight.
- > Every vehicle must be registered for enough weight to cover the Gross Vehicle Weight.
- > The driver must have this permit with him for it to be valid.
