**Martin County Board of Commissioners**  
**Five members (four year term)**

The Board of Commissioners of Martin County shall consist of five members, to be elected at-large by the entire electorate of the county, under a system of limited voting, as follows:

There shall be two residency districts created within the county as follows:

The WESTERN DISTRICT shall consist of the townships of Poplar Point, Goose Nest, Hamilton, Robersonville and Cross Roads;

The EASTERN DISTRICT shall consist of the townships of Williamston, Bear Grass, Jamesville, Williams and Griffins;

Two of the five commissioners shall reside in the WESTERN DISTRICT. They shall be elected simultaneously, and each voter in the county shall be permitted to cast one vote in the primary, and one vote in the general election, for these two commission seats;

Three of the five commissioners shall reside in the EASTERN DISTRICT. They shall be elected simultaneously, and each voter in the county shall be permitted to cast two votes in the primary, and two votes in the general election, for these three commission seats.

The candidates receiving the highest number of votes shall be declared the winners of the primary, and of the general elections, respectively. No run-off elections shall be held.
