Notice of Nonpartisan Municipal Election Town of Robersonville, North Carolina

A Nonpartisan Municipal Election will be held on Tuesday – November 5, 2019, in the *Town of Robersonville*, North Carolina, for the purpose of electing *one Mayor and five Council Members* for a term of 4 years. Polls will be open from 6:30 AM until 7:30 PM. The assigned polling places are:

Robersonville 1 Precinct - Robersonville Fire Department, 119 S Main Street, Robersonville

Robersonville 2 Precinct - Robersonville Senior Center, 203 E Green Street, Robersonville

Absentee ballots are allowed. Requests for an absentee ballot must be made on the *State Absentee Ballot Request Form* and received in the Martin County Board of Elections office by 5:00 PM on Tuesday – October 29, 2019. The Board of Elections will meet on October 15, October 22, October 29, and November 4 at 8:30 AM; on November 13 at 8:30 AM; and other times as may be necessary for the purpose of approving absentee ballot applications.

One-stop absentee voting will be held at the Martin County Governmental Center in the Commissioners' Boardroom (Room #121), located at 305 East Main Street, Williamston, NC. One-stop voting begins Wednesday – October 16, 2019, and ends Friday – November 1, 2019. One-stop voting hours are Monday through Friday 8:00 AM – 5:00 PM. Canvass will be held at 11:00 AM in the Martin County Board of Elections Office in Williamston on Friday – November 15, 2019.

All residents of the *Town of Robersonville* who are registered to vote with the Martin County Board of Elections may vote in this election. Voters who are previously registered need not re-register for this election. Those residents of the *Town of Robersonville* who are not registered to vote must register on or before Friday – October 11, 2019, in order to be eligible to vote on Election Day. Voters who are not registered by that deadline may register and vote during one stop early voting only, and will be required to provide documentation of their residence. Voters who fail to timely make a change in name or address in the county must update their information when presenting to vote, and may be required to vote a provisional ballot.

Voters voting in person are entitled to assistance by an election official, or, if assistance is needed due to disability or illiteracy, by a qualified person of their choice. Registration facilities and voting sites are accessible to all voters. Curbside voting is available for voters who are not physically able to enter voting sites.
