Advisor Kessler thanked all who attended recent District meetings and programs and invited all board members to attend the Conservation District's August 8, 2022 Special Call Meeting.

  at The Dole, with the date still to be determined. McHenry County Conservation
  Foundation and McHenry County Conservation District were both mentioned at July's Green
  Drinks event.

# 7.0 BOARD BUSINESS - CONSENT AGENDA

- 7.1 Authorization to renew Fox River Ecosystem Partnership membership for a cost not to exceed \$50.00.
- 7.2 Authorization to contract with Nancy Gonsiorek, CPA, LLC to compile an Unaudited Financial Statement for the McHenry County Conservation Foundation and prepare the IRS Form 990 for a cost not to exceed \$3,750.
- 7.3 Consideration to submit MCCF Director Appointment Recommendation of Carolyn Campbell to the Conservation District Board of Trustees.

  <u>Director Haisler made a motion to accept the Consent Agenda, Director Eisbrener seconded the motion</u>. A roll call vote was taken. All were in favor. <u>Motion passed unanimously</u>.

#### 8.0 BOARD BUSINESS

8.1 Authorization to contract with Creative Graphics Management on a trademark redesign for a cost not to exceed \$4,150.

Executive Director Flavell presented the Directors with an updated price quote obtained from the designer who quoted the project in May 2022. The designer removed mock marketing materials from the original quote in order to reduce the cost. The new quote was for logo design only. Wendy Kummerer, Conservation District Director of Marketing & Education, was unable to attend the meeting so Executive Director Flavell shared correspondence from her in support of a logo redesign. Secretary Eisbrener suggested the Foundation obtain another bid. Director Althoff commented that \$4,000 was not out of line and appreciated the cost reduction. Vice President Semel stated he was accustomed to receiving three bids for projects. Discussion continued to suggest the Foundation obtain three bids for projects over \$10,000, or another agreed upon amount, in the future. Advisor Kessler shared that while multiple quotes/proposals are helpful, creative services are different than purchasing a vehicle or product.

<u>Director Althoff made a motion to authorize contracting with Creative Graphics</u>

<u>Management on a trademark redesign for a cost not to exceed \$4,150. Director Livingston seconded the motion.</u> Roll call vote taken. President Ivers - yes, Vice President Semel - no, Treasurer Becker - yes, Secretary Eisbrener - no, Director Dreher - yes, Director Gorman - yes, Director Haisler - yes, Director Livingston - yes, Director Althoff - yes. <u>Motion passed on a 7 to 2 vote.</u>

# 9.0 EXECUTIVE DIRECTOR UPDATES

9.1 Project Updates

Executive Director Flavell reported that work is continuing at the former Camp Lakota, including volunteer conducted prescribed burning and contracted brush clearing. President Ivers suggested a volunteer opportunity at Lakota to introduce site to public. Executive Director Flavell agreed to bring up the idea with the Conservation District's Volunteer Coordinators. Other updates included Youth and Family Center summer Conservation District programming and Foundation-supported work at Pleasant Valley.

9.2 Community Engagement

Executive Director Flavell will be leading a bike ride along the Ridgefield Trace on October 1, 2022. Executive Director Flavell thanked Director Haisler and his wife for helping at The Dole at Lakeside Fest; she thanked Director Gorman for leading the June Prairie Trail clean up; and she thanked everyone else who helped with the Pedal, Paddle, Saddle event.
