The Conservation Police Department was named a finalist for the 2021 Destination
Zero Officer Wellness Award by the National Law Enforcement Officers Memorial Fund.
Advisor/MCCD Executive Director Kessler received the Illinois Parks and Recreation
Association's Robert Artz Lifetime Achievement Award honoring those whose service
has created awareness of the importance of parks and recreation. The Festival of
Sugar Maples event was given high reviews. The District's FY 2021 Budget was
presented to the County's Finance & Audit Committee and an online security training
class was taken by District Board Members. Director Dreher inquired about the
District's budget. He wondered if there was a budget summary and statement
regarding adequacy of funding.
