 Ed Collins, McHenry County Conservation District's Director of Land Preservation and Natural Resources, gave the presentation "Sandshells, Creepers and Elktoes Oh My!" which highlighted the District's work reintroducing native mussel species into McHenry County waterways, primarily Nippersink Creek.

Treasurer Becker gave an overview of the November 2021 Profit & Loss and the November 2021 Balance Sheet. Due to a delay in accessing December's bank statements, review of the December 2021 financials was tabled until the March meeting.

9.0 DIRECTOR & BOARD LIASION REPORTS

9.1 McHenry County Conservation District Report: District Liaison Thomas
Liaison Thomas shared that Ed Collins was a 2021 Dr. George B. Rabb Force of Nature
Award recipient. The Conservation District recently hired a new Marketing Coordinator,
Maddy Neubauer, and the bison have arrived at Pleasant Valley. Currently, the
Conservation District board is working on the 2022/2023 budget. Liaison Thomas then
gave Advisor Kessler the floor and Advisor Kessler shared that if all goes as planned, the
budget was expected to be finalized and approved by the McHenry County Board before
April 1, 2022. Advisor Kessler also share that the Conservation District is currently
trying to fill several open positions and that Executive Director Flavell was working
with a Conservation District team on a federal grant opportunity from the Economic
Development Administration to fund work along the Prairie Trail.

Director Haisler asked if this was a recurring pledge or a one-time \$10,000 commitment. Executive Director Flavell shared with the board that there was not a current expectation that the Foundation would support the program annually, but that the project could use funding on an ongoing basis. Director Haisler shared that he felt this was a legacy project that should be implemented countywide and would need continued funding, which he was in support of. Vice-President Semel commented that there may be federal grants available to fund the work and spoke to various engaging ways to raise funds.

- 10.6 Consideration to Finalize and Adopt the MCCF Board Member Fundraising Policy. The board discussed the collective board fundraising goal. Discussion was had regarding the tracking of gifts made thanks to board conversations. It was confirmed that gift solicitation could be tracked in the CRM. Consensus was reached to set the collective goal at \$25,000 for combined board giving and fundraising.

A draft budget was shared and consensus was reached to support Conservation Congress at a minimum of \$10,000. Ratification of the action will be taken at the March meeting.

12.2 Directors and Officers Insurance Umbrella Policy Update

Executive Director Flavell gave an update on the board's request for information regarding additional Directors and Officers insurance coverage. Executive Director Flavell spoke with insurance representatives from Aon Insurance, Mylo Insurance, Hartford Insurance, Gallagher Insurance, and Travelers Insurance and none of these providers were able to offer an umbrella policy meant to be placed over an insurance policy their organizations were not underwriting. The Foundation's current insurance provider, the Park District Risk Management Agency (PDRMA), does not offer umbrella coverage to any of their policies since they are not an insurance company. Consensus was reached to maintain coverage with PDRMA and not to further pursue alternative coverage.
