MECOSTA COUNTY PARK COMMISSION

RULES AND REGULATIONS

ADOPTED BY: THE MECOSTA COUNTY PARK COMMISSION AND AMENDED ON FEBRUARY 15th, 2022

ADOPTED BY: THE MECOSTA COUNTY BOARD OF COMMISSIONERS AND AMENDED ON MARCH 3rd, 2022

PREAMBLE

An ordinance to regulate and control all lands, waters, and property administered by or under the jurisdiction of the Mecosta County Park Commission.

WHEREAS, MCLA 46.11; MSA 5.331, authorizes the Mecosta County Board of Commissioners to enact Ordinances relating to county affairs; and

WHEREAS, MCLA 46.351; MSA 45.570(101) authorizes the Mecosta County Board of Commissioners to make rules and regulations with respect to the County Parks and Recreation Commission as the Board of Commissioners considers advisable; and

WHEREFORE, the County Board of Commissioners of Mecosta County believes that the safety and general welfare of the People of the County would be enhanced by the enactment of a County Ordinance regulating and controlling all lands, waters, and property administered by or under the jurisdiction of the Mecosta County Park Commission;

NOW THEREFORE, BE IT ORDAINED by the County of Mecosta, Michigan as follows:

PARK RULES:

Under the Authority of Public Act 261 of the State of Michigan (1965), as amended, the Mecosta County Park Commission herewith promulgates and published the following rules for the use, protection and control of all park acreage and facilities under its management control.

A WORD ABOUT OUR PARKS:

The Mecosta County Parks are not supported by a yearly tax appropriation and instead depend on user fees to operate, maintain, and keep parks available for public use.

A.D.A GUIDELINES:

Any questions or concerns about equal access for all visitors to our parks should be directed to the Administrative Office at (231) 832-3246.

Section 1: DEFINITIONS

- 1. "**Commission**" shall mean the Mecosta County Park Commission.
- 2. **"Commission Property"** shall mean all lands, waters, and property administered by or under the jurisdiction of the Mecosta County Park Commission.
- 3. **"Person" or "Person(s)"** shall mean individuals, male or female, singular or plural; firms, corporations or any group of individuals.
- 4. **"Camping"** means the overnight lodging or sleeping of person or persons in a cabin, tent, trailer-tent, motor home, trailer-coach, vehicle camper, motor vehicle, or in any other conveyance erected, parked, or placed on the premises within any park or recreation area administered by the Mecosta County Park Commission.
- 5. A **"Campsite"** shall not consist of more than one (1) picnic table, one (1) fire pit, one (1) electric outlet (where available), one (1) water spigot (where available) and one (1) seepage pit (where available). Its boundaries shall be the distance between campsite marking posts on both sides, and a line formed by the electric box in the rear (if available). The size will be determined by the park manager.
- 6. **"Quiet Hours"** means the designated period of time between 10:00 pm and 8:00 am during which all noise, conversation or activity shall be confined to the boundaries of the campsite.
- 7. **"Day use"** shall mean the use of the Commission property between 8:00 a.m. and 10:00 p.m. by person or persons not registered to camp or visiting campers.
- 8. **"Motor driven vehicle"** means a vehicle, motor vehicle, or vehicle, operated, or designed for operation upon a public highway by power other than muscular power, including motorcycles and golf carts.
- 9. **"Motorcycle"** means a vehicle having a saddle or seat for the use of the rider, designed to travel on not more than 3 wheels in contact with the ground, which is equipped with a motor that exceeds 50 cubic centimeters piston displacement.
- 10. **"Fireworks"** means a device made from explosive or flammable composition used primarily for the purpose of producing a visible display or audible effect, or both, by combustion, deflagration, or detonation. Fireworks includes, but is not limited to, firecrackers, roman candles, bottle rockets, flat paper caps, sparklers, cone fountains, toy snakes, blank cartridge pistols, toy guns in which explosives are used, or other fireworks of like construction.
- 11. **"Smoking"** means the practice in which a plant or substance is burned, and the resulting smoke or vapor is breathed in and exhaled. Smoking includes, but is not limited to, the use of cigarettes, cigars, marijuana, pipes, e-cigarettes, vaping or other similar devices.

Section 2: APPLICATION OF ORDINANCE

Sec.2.a The provisions of this ordinance shall apply to and regulate and control all lands, waters and property administered by or under the jurisdiction of the Mecosta County Park Commission.

Section 3: HOURS

- Sec.3.a No person shall remain upon Commission property between 10:00 p.m. and 8:00 a.m., except at designated camping areas. Said hours may be extended upon approval of the Commission. It shall be unlawful for any person to enter park lands or waters which have been designated as closed to public use or entry.
- Sec.3.b Camping permit check-in begins at 3:00 p.m. on the date of arrival. Camping permit expires at 1:00 p.m. on the date of departure.

Section 4: FEES AND CHARGES

- Sec.4.a No person shall use any facility, land or area for which a fee and charge has been established by the Commission without payment of such fee or charge.
- Sec.4.b No person shall occupy a campsite for which a fee is charged until the entire fee has been paid.
- Sec.4.c Refunding of any unused portion of a camping permit or reservation may be granted in accordance with the Park Commission refund policy. Refund requests must be received from the registered camping guest to be evaluated. All refund requests must be submitted in writing to the Park Commission administration office. An administrative fee, as established by the Commission, shall be charged on each approved refund.
- Sec.4.d A non-refundable reservation fee as established by the Commission shall be billed for all non-seasonal advanced reservations related to campsite and facility use.

Section 5: PERMITS AND REGISTRATIONS

- Sec.5.a A valid daily or annual vehicle permit shall be permanently displayed in a clearly visible location on the passenger side of the windshield of any vehicle entering upon Commission property requiring such a permit.
- Sec.5.b Camping registration shall be completed by means of a signed permit and acknowledgement form.
- Sec.5.c The person registering for a campsite must be at least 18 years or older and the minor persons using the permit must have a responsible adult immediately accessible within the park.

- Sec.5.d An organized youth group camping with their leaders shall be registered on one permit.
- Sec.5.e Any person registering for a permit shall provide the names of additional persons present within the park, upon request.
- Sec.5.f A permit holder shall only occupy a campsite assigned by park staff.
- Sec.5.g A motor home traveling to the campground without an additional vehicle will be charged the normal fee for a vehicle permit as it is assumed the motor home is their primary form of transportation.

A motor home traveling to the campground with an additional vehicle (tow or accompanying) will be charged the normal vehicle pass for the accompanying vehicle and will not be charged a fee for the motor home, provided the motor home does not leave the campground for the duration of their stay.

- Sec.5.h At Brower Park, a camping permit may be used for a period not exceeding 21 days, with the exception of seasonal sites and pre/post seasons, when camp permits may be used for a period not exceeding 31 days. Pre-season being defined as when the park opens in the spring thru 1:00 p.m. the Sunday prior to the Memorial Day Weekend. Post season being defined as from 1:00 p.m. the Sunday of the Labor Day weekend, until the park closes for the season.
- Sec.5.i In the event an identified camper notifies park office staff of their lot abandonment, the lot shall become available.

In the event there is no notification of abandonment, and a campsite remains unoccupied, the lot shall be held for a 24-hour period, which shall then constitute abandonment and the lot shall become available.

Sec.5.j Nothing contained herein shall exempt the users of the reserved facilities from full compliance with all laws, ordinances, and rules of the Commission relating to use and conduct on Commission property.

Section 6: RESERVATIONS

- Sec.6.a Campsite reservations will be accepted at Brower, Merrill-Gorrel, School Section, and Paris Parks. Cabin reservations will be accepted at all parks.
- Section 7: CAMPING

No Person Shall:

Sec.7.a Camp except in areas provided and designated for such use.

- Sec.7.b Camp without a permit. In the event that a camping unit occupies a site for more than 24 hours after the camping permit expires, the Abandonment Policy will take effect. Once a camping unit has been abandoned, the Mecosta County Park Commission reserves the right to tow the camping unit at the expense of the permit holder and accepts no liability for the contents or safety of the camping unit. In addition, if the campsite occupied by the abandoned camping unit displaces the next reservation on the campsite, the permit holder of the site occupied by the abandoned camping unit will be charged double for each night the campsite is occupied past the check out date on the camping permit.
- Sec.7.c Allow a campsite to be occupied overnight by more than 8 individuals.
- Sec.7.d Allow minors to occupy a campsite without adult supervision.
- Sec.7.e Allow persons, other than those registered, to use a campsite or transfer a campsite permit to another guest.
- Sec.7.f Allow more than two motor driven vehicles, one primary camping unit, one additional soft-sided camping tent, and one trailer (boat or utility) to occupy a single campsite between the hours of 10:00 p.m. and 8:00 a.m.
- Sec.7.g Create a disturbance to disrupt the peace, quiet and tranquility of the camping area during quiet hours of 10:00 p.m. and 8:00 a.m.
- Sec.7.h As a non-camper visit campers, or as a camper allow non-camper visitors, between the hours of 10:00 p.m. and 8:00 a.m.
- Sec.7.i Continuously walk or cruise in any motor-driven vehicle in, through and around campsite areas for the purpose of attracting attention or distracting persons using campsites except registered campers/persons to a specific registered campsite.
- Sec.7.j Wash dishes at water outlets; dump dishwater on campsites; or discharge wastes of any type on campsites or park premises, except in designated containers, drains or dumping stations.
- Sec.7.k Occupy a campsite after checkout time of 1:00 p.m. on the last day covered by the permit. Violators will be fined a \$50 fee.
- Sec.7.1 Allow their campsite to become cluttered or unkempt in a manner that will reflect negatively on the Park Commission. Campsite grounds shall be kept free of personal property which may impede the staff's ability to trim and maintain the grounds. Individual campsite cleanliness standards shall be at the discretion of the campground management and staff.
- Sec.7.m Have a satellite dish unattached from their camping unit unless the satellite dish is under one yard in diameter and is moved when campsite maintenance or mowing is scheduled.

Sec.7.n	Utilize outside refrigeration equipment larger than 5.5 cubic feet and in excess of 36" in
	height. No more than one outside refrigeration device per lot will be allowed. All outside
	refrigeration equipment must be in proper working condition. Outside refrigeration
	equipment includes, but is not limited to refrigerators, freezers, ice makers and electric
	coolers.

- Sec.7.0 Store an excessive number of items under the camper or in front of the tongue.
- Sec.7.p Water grass on campsites unless utilizing an in-hand spray nozzle. Watering of roadways is strictly prohibited.
- Sec.7.q Wash their camping unit, vehicles, or personal equipment on Park Commission property.
- Sec.7.r Use the park grounds to provide services, vending, or business operations which result in a direct financial benefit, unless prior written consent from the Park Superintendent or designee has been granted.
- Sec.7.s Store more than one face cord (8 ft. x 4 ft. stack) of firewood on a campsite.

Section 8: FIRES

No Person Shall:

- Sec.8.a Willfully set fire to or cause to be set fire to any tree, woodland, brushland, grassland, or meadow.
- Sec.8.b Build any fire except within receptacles approved and designated for such purposes. Fire receptacles shall not be relocated from existing placement or altered.
- Sec.8.c Drop, throw or scatter lighted matches, burning cigars, cigarettes, tobacco paper or other flammable material within or upon Commission property.
- Sec.8.d Dispose of coals or ash except in designated areas provided for such purposes.
- Sec.8.e Leave a fire unattended.
- Sec.8.f Leave infants or children unattended near fires or hot receptacles.
- Sec.8.g Build a fire of a size larger than that approved by a park manager, which may be limited, or prohibited entirely, in the interest of fire safety based on existing conditions or circumstances.

Section 9:	MOTOR DRIVEN VEHICLES (Motor driven vehicle regulations include all permitted
	vehicles powered by a fueled or electric motor. See additional rules for motorcycles and
	golf carts.)

Sec.9.a Operators must provide proof of a valid driver's license upon request.

No Person Shall:

- Sec.9.b Operate a motor driven vehicle of any kind while intoxicated or impaired, or with an open alcohol container.
- Sec 9.c Operate a motor driven vehicle of any kind or nature except on designated roads and parking areas.
- Sec.9.d Operate a motor driven vehicle on any park road at a speed exceeding 10 miles per hour or at any speed greater than that posted.
- Sec.9.e Violate provisions of the Motor Vehicle Code Act #300 of the Public Acts of 1949, as amended.
- Sec.9.f Form an obstruction to traffic upon any roadway or in any parking area.
- Sec.9.g Be allowed to ride in or on the bed, tailgate, or outside portions of a motor vehicle. Further, no person is permitted to ride in or on towed equipment such as a utility or boat trailer, loaded or unloaded or any similar item with the exception of park sponsored activities.
- Sec.9.h Operate a vehicle that is not licensed for roadway use.
- Sec.9.i Operate an ORV (off road vehicle) on park commission property.

Park maintenance vehicles, emergency vehicles, and motorized enabling vehicles are exempt from the above rules.

Section 10: MOTORCYCLES AND GOLF CARTS

Motorcycles are allowed in all of the Mecosta County Parks. Golf Carts are allowed in School Section, Merrill-Gorrel and Paris Parks.

- Sec.10.a Appropriate vehicle permits must be purchased and affixed to any motorcycle as directed by park staff. To be admitted to any park, a motorcycle must be licensed and insured for on road travel.
- Sec.10.b All golf carts must be registered at the park office with an annual vehicle permit affixed before they are permitted for use within a park.

- Sec.10.c Drivers must be at least 16 years of age with a valid driver's license.
- Sec.10.d No standing is allowed on a moving golf cart. Only one person per designated seat permitted. Keys must be removed when not in use.
- Sec.10.e All golf carts must be parked during the hours of 10:00 p.m. (or dusk, whichever comes sooner) 8:00 a.m.
- Sec.10.f Golf carts are limited to one (1) per campsite.
- Sec.10.g All golf cart owners are responsible for their guests and must make sure guests know and follow all rules.
- Sec.10.h Motorcycle and golf cart users shall comply with all other rules and regulations governing motor driven vehicles, not inconsistent with this paragraph.

Section 11: PARKING IN PROHIBITED AREAS

No person shall stop, stand, or park:

Sec.11.a A motor driven vehicle, or any trailer, boat, or other towed vehicle of any kind, upon any roadway or in any parking area in such manner as to form an obstruction to traffic thereon.

Section 12: BOATING

- Sec.12.a No person shall bring into, launch, moor, use or navigate any boat, canoe, kayak, raft, or other watercraft upon any watercourse, river, lagoon, lake, pond or sloughs located within or upon Commission property, except at such time and place as provided or designated for such purpose. All such watercraft shall comply with all Federal and State laws and all rules, regulations and responsibilities governing the use and operation of watercraft.
- Sec.12.b Day use watercraft trailers may be parked in designated parking areas only and must remain attached to their tow vehicle.
- Sec.12.c A person must be a current registered camping guest at the park to keep or moor a boat within the park overnight. Campers must keep their watercraft trailers on their campsite or in designated trailer storage areas during overnight hours.
- Sec.12.d Watercraft are required to display an annual Mecosta County Parks mooring permit when mooring within any park. Watercraft may only be moored or anchored in designated areas.
- Sec.12.e Annual mooring permits must be permanently affixed to the starboard (right) side of the watercraft in line with and 3 inches from the registration numbers/decal. Mooring permits must be affixed in a location visible when watercraft is moored and covered.

- Sec.12.f Mooring areas are available on a first come first serve basis. Reserving of a specific mooring post or area is prohibited.
- Sec.12.g Boat docks, including mooring or other tie down devices or structures may not be constructed or installed. Any of the above not constructed by the Park Commission will be removed.
- Sec.12.h Watercraft are not permitted to operate above "slow, no wake speed" within 100 feet of designated swimming areas.
- Sec.12.i Motor driven vehicles, watercraft, trailers, and other personal property left on Park Commission property in violation of these rules are subject to removal and impoundment. The owner may reclaim possession of such property upon payment of the charges incurred on such property for its removal and storage.

Section 13: OPERATION OF BICYCLES

Bicycles shall be operated as closely to the right-hand side of the path, trail or roadway as conditions permit and shall be ridden single file.

No Person Shall:

- Sec.13.a Operate a bicycle in a manner which endangers pedestrians, oneself, and other bicyclists.
- Sec.13.b Operate a bicycle on a sidewalk or swimming beach, within a building or structure, or within any area posted as prohibited to such use.
- Sec.13.c Ride upon or carry any person upon a bicycle handlebar or frame.
- Sec.13.d Operate a bicycle between sunset and sunrise.

Section 14: PEDDLING AND SOLICITING

No person shall peddle or solicit business of any nature whatever, or distribute handbills, or other advertising matter, or post unauthorized signs on any lands, waters, structures, or property of the Commission, unless first authorized in writing by the Commission or its authorized agent.

Section 15: LOUDSPEAKERS

No person shall:

Sec.15.a Use a loudspeaker, public address system or amplified equipment within or upon Commission property without a written authorization issued by the Commission or its authorized agent.

Sec.15.b Make use of any sound amplification device, audio device, or car stereo which produces sound at a level which can be heard clearly 25 feet from the source, bothers or annoys other park users, park neighbors, or in any other way disturbs the peace and order of a park area unless prior written authorization is obtained from the Commission or its agent as a part of or separately from a facility reservation.

Section 16: LITTERING

No Person Shall:

- Sec.16.a Discard, or deposit refuse of any kind or nature except by placing said refuse in containers provided for such purpose.
- Sec.16.b Throw, lay, drop, or discharge into or leave on lands or in waters any substance, matter or thing, liquid or solid, which may or shall result in the pollution of said lands and waters.
- Sec.16.c Dispose of any smoking waste or tobacco product waste onto any beach, playground, grass, or other area except by placing said waste into containers provided for such purpose.

Section 17: PERSONAL CONDUCT

No Person Shall:

- Sec.17.a Be under the influence of intoxicants, narcotics, or other mind affecting drugs, unless prescribed by a physician or done in accordance with Federal, State and local law.
- Sec.17.b Bring alcoholic beverages onto Commission property except for personal consumption in moderate amounts in conjunction with day use activities, camping, and reserved group functions. The sale, furnishing, and/or distribution of alcoholic beverages in any manner whatsoever is prohibited. Additionally, no kegs or alcoholic beverages in bulk containers are permitted. Bulk is defined by the Commission as anything larger than a 12-ounce container for beer or a wine cooler and anything larger than a 750-ml container for any other alcoholic beverage.
- Sec.17.c Store or place alcoholic beverages in a visible and easily accessible location when not directly monitored or allow for underage consumption of alcoholic beverages upon Commission property.
- Sec.17.d Smoke within 50 feet of any building, pavilion, bathhouse, cabin, playground, beach or designated swimming area.
- Sec.17.e Engage in any violent, abusive, loud, boisterous, vulgar, lewd, wanton, obscene, indecent, or otherwise disorderly conduct tending to create a breach of the peace, or disturb or annoy others, while in or on any Commission property.

- Sec.17.f Appear on property administered by the Commission in a state of nudity, or commit, perform, engage in any lewd, lascivious, obscene, or indecent act or behavior, or make any indecent exposure.
- Sec.17.g Allow any person under ten years of age to use, enter, or be in a bathhouse, playground, or beach area without the supervision of an adult. Children under ten must be accompanied by an adult after 10 pm when not on a campsite.
- Sec.17.h Conduct or participate in any form of gambling, lottery or game of chance upon Commission property except as permitted by state law and approved by the Commission.
- Sec.17.i Organize or arrange any event, gathering, tournament, game or other activity open to public participation in which a fee is charged, or donation collected within property administered by the Commission without prior written approval from the Superintendent or designee.
- Sec.17.j Impersonate any employee or contracted employee of the Commission.
- Sec.17.k Interfere with any park employee in the course of his or her duties or refuse to obey any lawful command of any park employee.
- Sec.17.1 Resist, obstruct, be abusive, or address in a profane or obscene manner any Commission agent or employee.

Section 18: SWIMMING, BATHING, AND WADING

No Person Shall:

- Sec.18.a Swim, bathe, wade, snorkel or scuba dive in any of the watercourses, lakes, ponds or sloughs located within or upon Commission property except at such times and places as may be designated for such purposes.
- Sec.18.b Have glass containers within 50 feet of any beach area or in the water adjacent thereto.
- Sec.18.c Tamper with, remove, destroy or in any manner whatsoever, render useless swim area markings or equipment designated and situated for water rescue and safety purposes.
- Sec.18.d Use safety and rescue equipment for any purpose other than water rescue or safety purposes.
- Sec.18.e Bring a hot tub, portable hot tub or a portable pool into any park at any time.

Section 19: DESTRUCTION OF PROPERTY

No Person Shall:

- Sec.19.a Willfully destroy, deface, alter, change or remove any monument, stone marker, benchmark, stake, post or blaze marking, or designating boundary line, survey line, or reference point.
- Sec.19.b Cut, break, mark upon or otherwise injure any building, equipment, bridge, drain, wall, fountain, lamppost, fence, gate, hedge, or other structure.
- Sec.19.c Deface, destroy, or remove any placard, notice or sign, whether permanent or temporary, posted or exhibited within or upon Commission property.
- Sec.19.d Appropriate, excavate, injure, or destroy, any historic site or prehistoric site or any artifact, without permission of the Commission.

Section 20: DESTRUCTION OF PLANT LIFE AND NATURAL SURROUNDINGS

No Person Shall:

- Sec.20.a Cut, remove, chip, blaze, box, girdle, trim, pick, gather, uproot, remove, deface, or destroy any flower, plant, tree, sapling, seedling, bush or shrub. Guests are permitted to cut the grass on their individual campsites utilizing a power mower/trimmer daily between the hours of 10:00 a.m. and 6:00 p.m.
- Sec.20.b Remove or cause to be removed any sod, earth, humus, peat, boulders, gravel or sand, without written permission of the Commission.
- Sec.20.c Tie objects from any tree, hang or use a slack line, tight rope, or clothesline unless prior permission is obtained from Park Management.
- Sec.20.d Hang or use a hammock in any manner that could cause damage to a tree, off-trail area, or manmade structure. Hammocks may be hung using double wrapped wide straps on trees over 6 inches in diameter upon a registered campsite or within 10 feet of an established trail.

Park maintenance operations are exempt from the above rules.

Section 21: HUNTING, FISHING, TRAPPING

Sec.21.a Fishing within any property managed by the Commission shall be permitted in accordance with Commission guidelines and the laws of the Department of Natural Resources of the State of Michigan.

No Person Shall:

- Sec.21.b Hunt, trap, catch, wound, kill, or treat cruelly any bird or animal. Molest or rob, any nest, lair, den or burrow of any bird or animal in or upon any land or waters administered by the Commission.
- Sec.21.c Feed or bait wildlife on property administered by the Commission, including feeders intended for birds, squirrels, or other common park animals.
- Sec.21.d Fish within a designated swimming area.
- Sec.21.e Fish in an area where fishing is prohibited by posted notice.

Section 22: FIREARMS

Sec.22.a All persons shall comply with all State and Federal laws pertaining to weapons and/or firearms.

No Person Shall:

- Sec.22.b Discharge or set off a pistol, rifle, shotgun, slingshot, or any other instrument which discharges a projectile by air, explosion, or any other force except for any deputy sheriff, police officer, or other duly appointed law enforcement officer carrying out the duties and responsibilities of their position or by a person carrying a weapon in accordance with Michigan law and in the legal defense of human life unless prior written permission is obtained from the Commission or its agent.
- Sec.22.c Store firearms and ammunition unless kept in locked cases and/or trigger guards attached when not in use.

Section 23: PETS

If you have a pet, you must abide by the following rules. Failure to comply shall subject you to any remedy provided for violation of these rules, including immediate eviction of the pet and owner.

- Sec.23.a Two pets per campsite are permitted in Brower, Merrill-Gorrel and Paris Parks and at Haymarsh and Tubbs Lake State Game Area campgrounds. No pets shall be allowed in School Section Lake Park.
- Sec.23.b Pets that are permitted are domesticated dogs, cats and small birds in cages.
- Sec.23.c Park staff may allow a pet not specifically defined above if similar in characteristics to a domestic dog or cat and approved in writing by the Park Superintendent or designee.

- Sec.23.d Park staff may refuse to admit or require removal of any domestic pet which exhibits dangerous or vicious behavior which could be a hazard to other persons in the park.
- Sec.23.e Service animals are permitted in any Mecosta County Park in accordance with the guidelines of the Americans with Disabilities Act.
- Sec.23.f All pets shall be kept in the direct possession or under the immediate control of its owner or owner's agent. Pet owner or owner's agent shall not allow any pet in their possession to create a nuisance or other disturbance.
- Sec.23.g When your pet is on your campsite, your pet may be placed on a tie-out provided the length of rope does not exceed the campsite boundaries and that a responsible adult is present and in direct control of the animal. Portable crates created for the purpose of transporting your pet are also acceptable for restraining your pet on a campsite.
- Sec.23.h When removed from the confines of the individual campsite, your pet must be on a leash, not to exceed 6 feet in length.
- Sec.23.i Pets are not permitted in beach areas, playgrounds, pavilions, park buildings or within the boundaries of a rental cabin site.
- Sec.23.j No person shall walk any pet without having in possession a device to pick up pet waste. Pet waste shall be cleaned up immediately and disposed of utilizing a proper waste deposal method.
- Sec.23.k Your pet must have a current rabies shot, and/or usual and customary shots required for the type of pet. Proof may be required before entrance into the park.

Section 24: REMOTE CONTROLLED DEVICES AND RIDE ON TOYS.

No Person Shall:

- Sec.24.a Operate remote controlled toys such as cars or trucks unless in an area designated for their use.
- Sec.24.b Use battery operated ride on toys in any campground at any time.

Section 25: AERIAL DEVICES AND FIREWORKS.

- Sec.25.a No person shall launch, land or operate any unmanned, remote-controlled aircraft unless authorized in writing by the Park Superintendent or designee.
- Sec.25.b No person shall launch, land or operate any aerial device such as ultra-light aircraft, hot air balloons, parasails, parachutes, and sky lanterns unless authorized in writing by the Park Superintendent or designee.

- Sec.25.c No person shall offer for sale, sell as retail, expose for sale, possess, give, furnish, transport, use, explode, or cause to explode fireworks on Park Commission property.
- Sec.25.d Any person operating any manned or unmanned aerial device who has obtained authorization shall do so in accordance with all federal, state, and local laws, regulations, ordinance, and guidelines.

Section 26: PATIO AND STORAGE SHED CONSTRUCTION

The installation of a Patio or Storage Shed is subject to the following requirements:

Sec.26.a	Only one Patio and/or Storage Shed per seasonal campsite is permitted.
Sec.26.b	No footings or permanent foundation are to be used. Construction shall be at ground level only and shall follow the contour of the ground. No digging or trenching is permitted.
Sec.26.c	Patio size shall not exceed 160 square feet (example 8' x 20') ramp and/or steps included. Storage Shed size shall not exceed a footprint of 48 square feet (example 6' x 8.')
Sec.26.d	Patios or sheds shall be constructed in sections that are easily removable. Patio pavers, wooden patio sections or like materials count toward the total allowable footprint.
Sec.26.e	No railings, benches, posts, fencing or facings, etc. are to be installed.
Sec.26.f	Walkways between patios or sheds are not allowed. Patio pavers are not permitted on a campsite in separation from the main footprint of the patio.
Sec.26.g	If a special type of patio is required to be used as an enabling device by the physically challenged, a request should be made to the Superintendent or designee for a special consideration permit.
Sec.26.h	Patio and Storage Shed placement, building materials and the type of construction is subject to approval by the Superintendent or designee. If a Patio or Storage Shed is found not to be in compliance, it shall be removed or altered in order to meet proper

Section 27: EMERGENCY POWERS

requirements.

Nothing in these rules shall:

- Sec.27.a Prohibit or hinder any Commission employee or agent, or any peace officer from performing their official duties.
- Sec.27.b Prohibit the Commission from establishing emergency rules required to protect the health, welfare, and safety of park visitors; to protect park property; to maintain order.

Section 28: VIOLATION OF RULES

- Sec.28.a Upon a violation of any provision of the foregoing rules, the Superintendent or designee, a park manager, assistant manager, a member of the Mecosta County Park Board or law enforcement officer may revoke user privileges and order the offending person(s) to leave park property. Any person who has been evicted from park property pursuant to a violation of park rule(s) shall be deemed ineligible to use and/or be present on any Mecosta County Park property for the time limit given in writing up to and including a permanent eviction based on the severity of the offense. Upon eviction notice, any continued use or re-entry to Park Commission property will lead the Park Commission to pursue a trespass violation of the law.
- Sec.28.b In addition to any administrative penalty provided for herein, any person violating any provision of the foregoing rules shall be guilty of a misdemeanor and upon conviction thereof shall be fined not more than \$100.00 and costs of prosecution, or imprisoned in the county jail for a period not exceeding 90 days, or both, for each offense, at the discretion of the court.

Section 29: REINSTATEMENT OF USER PRIVILEGE

Sec.29.a Any person who has been evicted from park property pursuant to a violation of park rule(s) shall be deemed ineligible to use and/or be present on any Mecosta County Park Commission property for the term specified. To appeal the terms of an eviction, a written request is required to the administrative office so that the requesting party can be given a time and date to come before the Commission for re-determination. Commission members may evaluate any eviction notice and term for re-determination. Reinstatement of user privileges requires a majority vote of the Commission members present.

Section 30: SEPARABILITY

Sec.30.a The provisions of this ordinance are separable, and the invalidity of any phrase, clause or part of this ordinance shall not affect the validity or effectiveness of the remainder of the ordinance.

Section 31: EFFECTIVE DATE

Sec.31.a This Ordinance shall become effective on the date that Notice of Adoption is published in a newspaper of general circulation in the County. At the time this Ordinance takes effect, the existing Park rules promulgated under the authority of Public Act 261 of the State of Michigan (1965), as amended, are hereby repealed.

AGENCY INFORMATION

Meals on Wheel Mecosta County feels confident that together with United Way's long-standing partnership, we're building strong interdependent community, while building individual strength and security for isolated Seniors within Mecosta County.

Last year our Meals on Wheels program assured sound nutrition and optimized health, to 317 Seniors by providing 48,488 meals. (These individuals are homebound and/or isolated, not leaving their homes under normal circumstances due to physical/mental reasons, unable to prepare and shop for food on their own). Often our meal delivery person is the only person they see, making the delivery even more important as they also perform an overall wellbeing check for the Seniors, both nutritionally and emotionally.

The uniqueness of our programming, as our mantra states is, we provide "A Meal & So Much More". This starts with the volunteer help of 32 community members, who travel across Mecosta County over 79,400 miles a year, to DELIVER to isolated Senior's homes, a hot meal AND a friendly wellbeing check.

GRANT PURPOSE

Meals on Wheels serves the daily nutritional needs of Mecosta County Seniors (60 years of age and older). We eliminate hunger and resolve isolation, by offering nutrition education and delivering scratch cooked meals along with a daily check, thus assuring "Basic Crisis Needs of the Severest Nature" are met.

Our goal is to help secure homebound Seniors who are nutritionally at risk, by fulfilling, strengthening, and empowering not only their bodies but also their minds, for overall health and wellness. Optimum health brings improved living, which eliminates or at a minimum, limits relying on other people or costly programs/services (such as private care, assisted living, and institutional care).

Our program serves on a "priority needs basis" since Senior hunger is not just an income issue. Many Seniors who can afford good nutrition, lack access/care or mobility/ability. So sadly, half of Senior health concerns are primarily due to lack of proper nutrition, (1 out of every 7 Seniors, lack proper nutrition.) And ironically, ONE DAY spent in the hospital costs more than a WHOLE YEAR'S supply of Meals on Wheels.

On-going challenges (other than those experienced by everyone over the last year), is trying to cover the everrising need of high-priority clientele, increased food/gasoline costs, reduced governmental funding, and clients growing limitations to give the full suggested donation amount.

EVALUATION

*Definition of a unit of service, is the nutritional meal AND important well-being check, (48,488 last year.) *Service need is measured by a detailed, personal assessment (or phone when personal contact is not possible.).

*Service control is assured with reassessments being done every six months, or earlier if needed. *Service success is measured by our "Outcome Surveys", which are done annually. All information/data is compiled and stored in our data-base system, which helps us keep service quality high & costs low, and produce statistical reports used to secure program funding.

VOLUNTEERS

The success of our Meals Program relies on MANY community members coming together and believing in our mantra, "It's a Meal & So Much More." Such collaboration allows us to continue to promise the Seniors of Mecosta County high service, and quality care.

Last year, Mecosta Meals Program saved \$22,405 in-kind when 2,270 work hours were volunteered. Within these extraordinary efforts of 32 VOLUNTEERS (deliverers, packagers, dish washers, program aides.)

CURRENT CLIENT SUCCESS STORY

Mr. G's sole purpose in life has been, taking care of his family. Even at the age of 95 he continues to singularly care for his daughter who is now 70 years old, (she has always lived with her father due to care needs of debilitating polio and other health issues.)

Mr. G is a proud man who wants to be there for his daughter, however progressive health changes for both has made daily living tasks more and more difficult.

Mr. G contacted Mecosta County Commission on Aging to request help with keeping both himself and his daughter from being institutionalized. A Case Worker went to their family home to do an at-home evaluation, where information was received and given to design a helpful "care plan." Due to meal preparation being very difficult now, it was recommended that Meals on Wheels would be included as part of the care plan for both.

Thanks to hot meals being delivered to their home Monday, Tuesday, Thursday, Friday, and frozen meals for Wednesday, Saturday, and Sunday, BOTH Mr. G and his daughter can remain TOGETHER in their family home and avoid being separated into nursing facilities. (Saving the whole community, as just 1 day in a nursing-home costs community assistance MORE than a WHOLE YEAR of Meals on Wheels delivering nutritiously wholesome meals.)

COVID AGENCY STORY

The COVID-19 pandemic recommendations continue to require redesigning our programming. Thinking outside the box has become a necessity to keep our Meals on Wheels "rolling" in a safe manner. Many delivery difficulties have been over-come. While individuals are quarantining due to virus contact, well-being checks have resorted to telephone calls out of necessity.

Unfortunately, community fundraising opportunities have continued to be negatively affected. Due to many events being postponed, our income has taken a decline. We remain hopeful for 2022-year end improvements.



- Any allocated agency found in possible violation of this policy will be notified in writing and asked to respond to MOUW concerning the circumstances surrounding the possible violation in writing.
- 2) The MOUW Board of Directors Executive Committee will review all details of the possible violation, including the agency's written response. Should an agency be found in violation, the Executive Committee will provide a recommendation for action to the MOUW Board of Directors.
- 3) Penalties available to the MOUW Board of Directors, which includes but are not limited to any or all of the following:

*Agency is placed on a period of probation

- *Agency's funding allocation receives a pro-rated reduction
- *Agency's funding is terminated

The Mecosta County Planning Commission gains their authority and duties through both the Michigan Planning Enabling Act (PA 33 of 2008) and the Michigan Zoning Enabling Act (PA 110 of 2006). The Michigan Planning Enabling Act (MPEA) provides for the creation, organization, powers, and duties of Planning Commissions. The Michigan Zoning Enabling Act (MZEA) provides for the adoption of zoning ordinances and the establishment of zoning districts and prescribes powers and duties of certain officials including the Planning Commission and Zoning Board of Appeals

Section 19 of the MPEA (MCL 125.3819) requires the Mecosta County Planning Commission to make an annual written report to the County Board of Commissioners. This report is to provide the Board with a summary and status of planning activities over the past year. As the Planning Department is combined and operated with Building the report will include information about both sectors of the Department as well as the Plan Commission and Zoning Board of Appeals.

PLAN COMMISSION ACTIVITY

The Plan Commission had eleven meetings this year. Within the meetings there were 32 special use requests, seven site plan reviews, two zoning map amendment requests, and one zoning ordinance text amendments. The Board also reviewed one private road. The zoning map amendments were approved by the Board of Commissioners. The Amendments which were sent before the Board of Commissioners are listed below.

ZONING TEXT AMENDMENTS:

One zoning text amendments took place in 2021. The Board investigated and approved allowing storage containers in some of our zoning districts with restrictions.

ZONING MAP AMENDMENT:

There were two zoning map amendments. One was for a green house facility on Monroe Road in Aetna Township and the other was for an existing residential structure on Northland Drive in Aetna Township.

67 of 101 Zoning Board of Appeals Activity

The Zoning Board of Appeals had eleven meetings in 2021. There were 20 variance requests. All but one of the variance requests were approved.

ZONING CLEARANCE AND VIOLATIONS

Zoning clearances are issued by the department for all building permits which are within our zoning jurisdiction. There are also zoning clearances issued for agricultural buildings and land splits. This year the department issued a total of 331 zoning clearance permits, which include land splits and camping permits. The purpose of the permit is to ensure that all proposed structures or changes are in conformance with the zoning ordinance. For the most part this means checking setbacks, height, percent land cover, but could also be road frontage, easements, and acreage requirements. 41 of the Zoning Clearance permits were issued for Agricultural Buildings in Mecosta County. There were also eight administrative zoning variances issued in 2020.

In 2021 there were 152 zoning enforcement cases up from the 91 of 2020 and 39 building enforcement cases down last year from 54.


68 of 101 Building Permit Activity

The department continued to see an increase in the number of building permits issued this year.

COMMERCIAL BUILDING ACTIVITY:

In 2021 the department issued 41 commercial building permits. The breakdown of the permit categories can be found in the graph below.


In 2020 there were 46 commercial building permits, so the department saw a decrease of 10.875% from 2020 to 2021.

69 of 101 Residential Building Permits

In 2021 there were 337 residential building permits, 513 electrical permits, 508 mechanical permits and 166 plumbing permits. In 2020 there were 319 residential building permits pulled. We also issued 475 electrical permits, 497 mechanical permits, and 151 plumbing permits. Electrical, plumbing, and mechanical permits also include those pulled for commercial projects. The breakdown of the building permits for both years is diagramed in the graph below. Residential permits saw an increase of 5.3%.



OTHER WORK IN 2021

In 2020 the office discontinued doing the rental inspections for the City of Big Rapids. With the busy schedule with the Planning Commission and Violations, not much "extra" work was completed. The staff was successful in abating 3 eyesores in the community (one being torn down and two being improved to the point that they are not considered a violation any longer).

MOVING FORWARD IN 2022

In 2022 the department is doing some major cleaning. We worked last year on figuring out a solution to our storage issue and are now working on implementing the solution. It is going to be a long process, but hopefully we can complete it within the year. Staff would also like to look at doing the 5-year update of the Master Plan (the Planning Commission decided not to do it last year as the census was taking place) depending on when the full census data will be released.

INTRODUCTION

TO THE MECOSTA COUNTY BOARD OF COMMISSIONERS

In compliance with the provisions of the Michigan Drain Code, Section 31 of Chapter 2, of Act No. 40, of the Public Acts of 1956, I am pleased to submit the 2021 Annual Report for the Mecosta County Drain Commissioner's Office. This report is for the period January 1, 2021, through December 31, 2021.

The Drain Commissioner has jurisdiction over county drains and drainage districts created under the Drain Code, including the maintenance of those drains and construction of improvement projects. Mecosta County has 39 county drains.

The Drain Commissioner is the delegated authority under Part 307 of PA 451 of 1994 (Inland Lake Levels) of Natural Resources and Environmental Protection Act (NREPA) responsible for maintaining lake levels and levying special assessments for costs involved. Mecosta County has 7 court ordered lake level control structures.

The Drain Commissioner is a member of lake improvement boards established under Part 309 (Inland Lake Improvements) of NREPA, along with appointed county commissioners, a representative from a local unit of government, and a lake owner representative. Mecosta County has 3 lake improvement boards.

The Drain Commissioner is the County Enforcing Agency under Part 91 of NREPA (Soil Erosion and Sedimentation Control). The County Enforcing Agent is responsible for the administration and enforcement of Part 91 of NREPA, and may charge fees, review plans, and issue permits. Also, the Drain Commissioner oversees the review of storm water site plans for Mecosta County, Big Rapids Charter Township, Mecosta Township, and Morton Township building and zoning departments at their request.

This report is not only an accounting of the funds for County drains and lake level accounts, but also an overview of the projects worked on in 2021.

The following are some highlights of this report:

- Completion of Ford Drain petition project
- Completion of the Brady Lake Dam replacement
- Completion of the State mandated triennial inspections of Blue Lake, Chippewa Lake and Horsehead Lake Dams
- Legal review of select drains and dams
- Compliance with Soil Erosion and Sedimentation Control (SESC) program audit
- Issuance and inspection of SESC permits

2021 COMMITTEES, APPOINTMENTS & MEETINGS

Michigan Association of County Drain Commissioners (MACDC)

The Michigan Association of County Drain Commissioners (MACDC) is the professional association for County Drain and Water Resources Commissioners. Mecosta County is part of the Northwest District of this association. The Drain Commissioner is a member and attends meetings and the annual conferences.

Drain Committee

The Drain Committee meets quarterly with the purpose of keeping the County Board of Commissioners informed of projects that might involve their districts or the County as a whole. This Committee also meets as needed to address ongoing drain or lake level control (dam) projects. The Drain Commissioner is a member, and the members of the County Board of Commissioners change each year.

Mecosta County Park Commission

The Drain Commissioner is a Board Member of the County Park Commission, which sets policy for the parks and oversees the general operation of the County Park system.

Department of Public Works (DPW)

The Drain Commissioner is a Board Member of DPW. The DPW allows the County the ability to participate with townships, villages, or cities, in financing of bonds for projects involving water supply systems, sewage disposal systems, refuse systems, lake improvements and erosion control systems within the county.

Lake Improvement Boards

Local Emergency Planning Team (LEPT)

2021 COUNTY DRAIN PROJECTS

Blanchard Intercounty Drain – Millbrook Township

Blanchard Intercounty Drain is an intercounty drain with Isabella County. Established in 1916, in Sections 24 and 25 of Millbrook Township, Mecosta County, and Sections 17, 18, 19, 20 and 30 of Rolland Township, Isabella County. The length of this drain in Mecosta County is 1.26 miles and 3.71 miles in Isabella County, for a total length of approximately 4.97 miles. This is a combination of open ditch and tiled drain.

In 2021, a small area near the drain was regraded to improve drainage of a farm field.

Colby Lake Drain – Colfax and Martiny Townships

Colby Lake Drain was established in 1909. Located in Sections 11 and 12 of Colfax Township and Section 7 of Martiny Township, this is an open channel system approximately 1.98 miles in length.

Beaver activity continues to be a problem for this drainage system. Several beavers and their dams were removed from the drain in 2021.

Culp Drain – Millbrook Township

Culp Drain was established in May of 1909. Located in Sections 22, 23, 24, 26, 27 & 28 of Millbrook Township, this is an open ditch drainage system approximately 4.23 miles in length.

An Engineer was hired to inspect the entire drain to determine its condition since the petition project was completed in 2015. There are several downed trees is the drain which need to be removed. This drain will require maintenance in 2022.

An Attorney was hired to review the historical documents for this drain to make sure it was created with all the proper papers and orders. The result is that this is a legally established drain and drainage district.

Edgar Intercounty Drain - Deerfield and Hinton Townships

Edgar Intercounty Drain is an intercounty drain with Montcalm County. Established in 1905, in Section 36 of Deerfield Township and Sections 30 & 31 of Hinton Township, Mecosta County, and Section 6 of Cato Township and Section 1 of Winfield Township, Montcalm County. The length of this drain in Mecosta County is 2.75 miles and 1.26 miles in Montcalm County, for a total length of 4.01 miles. This is an open channel drain.

In 2019, both Counties were contacted about the need to clear this drain to provide a good outlet for other county drains that flow into this drain. An Engineer was hired to inspect the drain to evaluate the need for maintenance. In 2020, maintenance was done to dip out channel and remove debris from channel. In 2021, the maintenance for this drain was completed.

Ford Drain – Aetna, Austin, and Mecosta Townships

Ford Drain was established in 1902. Located in Section 35 & 36 in Mecosta Township, Section 31 of Austin Township and Sections 1 & 2 of Aetna Township, this is an open channel system approximately .85 mile in length.

Pursuant to Section 197 of Act No. 40, P.A. 1956, as amended (The Drain Code) we were able to hire an engineer to review the district boundaries and apportionments and hold a Day of Review of District Boundaries and a Day of Review of Apportionments. This was done on August 14, 2019.

Soon after the review of the district, a petition for drain maintenance was received. The scope of the maintenance on this drain was determined in 2020. The work on this drain was substantially completed in 2020. This project was completed in the spring of 2021.

<u> Green Drain – Sheridan Township</u>

Green Drain was established in September of 1916 in Sheridan Township, Section 8. This is an open ditch drain approximately 1.53 miles in length.

Pursuant to Section 197 of Act No. 40, P.A. 1956, as amended (The Drain Code) we were able to hire an engineer to review the district boundaries and apportionments and hold a Day of Review of District Boundaries and a Day of Review of Apportionments. The field review of this drain was done in 2020. This review of the district was completed in 2021.

Hills of Mitchell Creek- Big Rapids Charter Township

Hills of Mitchell Creek Drain is in the Hills of Mitchell Creek Subdivision, Section 10 of Big Rapids Charter Township. It is established as a 433 Drain creating the drain and drainage district under the 433 Agreement. On January 14, 2008, the Drain Commissioner accepted the Hills of Mitchell Creek Drain and District as a County Drain. This is a series of drainage basins located within the subdivision.

An Attorney was hired to review the historical documents for this drain to make sure it was created with all the proper notices and orders. The result is that this is a legally established drain and drainage district.

Ives Drain - City of Big Rapids and Big Rapids Charter Township

The City of Big Rapids approached our office regarding the potential to create a new county drain crossing under lves Street and out-letting into the Muskegon River.

A study of the affected area by an Engineer was asked for and paid for by the City of Big Rapids under the authority of our office. The study determined the watershed (drainage district boundary), documented severe bank erosion, documented exposed utilities, and defined the drain to be an open channel approximately .65 miles long east of lves Avenue.

On April 15, 2019, the Drain Commissioner accepted an Order Laying Out and Designating the Drainage District via a petition of property owners in the drainage district. This action created the Ives Drain Drainage District.

On August 1, 2019, the Drain Commissioner received a petition to locate, establish and construct the lves Drain. This resulted in the need for a Board of Determination made up of 3 members to vote on the establishment of the drain. On October 16, 2019, a Board of Determination took place. The Board members voted unanimously to establish the lves Drain.

The Ives Drain is a .65-mile-long open channel watercourse east of Ferris State University discharging into the Muskegon River. The Ives Drain Drainage District consists of 448 acres located in Section 22 of Big Rapids Township, T.15N.-R.10W.; Sections 14-15 and 22-23 of the City of Big Rapids, T.15N.-R.10W. in Mecosta County, Michigan.

The following steps remain for this drain:

- Complete final design
- Easement acquisition
- Incorporate landowner comments
- Coordinate with utilities
- Bid letting
- Day of Review of Apportionments
- Award of project to contractor
- Begin Construction

<u> Jenkins Drain – Hinton Township</u>

Jenkins Drain was established in 1919 and is in Hinton Township in Sections 24, 25, 26, 27, and 34. The Jenkins Drain is approximately 5.15 miles in length, a tiled and open ditch drain.

In 2021 maintenance was done to dip out channel and remove debris from channel.

Northgate Drain - Big Rapids Charter and Green Charter Township

Northgate Drain was established in 1990, located in Section 3 of Big Rapids Charter Township and Sections 33 and 34 of Green Charter Township, the length of the drain is 2.28 miles, including both open ditch and underground tile.

Pursuant to Section 197 of Act No. 40, P.A. 1956, as amended (The Drain Code) we were able to hire an engineer to review the district boundaries and apportionments and hold a Day of Review of District Boundaries and a Day of Review of Apportionments. The field review of this drain was done in 2020. This review of the district was completed in 2021.

An Attorney was hired to review the historical documents for this drain to make sure it was created with all the proper notices and orders. The result is that this is a legally established drain and drainage district.

Parks Drain - Sheridan & Wheatland Townships

Parks Drain was established in 1906. Located in Sections 27, 28, 29, 32,33 and 34 of Sheridan Township and Section 3 of Wheatland Township, it is an open ditch system approximately 2.18 miles in length.

We continue to have beaver problems on this drainage system. Several beavers and their dams have been removed.

<u>Snow Drain – Hinton Township</u>

Snow Drain was established in January of 1907 and is in Hinton Township, Sections 24, 29, 30, & 32. This is a tiled and open ditch drain approximately 2.24 miles in length.

An Attorney was hired to review the historical documents for this drain to make sure it was created with all the proper notices and orders. The result is that this is a legally established drain and drainage district.

Additionally, historical easements for this document were filed with the County Register of Deeds.

Stevens Drain - Hinton Township

Stevens Drain was established in 1924, Sections 14, 23 and 26 of Hinton Township. The length of the drain is approximately 1.40 miles and is a tiled drain.

An Attorney was hired to review the historical documents for this drain to make sure it was created with all the proper notices and orders. The result is that this is a legally established drain and drainage district.

Tonkin Drain - Big Rapids Charter Township

Tonkin Drain was established in 1904 in Big Rapids Charter Township, Sections 26, 27 & 35. The drain length is 1.25 miles and is an open ditch.

We received a petition for maintenance on this drainage system on March 27, 2018. A Board of Determination was held on May 30, 2018, in which the project was found necessary. We continued to look at options to help this drainage system including but not limited to extending this historic county drain all the way to the Muskegon River and upstream, to better control the water that flows into and out of this historic drainage system.

The following steps remain for this drain:

- Complete final design
- Easement acquisition
- Incorporate landowner comments
- Coordinate with MDOT and utilities
- Bid letting
- Day of Review of Apportionments
- Award contract to selected bidder
- Begin Construction

Waldron Drain - Big Rapids Charter Township

Waldron Drain was established as a 433 Drain creating the drain and drainage district under the 433 Agreement. On October 11, 2004, the Drain Commissioner accepted the Hills of Mitchell Creek Drain and District as a County Drain. This is retention/detention pond system.

An Attorney was hired to review the historical documents for this drain to make sure it was created with all the proper notices and orders. The result is that this is a legally established drain and drainage district.

Willmer Drain - Grant and Green Charter Townships

The Willmer Drain was established in 1905. Located in Section 7 of Grant Township, this is an open ditch drain approximately 582 feet in length.

Maintenance was done to clear debris from the downstream bank of the drain on Indian Village Road.

2021 ESTABLISHED LAKE LEVEL PROJECTS

Mecosta County has seven lake level control structures (dams) with court ordered lake levels established. The Drain Commissioner is the delegated authority for the care and control of these structures. Below are the dams that had work done and/ or legal review on them during 2021.

Brady Lake Dam - Aetna Township

Brady Lake Dam is in Section 21 of Aetna Township. The Lake Level was established on September 30, 1982, at 938.50 feet above mean sea level.

Due to the existing steel weir dam rusting/eroding, it was suggested and determined that an earthen dam structure would be built as a replacement. The dam was replaced in 2021.

An Attorney was hired to review the historical documents for this dam to make sure it was created with all the proper notices and orders. The result is that this is a legally established lake level and special assessment district.

Chippewa Lake Dam – Chippewa Township

Chippewa Lake Dam is in Section 32 of Chippewa Township. The Lake Level was established on January 19, 1972, at 1065.2 feet above mean sea level.

Beavers and their dams were removed from the channel near the dam again in 2021.

Horsehead Lake Dam – Martiny Township

Horsehead Lake Dam is in Section 28 of Martiny Township. Horsehead Lake, Little John Brown and Big John Brown Lakes are connected and are controlled by the county dam. The Lake Level was established on February 02, 1972, at 1012.00 feet above mean sea level in the summer and 1011.26 feet above mean sea level in the winter.

The Road Commission widened 14 Mile Road and reduced the access to the dam from the road shoulder. A foot bridge was installed at the dam to allow easy access to the dam.

An Attorney was hired to review the historical documents for this dam to make sure it was created with all the proper notices and orders. The result is that this is a legally established lake level and special assessment district.

Pickerel (Burgess) Lake Dam – Colfax and Grant Townships

Pickerel (Burgess) Lake Dam is in Sections 4 and 5 of Colfax Township and in Sections 32 and 33 of Grant Township . The lake level was established June 24, 1971, with the Summer Level set at 950 feet above Mean Sea Level and the Winter Level set at 949 feet above Mean Sea Level.

An Attorney was hired to review the historical documents for this dam to make sure it was created with all the proper notices and orders. The result is that this is a legally established lake level and special assessment district.

The Mecosta County Road Commission removed downed trees from the downstream side of the dam along 18 Mile Road.

Pretty Lake Dam – Martiny Township

Pretty Lake Dam is in Sections 11 & 14 of Martiny Township. A lake level of 1003.0 feet (USGA DATUM) was set by the Circuit Court on March 14, 1990.

An Attorney was hired to review the historical documents for this dam to make sure it was created with all the proper notices and orders. The result is that this is a legally established lake level and special assessment district.

2021 LAKE LEVEL CONTROL STRUCTURE INSPECTIONS

Three Lake Level Control Structures needed their State Mandated Triennial Inspections in 2021:

- Blue Lake Dam Morton Township
- Chippewa Lake Dam Chippewa Township
- Horsehead Lake Dam Martiny Township

2021 LAKE IMPROVEMENT BOARDS

Natural Resources and Environmental Protection Act (Excerpt) Inland Lake Improvement Act Part 309 of Act 451, P.A. of 1994, as Amended

Part 309 of Act 451, P.A. of 1994, as amended, is known as the "Inland Lake Improvement Act". This Act provides for the improvement of certain inland lakes. These improvements might include, weed control, dredging, removal of undesirable materials from lakes and authorizes the raising of money by taxation and special assessments.

The act provides for the establishment of a "Lake Board" that is charged with the responsibility of carrying out desired improvements.

On public inland lakes, lake boards may be established by the governing body of a local unit (City, Village, Township or County) upon its own motion or by petition of 2/3 of the freeholders owning lands abutting the lake. Such action can be taken by the governing body of any local unit in which all or any part of the lake is located.

On private inland lakes, a lake board can be established by petition only.

Each year we report on the activity of each of the Lake Boards on which the Drain Commissioner serves as a Board Member. These are as follows:

BRADY LAKE IMPROVEMENT BOARD

With a maximum depth of 19 feet, Brady Lake covers 58 acres in Aetna Township. A Lake Level Control Structure was established on the west side of the lake in 1982. A Lake Improvement Board was established in the spring of 1988 to treat the weeds in Brady Lake.

This Lake Improvement Board meets once a year when property owners hold their annual meeting.

Officers consist of: Gary Dubridge (President, Property Owner), Beverly McLaughlin (Secretary and Treasurer, Aetna Township Clerk), Jim Welmerink (Property Owner), Tom O'Neil (County Commissioner), and Karla Miller, (Drain Commissioner).

The annual meeting was held on May 1, 2021. Karla Miller gave an update on the Brady Lake Dam replacement project. Beverly McLaughlin prepared a Treasurer's report. Gary Dubridge discussed the overall condition of the lake.

JEHNSEN LAKE IMPROVEMENT BOARD

With a maximum depth of 18 feet, Jehnsen Lake covers 270 acres in Martiny Township and is located north of Horsehead Lake. The Lake has approximately 3 square miles of drainage. A private dam was constructed several years ago at the outlet where Jehnsen Lake flows into Horsehead Lake.

In September of 2007, Martiny Township Board established the Jehnsen Lake Improvement Board, after receiving petitions signed by 74% of the freeholders owning lands abutting Jehnsen Lake.

The Board Members for Jehnsen Lake Improvements are Rodger Sinen (President, Property Owner), Julie McDonald (Property Owner), Barb Hampel (Martiny Township Supervisor), Jerrilynn Strong (County Commissioner), Karla Miller (Secretary and Treasurer, Drain Commissioner).

The annual meeting was held on June 14, 2021. Karla Miller presented the financial report and presented bills to be paid. Rick Buteyn, Progressive AE Field Scientist, discussed the overall condition of the lake and the results of the weed control activity. Emma Costantino, Outreach Coordinator, North Country Cooperative Invasive Species Management Area, provided an overview of the services the group provides and made available printed materials to the Board.

TRI-LAKES LAKE IMPROVEMENT BOARD

The Tri-Lakes consist of Round Lake, Blue Lake and Lake Mecosta, totaling 700 acres of spring fed water. The Tri-Lakes Lake Improvement Board was established in 1989, this Board was formed for the protection of public health, safety and welfare, the conservation of natural resources and the preservation of property values on the lakes.

The board members are Mark Wrona (President, Property Owner), Sandy Brogan (Treasurer, Property Owner), Dave Lewis (Property Owner), Linda Howard (County Commissioner) and Karla Miller (Secretary, Drain Commissioner),

The Lake Improvement Board met on September 13, 2021. Sandy Brogan presented the Treasurer's report and presented invoices. Tony Groves from Progressive AE discussed the overall condition of the lake. Dave Lewis discussed the assessments for Gypsy Moth control will be placed on the winter tax roll.

SOIL EROSION & SEDIMENTATION CONTROL (SESC) REPORT

As of March 16, 2001, the Drain Commissioner's Office became the County Enforcing Agency (CEA) for Mecosta County Soil Erosion and Sedimentation Control. The Drain Commissioner and Deputy Drain Commissioner are certified by the Michigan Department of Environment, Great Lakes, and Energy (EGLE) to issue permits and perform inspections.

A review of the Mecosta County Drain Commission's SESC CEA program was conducted by the Department of Environment, Great Lakes and Energy (EGLE). Staff of the Water Resources Division (WRD), Grand Rapids District Office (GRDO) began the review on October 1, 2021. The review was conducted pursuant to Section 9105 of Part 91, SESC (Part 91), of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (NREPA). The review included an evaluation of SESC applications, plans, permits, ordinance, training, inspections, compliance and enforcement efforts and site conditions. The WRD completed its review on October 29, 2021. The Mecosta County Drain Commission's SESC CEA program meets the minimum requirements under Part 91 and is granted "approved" status.

FINANCIAL SECTION: EXPLANATION OF FUNDS

Under PA 40 of 1956 (Michigan Drain Code – As Amended), the Mecosta County Drain Commissioner is the administrator of any County Drain Funds, or any other special funds created for and used by this office and has the sole authority for their use.

The following is a brief explanation of the Drain Funds and any other special fund used by the Drain Commissioner. If you have any questions regarding any of these, please feel free to contact the Drain Commissioner's Office.

FUND #801: COUNTY DRAIN FUND ACCOUNTS

Each Drain and Lake Level, under the authority of the Drain Commissioner, has a specific name and number (i.e., Barryton Drain – Fund #801.01). Records must be maintained showing all activity in each of these accounts. The 801 account funds can only be used for the drain they are assigned. For example, funds in the Barryton Drain – Fund #801.01 cannot be used to pay for repair, maintenance work, etc. done on the Blanchard Joint Drain – Fund #801.02. This is because each drain has a specified district, which can be assessed for the work that has been done. If a drain or lake level needs repair, the payment for said work is taken from their specific fund. If there are not enough funds in their account, the necessary funds are borrowed from the Revolving Drain Fund until an assessment for that district can be done. The Drain Commissioner has up to 2 years to assess a district for maintenance and repairs.

FUND #802: REVOLVING DRAIN FUND

The Mecosta County Board of Commissioners established the Revolving Drain Fund with the starting amount of \$17,440.00. In 2015, the Mecosta County Board of Commissioners increased the available funds by \$30,000.00. In 2021, the Mecosta County Board of Commissioners increased the available funds by \$50,000.The total principal available is now \$97,440.00. This money is used for Drain or Lake Level projects when there is not enough funding in their Drainage District account. This fund is then reimbursed from the Drainage District when collection of their Special Assessment is completed. In 2000, we started receiving interest (LAMP Interest) on the Revolving Drain Fund. For more information on the amount of interest received, see the Revolving Drain Fund Report.

SPECIAL FUNDS

FUND #506: PLAT REVIEW FEES

This fund was created by Resolution on September 16, 1999, allowing the Drain Commissioner the funds necessary to review Subdivision Plats, Site Condominiums and Mobile Home Parks. Fees collected for reviewing these plats will go into this fund to be used for consulting and engineering expenses when necessary.

FUND #101-477: SOIL EROSION & SEDIMENTATION CONTROL FEES

In March of 2001, the Drain Commissioner's Office acquired the Soil Erosion Department for Mecosta County. For more information on fees collected, see the report for Soil Erosion Permits.
