Mecosta County Board of Commissioners,

As you may, or may not, be aware there is some legislation trying to pass the Senate to require County Treasurers to provide electronic records of data that is not maintained by the Treasurer's office and to charge a minimal/no fee for tracking it down. HB 4730 – the "Zillow Legislation." If this Bill passes, Zillow would acquire the information, then sell our records for a profit. This would put our property at risk of fraud or even theft. HB 4730 would unreasonably burden taxpayers with the costs of providing data to private corporations. Even out-of-state corporations such as Zillow.

The Michigan Association of County Treasurers (MACT) is actively opposing HB 4730 - the "Zillow Legislation."

Attached are copies of some recent resolutions passed by other Counties that we can use to make our own resolution to record our opposition of this Bill. This Bill is currently opposed by MACT, MARD, and MAC.

Please consider creating a resolution to oppose this Bill in our County.

OPPOSITION TO HOUSE BILLS 4729, 4730, 4731, and 4732

- WHEREAS, House Bill 4730 would require county treasurers to provide electronic records containing any data maintained within the treasurer's office, and
- WHEREAS House Bill 4730 would burden county treasurers to provide "qualified data files" containing only one (1) piece of data out of 16 possible data items, and
- WHEREAS, House Bill 4730 limits how much treasurers can charge for parcel records and would burden taxpayers with the cost of data collection provided to out-of-state, and other corporate entities, and
- WHEREAS, the Michigan Association of County Treasurers, Michigan Association of Counties, Michigan Association of County Clerks, and Michigan Association of Register of Deeds oppose House Bill 4730

THEREFORE, BE IT RESOLVED:

That the Mecosta County Commission calls upon the Michigan Senate to oppose efforts to adopt legislation under the current language as passed by the Michigan House of Representatives on April 27, 2022.

BE IT FURTHER RESOLVED:

That the Mecosta County Board of Commissioners stand in solidarity with the Mecosta County Treasurer and Mecosta County Register of Deeds to oppose HB 4729, HB 4730, HB 4731, and HB 4732 and stand up to corporations that data' mine records for profit while placing the burden on Mecosta County taxpayers;

IRS increases mileage rate for remainder of 2022

IR-2022-124, June 9, 2022

WASHINGTON — The Internal Revenue Service today announced an increase in the optional standard mileage rate for the final 6 months of 2022. Taxpayers may use the optional standard mileage rates to calculate the deductible costs of operating an automobile for business and certain other purposes.

For the final 6 months of 2022, the standard mileage rate for business travel will be 62.5 cents per mile, up 4 cents from the rate effective at the start of the year. The new rate for deductible medical or moving expenses (available for active-duty members of the military) will be 22 cents for the remainder of 2022, up 4 cents from the rate effective at the start of 2022. These new rates become effective July 1, 2022. The IRS provided legal guidance on the new rates in Announcement 2022-13 PDF, issued today.

In recognition of recent gasoline price increases, the IRS made this special adjustment for the final months of 2022. The IRS normally updates the mileage rates once a year in the fall for the next calendar year. For travel from Jan. 1 through June 30, 2022, taxpayers should use the rates set forth in Notice 2022-03 [PDF].

"The IRS is adjusting the standard mileage rates to better reflect the recent increase in fuel prices," said IRS Commissioner Chuck Rettig. "We are aware a number of unusual factors have come into play involving fuel costs, and we are taking this special step to help taxpayers, businesses and others who use this rate."

While fuel costs are a significant factor in the mileage figure, other items enter into the calculation of mileage rates, such as depreciation and insurance and other fixed and variable costs.

The optional business standard mileage rate is used to compute the deductible costs of operating an automobile for business use in lieu of tracking actual costs. This rate is also used as a benchmark by the federal government and many businesses to reimburse their employees for mileage.

Taxpayers always have the option of calculating the actual costs of using their vehicle rather than using the standard mileage rates.

The 14 cents per mile rate for charitable organizations remains unchanged as it is set by statute.

Midyear increases in the optional mileage rates are rare, the last time the IRS made such an increase was in 2011.

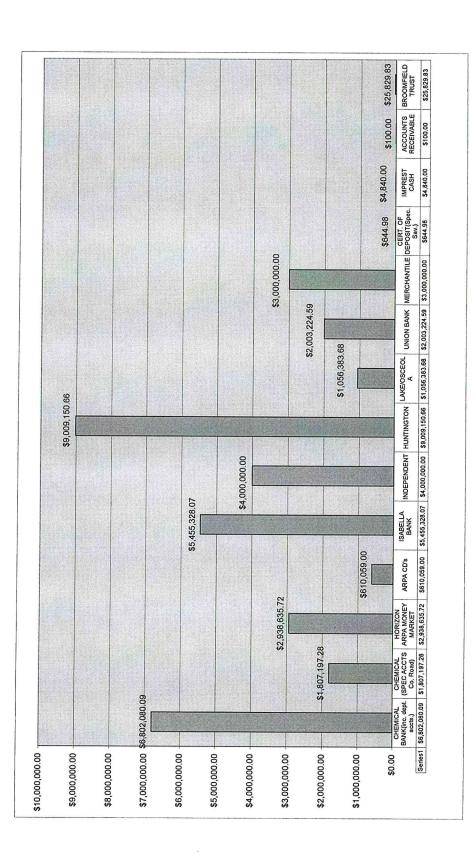

IMPORTANT CLIENT UPDATE

Michigan Supreme Court Order regarding Juneteenth Holiday

On June 1, 2022, the Michigan Supreme Court entered an Order adding Juneteenth to the official court holidays listed in the Chief Judge Rule 8.110 (the "Order"). The Court also ordered that as Juneteenth falls on June 19th every year, this holiday is to be treated like similar holidays that may fall on a weekend by making the Friday before or the Monday after the observed date. Juneteenth is observed in 2022 on Monday, June 20th.

Courts will be acting expeditiously to implement the new holiday by adjusting schedules, notifying litigants and other court users. In the event a Court already observes the holiday provided for in the new Order (including Juneteenth), the Court does not need to submit a Court Holiday Local Administrative Order ("LAO").¹ If not already observed, a LAO including Juneteenth is required to be submitted to the SCAO.

To ensure all employees who are members of a bargaining unit where the Court is the employer receive holiday pay for the observed Juneteenth, existing collective bargaining agreements should be amended to reflect this change (e.g., via Letters of Understanding/Agreement).² Implementation of the LAO is within the authority of the chief judge(s) and the local funding unit is not required to agree with or approve this change. MCR 8.110(D).

It is important to note that the Supreme Court's Order <u>only</u> applies to Courts and Court employees and <u>not</u> to the employees of the County (this includes the employees of the county-wide elected officials for which the County, through the Board of Commissioners, is a co-employer with the responsibility for determining the economic terms and conditions of employment which includes the number of paid holidays). Counties have options:

- 1. To remain open even though the Courts are closed;
- Offer to unions Juneteenth for 2022 (June 20th) as a paid holiday on a onetime, non-precedent setting basis;
- 3. Offer to unions to substitute Juneteenth for a different holiday on a one-time or permanent basis; or

¹ Courts are mandated to issue LAOs to establish court policies for regulating certain court functions and procedures; however, before its effective date, such LAOs must be sent to the State Court Administrative Office ("SCAO").

² Any Letter of Understanding entered into should contemplate whether Juneteenth should remain in effect for the remaining duration of each Collective Bargaining Agreement, reserving for the parties the right to bargain only when the next successor agreement is opened.

4. Offer to unions to add Juneteenth as an additional holiday without restriction.

For bargaining-unit employees, the designation of holidays and pay status is a term and condition of employment subject to a legal duty to bargain with unions. As a result, other than option "1" above, the remaining options would need to be implemented for bargaining unit employees by means of a mutually agreed upon amendment to existing collective bargaining agreements to reflect the change (e.g., via Letters of Understanding/Agreement).

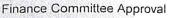

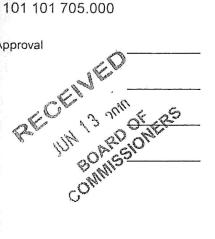

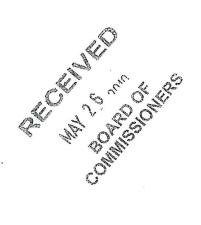
