Chair William Routley called the afternoon session of the Mecosta County Board of Commissioners to order at 3:00 P.M. with access to the public via Zoom. All those present stood and recited the Pledge of Allegiance to the United States Flag.

## **REVIEW & APPROVAL OF AGENDA – ADDITIONS:**

R. Steinke moved to approve the Agenda with an addition to New Business - 6.4 Private Security for Court Wing. J. Strong seconded; motion carried.

## **APPROVAL OF MINUTES:**

L. Howard moved to approve the October 26, 2022 Committee of the Whole Minutes and November 3, 2022 Board Minutes as presented. M. Bradstrom seconded; motion carried.

# SIGNING OF UNION CONTRACTS:

Tim Lewis, TPOAM Union Representative, thanked the Board for negotiating good contracts. Union Contracts that have been ratified were signed by all present.

## 5.1 NON-UNION PROPOSAL FOR 2023

# MECOSTA COUNTY RESOLUTION #2022-16

# 2023 BUDGET ADOPTION

- WHEREAS, the Uniform Budgeting and Accounting Act, Public Act 621 of 1978, requires that each unit of local government adopt a balanced budget for the General Fund and all subsidiary funds, and
- WHEREAS, the Chief Administrative Officer, through the Budget Committee did transmit a recommended set of balanced budgets to the Mecosta County Board of Commissioners according to the appropriate time schedule along with a suggested general appropriations act to implement those budgets, and
- WHEREAS, the Mecosta County Board of Commissioners has accepted and adopted those budgets during their regular meeting held on December 1, 2022, now
- **THEREFORE BE IT RESOLVED,** that the 2023 Mecosta County General Fund Budget and all subsidiary budgets as set forth as attachments to this Resolution are hereby adopted on a Departmental Fund Balance basis, subject to all Mecosta County policies regarding the expenditure of funds and other conditions as set forth in this Resolution.
- **BE IT FURTHER RESOLVED,** that all Elected Officials and Appointed Department Heads are responsible for their budget centers on a "Line-Item" basis.
- **BE IT FURTHER RESOLVED,** that the Finance Committee will work with all Elected Officials and Appointed Department Heads during the 2023 Fiscal Year to prevent expenditures in excess of the adopted budget which will require supplemental appropriations to offset said expenditures.
- **BE IT FURTHER RESOLVED,** that the Finance Committee of the Board of Commissioners shall review and approve all Budget alterations, intra-budget line item adjustments, the transfer of funds between Budget Centers, and other subsidiary funds prior to the completion of the transaction, with the exception of transfers authorized by the Controller/Administrator pursuant to Mecosta County Resolution 2004-14.
- **BE IT FURTHER RESOLVED,** that the Finance Committee of the Board of Commissioners shall review and approve all Capital Item Expenditures prior to the placement of an order for same.
- **BE IT FURTHER RESOLVED,** that the Finance Committee of the Board of Commissioners shall assure that funds are made available for future expenditures which

result from current operation, such as, but not limited to, Retirement Benefits and Workers' Compensation.

- **BE IT FURTHER RESOLVED,** that each Budget Center shall be responsible for the operations within all subsidiary funds and will inform the Board of Commissioners of all amendments as required by the Uniform Budgeting and Accounting Act.
- **BE IT FURTHER RESOLVED,** that it is understood by all parties involved in this process that revenues and expenditures may vary from those which are currently contemplated and may be changed from time to time as necessary by the Board of Commissioners during the 2023 Fiscal Year.
