6.1 COUNTY BUILDING THREAT POLICY

Budget Amendment Request 101 215 Clerk – Finance Officer

R. Steinke moved to approve the budget amendment request for County Clerk 101 215, increasing the budget by \$10,770 from Unreserved Contingency and moving money within the budget to cover previously approved wage increases. R. Vetter seconded; roll call vote: 7 yeas, 0 nays; motion carried.

Budget Amendment Request SR 234 Housing - Finance Officer

R. Steinke moved to approve the budget amendment request for SR 234 Housing Rehab, increasing expenditures by \$86,746 and moving money within line items to balance the budget. The \$86,746 is a refund to the State of program income that was more than the amount allowed for retention in the program; the money will come from Fund Balance. W. Routley seconded; roll call vote: 7 yeas, 0 nays; motion carried.
