PROPOSAL

Proposal 20-1

A proposed constitutional amendment to allow money from oil and gas mining on state-owned lands to continue to be collected in state funds for land protection and creation and maintenance of parks, nature areas, and public recreation facilities; and to describe how money in those state funds can be spent.

This proposed constitutional amendment would:

- Allow the State Parks Endowment Fund to continue receiving money from sales of oil and gas from state-owned lands to improve, maintain and purchase land for State parks, and for Fund administration, until its balance reaches \$800,000,000.
- Require subsequent oil and gas revenue from state-owned lands to go into the Natural Resources Trust Fund.
- Require at least 20% of Endowment Fund annual spending go toward State park improvement.
- Require at least 25% of Trust Fund annual spending go toward parks and public recreation areas and at least 25% toward land conservation.

Should this proposal be adopted?

Proposal 20-2

A proposed constitutional amendment to require a search warrant in order to access a person's electronic data or electronic communications.

This proposed constitutional amendment would:

- Prohibit unreasonable searches or seizures of a person's electronic data and electronic communications.
- Require a search warrant to access a person's electronic data or electronic communications, under the same conditions currently required for the government to obtain a search warrant to search a person's house or seize a person's things.

Should this proposal be adopted?

FORK TOWNSHIP PROPOSAL

RESCUE TRUCK CAPITAL IMPROVEMENTS PROPOSAL

Shall Fork Township impose an increase of up to .5 mill (\$0.50 per \$1,000 of taxable value) in the tax limitation imposed under Article IX, Sec 6 of the Michigan Constitution and levy it for three (3) years, 2020 through 2022 inclusive, for the purpose of providing funds for Rescue Capital Improvements-Rescue Vehicle, which .5-mill increase will raise an estimated \$23,500 in the first year the millage is levied?

MORTON TOWNSHIP PROPOSAL

MORTON TOWNSHIP YOUTH AND FAMILY CENTER PROPOSAL

Shall the total limitation on the amount of taxes which may be assessed against all taxable property in Morton Township, County of Mecosta, be increased by .25 mill (\$0.25 per \$1,000 of taxable value) and levied by Morton Township for a period of five years as a new additional millage to provide funds for the operation of Youth and Family Center that provides educational, social and recreation services to Morton Township's families. If approved, this millage would raise an estimated \$73,455.28 each year, for a period of five years, beginning in 2021 and ending in 2025.

Shall the tax rate limitation for Wheatland Township be increased, and a tax levied on all taxable property, in the amount of eight-tenths (0.8) mill (\$0.80 per \$1,000 of taxable value) for the years 2021-2024, inclusive?

This proposed millage would renew a previously authorized millage for Township Public Library purposes, in the amount of .8 mill. The purpose of this levy is to provide funds for operational expenses to allow the Library to continue to offer its present services. It is estimated that a levy of .8 mill could provide revenue of approximately \$35,965 in the first calendar year.

II. WHEATLAND TOWNSHIP PUBLIC LIBRARY RENEWAL OF PREVIOUSLY AUTHORIZED MILLAGE

Shall the tax rate limitation for Wheatland Township be increased, and a tax levied on all taxable property, in the amount of four-tenths (0.4) mill (\$0.40 per \$1,000 of taxable value) for the years 2021-2024, inclusive?

This proposed millage would renew a previously authorized millage for Township Public Library purposes, in the amount of .4 mill. The purpose of this levy is to provide funds for operational expenses to allow the Library to continue to offer its present services. It is estimated that a levy of .4 mill could provide revenue of approximately \$17,983 in the first calendar year.

Shall the incorporated Village of Barryton be vacated?

BARRYTON PUBLIC LIBRARY PROPOSAL

BARRYTON PUBLIC LIBRARY MILLAGE RENEWAL PROPOSAL

Shall the previously authorized millage of the Barryton Public Library District be renewed at a rate of 0.9920 of one mill for a period of 4 years (\$0.9920 per \$1,000 of taxable value for years 2021 through 2024 inclusive) for all district library operations and purposes authorized by law? If levied at its maximum this millage is estimated to provide revenues of \$110,000 in its first year. A home valued at \$75,000 (\$37,500 taxable value) would pay \$37.20 per year.
