MIDDLETOWN TOWN COUNCIL MEETING MINUTES
JUNE 9, 2015

The Middletown Town Council met for its regularly scheduled meeting on June 9, 2015 in the Public Meeting Room at 653 Locust Street, Middletown, Indiana at 7:00 P.M. The meeting was opened by Town Council President Betty Riley leading those present in the pledge to the flag. Clerk-Treasurer Drew Cooper noted that Council Members Betty Riley, Dave Wagner, Gary Kendall, and Norm Purdue were present. Shelly Kimmerling was absent. Town Attorney Joel Harvey was present.

1. Dave Wagner moved to hire Ryan Reed as a part-time dispatcher. Betty Riley seconded. The motion passed unanimously.
2. Betty Riley moved to update the employee policy manual to include an education requirement for dispatchers of a high school diploma or GED. Gary Kendall seconded. The motion passed unanimously.
3. Betty Riley moved to suspend the rules and do the second reading of ORDINANCE 2015-3 AN ORDINANCE AMENDING FINES FOR VIOLATIONS OF CERTAIN PROVISIONS OF TOWN CODE by name and number only. Dave Wagner seconded. The motion passed unanimously. Betty Riley moved to approve ORDINANCE 2015-3 on its second reading. Norm Purdue seconded. The motion passed unanimously. Dave Wagner moved to suspend the rules and do the third reading of ORDINANCE 2015-3 AN ORDINANCE AMENDING FINES FOR VIOLATIONS OF CERTAIN PROVISIONS OF TOWN CODE by name and number only. Norm Purdue moved to approve payment from the Local Road & Street Fund for extra paving on the 5th Street Storm Sewer Project on High Street east of 5th, Columbia Street on both sides of 5th, Central Street west of 5th, Maple Street west of 5th, and Locust Street from Dietrich Park to 2nd Street, for a cost of \$18,022.63. Dave Wagner seconded. The motion passed unanimously.
6. Norm Purdue moved to postpone the June 16 public meeting to June 23. Gary Kendall seconded. The motion passed unanimously.
7. There being nothing further to come before council, the meeting was adjourned.
