MIDDLETOWN TOWN COUNCIL MEETING MINUTES
NOVEMBER 1, 2016

The Middletown Town Council met on November 1, 2016 in the Public Meeting Room at 653 Locust Street, Middletown, Indiana at 7:00 P.M. The meeting was opened by Town Council President Jake Smith leading those present in the pledge to the flag. Clerk-Treasurer Drew Cooper noted that Council Members Jake Smith, Donita Chambless, Gary Kendall, and Betty Riley were present. Dave Wagner was absent. Town Attorney Joel Harvey was present.

1. Donita Chambless moved to promote Dispatcher Bryan Reed from Grade 2 to Grade 3, effective with the next payroll. Gary Kendall seconded. The motion passed unanimously.
2. Donita Chambless moved to increase the Dispatch Supervisor pay to \$15 per hour, effective with the next payroll. Gary Kendall seconded. The motion passed unanimously.
3. Matt Spidel, of Butler-Fairman-Seufert, announced that the new Water Treatment Plant is up and running. Donita Chambless moved to authorize payment #8 to Graves Plumbing for \$74,934.84. Gary Kendall seconded. The motion passed unanimously.
4. Betty Riley moved to approve ORDINANCE NO. 2016-3 AN ORDINANCE PROHIBITING PARKING IN CERTAIN AREAS IN THE TOWN OF MIDDLETOWN, INDIANA DURING SEVERE WINTER STORM EVENTS on its third reading. Donita Chambless seconded. The motion passed unanimously. The ordinance was adopted.

5. The Clerk-Treasurer read RESOLUTION 2016-11-01-01 A RESOLUTION APPROVING ADDITIONAL APPROPRIATIONS TO CERTAIN FUNDS:

GENERAL FUND	\$ 33,000
CUMULATIVE CAPITAL IMPROVEMENT FUND	\$ 4,500

Donita Chambless moved to approve the resolution. Betty Riley seconded. The motion passed unanimously.

6. The Clerk-Treasurer read ORDINANCE NO. 2016-05 AN ORDINANCE OF THE TOWN OF MIDDLETOWN, INDIANA, ADOPTING UNIFORM INTERNAL CONTROL STANDARDS FOR INDIANA POLITICAL SUBDIVISIONS. Donita Chambless moved to adopt the ordinance. Jake Smith seconded. The motion passed unanimously.
