**LEGAL NOTICE  
SEALED BIDS FOR THE LEASE OF MORROW COUNTY FARM**

Pursuant to Resolution adopted by the Morrow County Board of Commissioners on the 23<sup>rd</sup> day of January, 2023, it was determined that the land hereinafter described is no longer needed for the County’s purpose, and that said land shall be leased for agricultural purposes to the highest and best bidder. The Morrow County Board of Commissioners shall have the right to reject or accept any or all bids.

The County Commissioners will rent the County Home Land at the County Home Farm for one (1) year, with the option to renew at end of lease if the Commissioners do not go out to bid. The real estate to be leased shall include the tillable acres with the following exceptions:

All of the buildings, and the approximately seventeen (17) acres where they are located.

Lessee shall not be allowed to sublease the premises without the permission of the County Commissioners.

No hunting shall be allowed on the leases premises.

Lessee shall assume the risk and obligation of obtaining water for use at the leases premises, if desired.

BIDS: Sealed proposals will be received at the Office of the Morrow County Board of Commissioners, 80 North Walnut Street, Mt. Gilead, Ohio 43338, until 9:30 a.m. on February 15, 2023, at which time sealed bids will be opened and read aloud. The Morrow County Board of Commissioners shall have the right to reject or accept any or all bids. Prospective Bidders may review the proposed lease agreement by contacting the Clerk of the Morrow County Board of Commissioners.

Complete bid packet and forms are available in the office of the Morrow County Commissioners, Bids must be submitted on the forms supplied by the Morrow County Commissioners in a sealed envelope.
