IN THE MATTER OF

AUTHORIZING A COOPERATIVE AGREEMENT WITH THE MORROW COUNTY DEVELOPMENT AUTHORITY AND THE MORROW COUNTY ENGINEER; APPROVING THE ISSUANCE OF DEVELOPMENT AUTHORITY REVENUE BONDS; AND

AUTHORIZING THE APPROPRIATION OF FUNDS FOR DEBT SERVICE ON SUCH BONDS AND APPROVAL FOR CHAIRMAN TO SIGN: 23-R-888

WHEREAS, this Board of Commissioners (the "Board") determines it is in the best interest of Morrow County, Ohio (the "County") and its residents to construct, equip, and operate new facilities for the Morrow County Engineer in the County (the "Project"); and

WHEREAS, this Board determines that the Project will benefit the County and its residents by enhancing government operations, promoting transportation, and stimulating collateral development in the County; and

WHEREAS, it is in the best interest of the County to request the assistance of the Morrow County Development Authority (the "Development Authority") for constructing and financing the Project; and

WHEREAS, the Development Authority will issue revenue bonds (the "Bonds"), the proceeds of which Bonds will be made available for the Project, as further described in the Cooperative Agreement to be entered into by and among the Development Authority, the County, and the Morrow County Engineer (the "Cooperative Agreement"); and

WHEREAS, this Board has determined to authorize the payment of the principal of, premium, if any and interest on the Bonds ("Debt Service Charges") and Administrative Expenses (defined below) with the County's motor fuel excise tax funds, subject to annual appropriation, in accordance with the terms of the Cooperative Agreement and as provided in this Resolution, and to authorize the signing of the Cooperative Agreement.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Morrow County, Ohio that:

Section 1. Definitions. In addition to the words and terms defined in the Cooperative Agreement, the following words and terms shall have the following meanings unless the context or use clearly indicates another or different meaning or intent:

"Administrative Expenses" includes the fee of the Development Authority as issuer of the Bonds, amounts required to enforce any provisions of the Cooperative Agreement, and any amounts other than Debt Service Charges required to be paid under the Cooperative Agreement in connection with the Bonds.

"Appropriation Payments" means the payment related to the Bonds to be made by the County pursuant to, and in accordance with the schedule attached as an exhibit to, the Cooperative Agreement, which payments are subject to annual appropriation by this Board and shall be paid from motor fuel excise tax or any available resources of the County to the extent lawfully available to make Appropriation Payments.

"Original Purchaser" means, with respect to the Bonds, the Office of the Treasurer of Morrow County, Ohio.

"Purchase Price" means, with respect to the Bonds, seven million two hundred and fifty thousand dollars (\$7,250,000), plus any accrued interest on the Bonds from their date to the date of their delivery to the Original Purchaser.

Section 2. Determinations by the Board. This Board finds and determines as follows:

- (a) <u>Public Purpose</u>. The financing of the Project serves a proper public purpose by enhancing government operations, promoting transportation, and stimulating collateral development in the County.
- (b) <u>Cooperation with Development Authority</u>. It is necessary, proper and in the best interest of the County to request the Development Authority to issue the Bonds and for the Development Authority to use the proceeds from the issuance of the Bonds pursuant to the Cooperative Agreement.
- (c) <u>Cooperative Agreement</u>. It is necessary, proper and in the best interest of the County to authorize the Cooperative Agreement to provide for, among other things, (i) the issuance of the Bonds by the Development Authority, (ii) the provision of Appropriation Payments to pay Debt Service Charges on the Bonds and Administrative Expenses, and (iii) disbursement of the proceeds of the Bonds.

This Board finds and determines that the issuance of the Bonds and the signing and delivery of the Cooperative Agreement in connection with such issuance for the purpose provided in this Resolution serves a proper, public purpose.

Section 3. Bond Terms; Application of Proceeds.

(a) The Board approves the issuance by the Development Authority of the Bonds, in accordance with the Cooperative Agreement.

- (b) Appropriation Payments. The Appropriation Payments to be payable under and in accordance with the Cooperative Agreement during any fiscal year shall be an amount sufficient to cover the Debt Service Charges on the Bonds that are due and payable during that fiscal year and the Administrative Expenses that are due and payable during that fiscal year, and such Appropriation Payments shall be specified in an exhibit to the Cooperative Agreement; provided, however, that the County's payment of Appropriation Payments is subject to appropriation as provided in the Cooperative Agreement and nothing in the Cooperative Agreement or the Bonds shall constitute a pledge by the County, or an obligation of the County, of any taxes or other moneys to the payments due thereunder other than the application of the motor fuel excise tax as provided in the Cooperative Agreement.
- (c) <u>Application of Proceeds</u>. The proceeds from the sale of the Bonds shall be deposited and applied as provided in the Cooperative Agreement and for the purposes stated in this Resolution.

It is determined that the terms of the Bonds and the corresponding terms of Appropriation Payments as so determined within the limitations set forth in this Resolution and as so specified and set forth in the Cooperative Agreement will be in the best interest of the County and consistent with all legal requirements.

Section 4. Authorization of Cooperative Agreement; Additional Documents. In connection with the issuance of the Bonds, the Chair of the Board is authorized, in the name and on behalf of the County, to sign and deliver the Cooperative Agreement, substantially in the form on file with this Board, together with such changes that are not adverse to the County.

The Chair of the Board is authorized to sign and deliver and accept delivery of such instruments, certificates and documents as are necessary or appropriate to consummate the transactions authorized by this Resolution and the Cooperative Agreement.

The Chair of the Board is authorized to make the necessary arrangements on behalf of the County and cooperate with the Development Authority to establish the date, location, procedure and conditions for the delivery of the Bonds to the Original Purchaser and to take all actions necessary to effect due signing, authentication and delivery of the Bonds under the terms of this Resolution and the Cooperative Agreement. The Clerk of the Board or other appropriate official of the County shall furnish the Original Purchaser a true transcript of proceedings certified by the Clerk or other official, of all proceedings had with reference to the authorization of the Cooperative Agreement and the payment of Debt Service Charges on the Bonds and the Administrative Expenses.

- **Section 5. Interpretation.** Nothing in this Resolution is intended to, and no provision hereof shall be applied in any manner as would, impair the obligation of contract of the County with respect to any outstanding bonds, certificates of indebtedness, other obligations, indentures, or other agreements or contracts made or entered into by the County.
- **Section 6. Severability**. Each section of this Resolution and each subdivision or paragraph of any section is hereby declared to be independent, and the finding or holding of any section or any subdivision or paragraph of any section to be invalid or void shall not be deemed or held to affect the validity of any other section, subdivision or paragraph of this Resolution.
- **Section 7.** Compliance with Open Meeting Law. This Board finds and determines that all formal actions of this Board were taken in an open meeting of this Board, and that all deliberations of this Board were in meetings open to the public, all in compliance with the law, including Ohio Revised Code Section 121.22.

Mr. Mason introduced the resolution and moved its passage. Mr. Siegfried seconded the motion and, after discussion, a roll call vote was taken.
