Terms of Rental:

Upon submitting this form, the renter agrees to complete the event offering recycling within the borders of Morrow County, Ohio. The renter agrees to care for the equipment in a careful and prudent manner. Equipment shall be returned in the same condition as it was received. If, upon its return, the equipment is not in such condition, the renter will be liable for the cost of repairs, or renter may repair the equipment upon approval. The renter agrees to take recyclable items collected to one of the public recycling locations provided throughout Morrow County OR include collected recyclables with an approved curbside recycling collection program OR to a responsible recycling facility. Renter must also return completed "material collection form" when returning rented bins/lids and any unused recycling bags.

Hold Harmless Clause:

"To the fullest extent permitted by law, the renter agrees to defend, pay in behalf of, and hold harmless Morrow County Recycling & Litter Prevention Department/Keep Morrow County Beautiful against any and all claims, demands, suits, losses, including all costs connected therewith, for any damage which may be asserted, claimed or recovered against or from use of the above stated equipment or event, its elected and appointed officials, employees, volunteers or all others working in behalf of the Morrow County Recycling and Litter Prevention/Keep Morrow County Beautiful Department, by reason of personal injury, including bodily injury and death; and/or property damage, including loss of use thereof, which arises out of the alleged negligence of use of the equipment and/or any way connected or associated with this agreement". If the equipment is vandalized while in the process of the renter, the Renter will be held responsible for such repairs.

The Morrow County Recycling and Litter Prevention Department/Keep Morrow County Beautiful, its supervisors and employees shall not be held liable for any incidental or unforeseen damages which may result from rental, use, transportation, or failure of the equipment.
