The following Special Provision supplement the "Standard Specifications for Road and Bridge Construction", adopted January 1, 2022, the latest edition of the "Manual on Uniform Traffic Control Devices for Streets and Highways", and the "Manual of Test Procedures of Materials" in effect on the date of invitation of bids, and the Supplemental Specification and Recurring Special Provisions indicated on the Check Sheet included here in which apply to and govern the construction of the above named section, and in case of conflict with any parts, or parts of said Specifications, the said Special Provisions shall take precedence and shall govern.

CONTRACT BOND REQUIREMENTS

Any "furnish and apply" group bid, in excess of \$50,000, will require the successful bidder to provide a contract bond for the full amount of the award. When a contract bond is not required, the proposal guaranty check will be held in lieu thereof.

BITUMINOUS MATERIALS

All work shall be done in accordance with Section 403 of the Standard Specifications, except that payment for bituminous materials shall be at the contract unit price per gallon. The specific gravity at 60°F of bituminous material in the tank truck and the number of gallons at 60°F shall be shown on the weight ticket.

ROTO-TILLING ROADWAY

The existing surface shall be tilled to the width and depth as specified by the appropriate Township Highway Commissioner. The reshaping and compaction of the highway shall be performed by the Contractor. Compaction, reshaping and finishing shall be performed in accordance with Article 352.11 of the Standard Specifications except density will be to the satisfaction of the appropriate Township Highway Commissioner.

The surface shall be tilled by means of a self-propelled rotary tiller so that the tilled material shall have no particles larger than 1 1/2 inches.

The contractor will contact JULIE prior to the start of work in locating existing utilities and culverts. The contractor will be held responsible for protecting all previously located utilities and in the event he damages any of them, they shall be replaced by the contractor at his own expense.

SPECIAL PROVISIONS

Materials shall be delivered in total or partial shipment as ordered by the Township at any time during a period of one year from January 1, 2022.

NOTICE TO BIDDERS

The regulations of the Department of Transportation, Division of Highways, of the State of Illinois, require that all materials entering into the

be inspected and tested by the Bureau of Materials of said Department and a satisfactory report be in the hands of the governmental officials before said materials are incorporated in the work. Bidders are hereby notified that they must comply with this regulation at all times.

All bidders must take into consideration in bidding that there may be delays in having materials tested or delays due to lack of cooperation when awards are made to several low bidders. In order to minimize the delays, the successful bidders must cooperate at all times during the progress of the work.

Bidders are further notified that the awarding authority will not be responsible for or pay any demurrage charges or in any way reimburse any party furnishing materials, equipment, or labor for this work, due to delays in testing materials, or lack of cooperation between the various parties furnishing such equipment, materials, or labor.

Where materials are not tested by the Bureau of Materials of the Division of Highways of the State of Illinois at the point of origin before shipment is made, bidders will be held responsible for notifying said Bureau of Materials when shipment arrives at destination so that proper tests may be made.

Bidders on materials f.o.b. trucks or railroad will be required to allow the awarding authority the customary free period for unloading the material, the free period to commence after the satisfactory reports are received by the governmental officials. All demurrage charges incurred up to and through the free period as outlined above shall be borne by such bidder and if paid by the awarding authority, will be deducted from the invoice for this material.
