

## PROPOSITION TO ISSUE \$30,600,000 SCHOOL **BUILDING BONDS**

Shall the Board of Education of Arthur Community Unit

School District Number 305, Douglas, Moultrie, Coles, Piatt and Champaign Counties, Illinois, alter, repair and equip the Arthur, Lovington and Atwood-Hammond Grade School Buildings, including constructing secured entryways, build and equip an addition to and alter, repair and equip the Arthur-Lovington-Atwood-Hammond High School Building, including replacing heating, ventilation and air conditioning systems, and issue bonds of said School District to the amount of \$30,600,000 for the purpose of paying the costs thereof?
