ROAD AND BRIDGE COMMITTEE MEETING MINUTES

The meeting was brought to order at 9:00 a.m. by Mr. Bill Voyles. A motion was made by Mrs. Arlene Aschermann and seconded by Mrs. Elizabeth Houser to approve all claims as presented. Yea: 3 Nay: 0. Motion carried.

Business discussed:

1. Motion was made by Mr. Bill Voyles, seconded by Mrs. Arlene Aschermann to approve the Ordinance establishing a reduced speed limit through Kirksville to 40 mph. Yea 3 Nay 0 Motion Carried.
2. Motion was made by Mr. Bill Voyles, seconded by Mrs. Arlene Aschermann to approve the 2022 Bridge Petition List. Yea 3 Nay 0 Motion Carried
3. All documents acquiring ROW for Section #94-08111-00-BR have been recorded. Proceeding with IDOT approvals. Letting is tentatively scheduled for April 2022.
4. Environmental Site Report (ESR) needed to proceed with CH8 Stabilization for Section 19-00077-00-PV. IDOT has indicated the ESR process has become lengthy due to the availability of increased funding statewide, and ultimately an increase in the number of statewide projects. The ESR approval process will now take up to a year. CH8 has already been delayed one year...waiting another year is not an option. The phasing of the project will be revised to allow part of the project to proceed this year. Coordination with IDOT is underway.
5. Proceeding with plans to replace bridge structure on 1400N, Section 04-03128-00-BR. Anticipate a local letting for this project in July/August 2022.
6. Discussed funding to replace a culvert with a new single span bridge on 750E, Section 19-07136-00-BR. Sullivan Road Commissioner, Rich Rutledge, has requested assistance to use County Bridge or County Matching funds.
