Actual Results	<p>Murray County appointed the Murray SWCD as the local unit of government to administer the Wetland Conservation Act. The SWCD Technician administers all of the administrative and technical aspects of the grant including site visits, TEP meetings, sending out decisions, etc.</p> <p>As of December 31, 2019, the Murray SWCD had been contacted by 132 landowners that had questions related to wetlands or the Wetland Conservation Act. The majority of the workload was spent on ag related drainage projects on cropland and the remainder of the workload was spent on public drainage ditches, and zoning CPU's. Two hundred and five tiling requests and 3 ditch cleanouts requests were reviewed for WCA compliance. The 2019 Wetland Conservation Act Annual Report was completed and submitted to the MN Board of Water and Soil Resources.</p> <p>Water Planner – 56 hrs. at \$37.80 = \$2,116.80            SWCD Tech.- Aaron – 377.5 hrs. at \$35.81 = \$13,518.28            SWCD Tech.- Travis – 37.5 hrs. at \$38.96 = \$1,461.00            SWCD Manager – 98.5 hrs. at \$56.11 = \$5,526.84</p>
