- Family VEBA/HSA Plan \$5,200.00 deductible, 80/20 plan, with a monthly premium of \$1,905.00;
- Family VEBA/HSA Plan \$5,200.00 deductible with a monthly premium of \$2,048.00;
- Family VEBA/HSA Plan \$10,000.00 deductible with a monthly premium of \$1,682.00; and

WHEREAS, Murray County's health insurance premiums through PreferredOne will be the same in 2022 as in 2021;

NOW THEREFORE BE IT RESOLVED, that Murray County will offer the same health insurance options in 2022 as in 2021.
