Commissioner Jens introduced the following findings of fact and order and moved its adoption:

BEFORE THE MURRAY COUNTY BOARD OF COMMISSIONERS, ACTING AS DRAINAGE AUTHORITY FOR MURRAY COUNTY DITCH #30

Findings of Fact and Order for Partial Abandonment of Murray County Ditch #30, Pursuant to Minnesota Statutes 103E.806

WHEREAS, a Petition was received from John Stenke, Don Paplow, Jackie's Farms, and Mark Lorang, as owners of benefited property, for the abandonment of the upper part of the Main Tile and all of Lateral No. 1 of Murray County Ditch #30 on Petitioners' properties in Sections 34 and 35 of Belfast Township, Murray County.

WHEREAS, a public hearing was held on Tuesday, October 18, 2016, at 9:15 a.m. in the Commissioners Room of the Murray County Courthouse; and

WHEREAS, public notice was given pursuant to Minn. Stat. § 103E.806, subd. 3; and

WHEREAS, the hearing was open to public comment and there were questions raised by the Township and others attending the meeting.

NOW, THEREFORE, based on the testimony and written documentation, the Murray County Board of Commissioners, acting as Drainage Authority for Murray County Ditch #30, makes the following Findings of Fact and Order:

FINDINGS OF FACT

- 1. That Petitioners are the owners of property situated in the East ½ of Section 34 and in Section 35 of Belfast Township, Murray County, Minnesota, that is benefited by Murray County Ditch #30.
- 2. That the State of Minnesota is in the process of securing as many as six perpetual conservation easements on portions of Petitioners' properties in Sections 34 and 35 of Belfast Township. The purpose of said easements is to restore drained and altered wetlands and associated upland habitat.
- 3. That the portions petitioned to be abandoned on Murray County Ditch #30, do not serve a substantial useful purpose to any property remaining in the system and are not of substantial public benefit and utility, subject to the following conditions:
 - a. That all remaining conservation easements, as outlined in the Engineer's Report dated October 10, 2016, and attached as **Exhibit A**, be obtained.
 - b. That acceptance from the Township of the final construction plans be obtained.
 - c. That the structure and the 100 foot reach of non-perforated conduit from Stations 25+40 to 26+40 will become part of the Murray County Ditch #30 system. That it is contemplated that if some time in the future repairs are necessary, that there will be cooperation between the landowners, the State of Minnesota, and the drainage system.
 - d. That the partial abandonment, under Minnesota Statutes 103E.806, does not in any way change the benefits for Petitioners' properties.
 - e. That all costs of the implementation of the RIM Wetland Restoration, as outlined in the Engineer's Report dated October 10, 2016, and attached as **Exhibit A**, shall be

- borne by Petitioners and no cost shall be incurred by other landowners within the Murray County Ditch #30 system.
- f. That final construction plans and as-builts shall be submitted to the Murray County Auditor and included in the Murray County Ditch #30 file.

ORDER

NOW, THEREFORE, it is hereby ordered that the upper 2,640 feet of the Main Tile, from Station 0+00 to Station 26+40, and the entire 4,200 feet of Lateral No. 1, from Station 0+00 to Station 42+00, of Murray County Ditch #30 and located on Petitioners' properties shall be abandoned subject to the completion of the above conditions. This order does not release Petitioners' properties from any benefits under the current Benefits and Damages Viewers' Report. It is further ordered that those portions of Murray County Ditch #30 that are not abandoned, including the water control structure and the 100 feet of non-perforated conduit shall be determined to be part of the Murray County Ditch #30 system.
