## **Treasurers Report:**

- ➤ Motion (3/09/15g) Moved by Donna Kor, seconded by Darwin Patzlaff to pay the invoice of \$148.50. to Slayton Plumbing & Heating for parts. Motion carried unanimously.

➤ Motion (3/09/15h) Moved by Donna Kor, seconded by Darwin Patzlaff to pay the invoices of \$5581.00 and \$898.00 To the League of MN cities for 2015 additional blanket coverage and insurance. Motion carried unanimously.

Will also need a culvert on the driveway to the ponds, has been washing out the past few years.
