

NOTICE OF PRESIDENTIAL NOMINATION PRIMARY ELECTION

In the County of Murray, State of Minnesota.

Notice is Hereby Given, That a Presidential Nomination Primary Election will be held in the following Election Precincts until 8:00 p.m. on Tuesday, March 5, 2024 for the purpose of voting for a presidential candidate to be placed on the 2024 General Election Ballot..


Nomination primary voters must request the ballot of the major political party for the candidate for which they wish to vote. This is indicated on the polling place roster and then recorded as part of their voting history. The major political party ballot selected by the voter is private data (M.S. 207A.12(b)), except that it will be shared with the Minnesota chair of major political party they have chosen.
