**Meeting of the North Adams City Council  
Tuesday, February 08, 2022  
7:30 PM**

**MINUTES**

A meeting of the North Adams City Council was held at 7:30 p.m. in Council chambers.

**COUNCILORS PRESENT:** Councilors Barbeau, Blackmer, Bona, Harpin, Obasohan, Oleskiewicz, Sapienza, Shade, and Wilkinson; a quorum was present.

A moment of silence was observed for Diane O'Brien, a 32-year aide in the public school system, and Michelle Kirby, who served for several years as president of the PTG groups at Johnson and Conte Schools. Following the Pledge of Allegiance, the President called for approval of the minutes for the January 25, 2021 meeting. On the motion of Councilor Oleskiewicz, seconded by Councilor Sapienza, the minutes were approved.

The President called for the hearing of visitors.

Robert Smith, 163 North Street, spoke regarding paper #12,053. He noted that driving in the area of Hodges Cross Road has included high rates of speed and poor driving practices. He encouraged the Council to seek ways to reduce the speed, and then, hopefully, the number of accidents.

11,790-3      An ordinance to amend Chapter 2, Section 2-27 of the Revised Ordinances of the City of North Adams, Schedule A; Chapter 2, Section 2-28, Schedule B of the DPW and DPW Supervisor; and Part V, Schedule B of the Police Scale.

On the motion of Councilor Sapienza, seconded by Councilor Oleskiewicz, it was VOTED to adopt the amendment by unanimous yeas.

11,826      An ordinance amending the Revised Ordinances of the City of North Adams regarding the various fees established in the City Code.

On the motion of Councilor Bona, seconded by Councilor Harpin, it was unanimously VOTED to postpone to the meeting of April 26, 2022. Discussion ensued; Public Safety and Public Services are still reviewing. It will then go to the Finance Committee.

12,053            Communication submitted by Councilor Oleskiewicz requesting a review of the traffic issues in the area of the intersection of Hodges Crossroad.

The President filed the communication without objection. After discussion by Councilor Oleskiewicz, on the motion of Councilor Harpin, seconded by Councilor Shade, it was unanimously VOTED to send the paper to the Traffic Commission with a return to Council at the meeting of April 12, 2022.

The President filed the communication without objection. She explained the timeline of the hiring process for both the Clerk and Assistant Clerk positions. Marcus Lyon will be put forth for approval as Clerk at a special meeting on February 16, 2022. Interviews for the Assistant position will be held on February 9, 2022, with a candidate to be brought to Council on February 22, 2022.

Kate Barbeau, 1360 Church Street, noted that a snow day occurred on the cut off date for the acceptance of resumes for a posted City position. She asked if consideration might be given in the future to extending cut off dates. The President acknowledged her request, and noted that the Screening Committee checked for resumes over the following days, but as they were due through an online process, the snow day did not impact accepted responses.

The President called for Mayor's Concerns.

The Mayor thanked all the members of the disbanded IDEA Working Group (in response to the formation of the Council IDEA Committee via Ordinance) for their time and efforts in establishing an important resource.

The Mayor congratulated Jessica Lincourt on her appointment to the position of Assessor, having worked as the Assistant Assessor since 2019. She also welcomed new Code Enforcement Officer Marc Bryant, and noted that the City is still seeking to fill the assistant IT position.

The Mayor stated that the fire department will be doing ice rescue training at Windsor Lake. She stated that in separate news, the City has received \$190K in grant monies from the Department of Energy that will be parsed out in several areas.

The Mayor stated that Winterfest will be held Saturday, February 19, 2022.

The President called for Committee Reports and Minutes.

Councilor Wilkinson reported that the General Government Committee needs one more meeting to finish discussing the Council Rules.

Councilor Shade stated that she will be reaching out to the newly appointed members of the IDEA Committee to schedule the first meeting.

The President called for Liaison Updates and Councilor Concerns.

Councilor Shade stated that Berkshire Live Out Loud will be held at Berkshire Community College on April 2, 2022, intended to educate residents around issues of the LGBTQ community.

Councilor Sapienza stated that several walks have not been maintained, and are snow and ice covered, causing issues for pedestrians around the City. He urged residents to clear walks to the best that they are able.

President Blackmer stated that the United Way would be holding is chicken dinner on March 7, 2022, and that it is take-out only in light of the pandemic.

Seeing no correspondence, on the motion of Councilor Wilkinson, seconded by Councilor Shade, it was VOTED to adjourn at 8:20 pm.
