The Clerk called upon Pastor David Anderson from the First Baptist Church to invoke the Inaugural Invocation.

Pursuant to the City Election on November 5, 2013 the following were elected as

City Councilors for the City of North Adams for a term of two years. Please stand as your name is called and remain standing to take the oath of Office. **Lisa M. Blackmer, Keith J. Bona, Jennifer M. Breen, Eric R. Buddington, Nancy Bullett, Benjamin J. Lamb, Kate H. Merrigan, Joshua J. Moran, and Wayne Wilkinson.**

City Clerk Marilyn Gomeau administered the oath of office to the City Council.

The Clerk called the meeting to order.

On roll call the following responded; Councilor Blackmer, Bona, Breen, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson.

The Clerk called for nomination for President for the year 2014.

Councilor Bullet nominated Councilor Blackmer, seconded by Councilor Bona.

With no further nominations, Councilor Breen motioned to cease nominations, seconded by Councilor Bona.

The Clerk declares Councilor Blackmer as Council President for the year 2014.

The City Clerk administered the oath of office to Councilor Blackmer.

President Blackmer takes the chair.

Councilor Blackmer gave her address to the City Council.

Thank you fellow Councilors. I am truly honored by your support. Thank you to friends, family, colleagues, and all those who are gathered here to witness the 2014 organization of city government for our city, the City of North Adams.

As we embark on 2014, we say goodbye to seasoned veterans and welcome fresh faces and ideas. I look forward to working with the Mayor, Councilors and staff to serve the needs of the residents who elected us. I expect we will be thoughtful and respectful in our deliberations. We will not agree on everything, but we must work and compromise toward the best solutions.

While we continue to face the same challenges: shrinking state and federal funding chasing increased needs, aging infrastructure and stagnant tax-base, we have much to look forward to. The President announces Council is now ready to receive Mayor-elect Richard J. Alcombright and appoints Councilor Bullett and Councilor Moran to escort Mayor-elect to the Council Chambers.

The President called upon the City Clerk to administer the oath of office to Mayor-elect Richard J. Alcombright.

His Honor, the Mayor delivers his inaugural address.

Madam Clerk, Madam President, Madam Vice President, Councilors, School Committee members, Representative Cariddi, City Solicitor DeRosa, Pastor Dave, Father Matt, City and School Administration and Staff, Families, Friends, AND OF COURSE...MOM...WELCOME....

As I begin...I want to extend a very heartfelt "thank you" to the voters in the City of North Adams for returning me to office for two more years.

I also want to thank ALL City and School Staff for their hard work, commitment and dedication to the residents and student of this City.

Despite this VERY cold January day....the sun is shining and the birds are chirping in the City of North Adams as we begin a new year...a new year filled with hope and promise. Hope for better days....and promise of a brighter future.

Some have expressed concern that the number of new Councilors might be problematic. I fail to see the problems but very specifically focus on the many opportunities.

What this Council lacks in municipal experience is made up for in professional experience(s) in so many sectors....education, retail, health care, engineering, management, law, real estate, human services, art, technology....all of these sectors so aptly bundled into what you all bring to this new Council.

This community is very fortunate to have all of you in office....collectively you are a very strong body and I am CERTAIN that we will achieve many wonderful things over the next two years.

And while some of you will have much to learn....I am fully prepared as is my staff to be accessible with respect to any issue that might come before you.

I will work with Council President Blackmer to schedule workshops for the budget, capital needs, setting of the tax rate, VISION 2030 Master Plan and other specific areas of concern to the Council.

You have my assurance that I will continue to come to each and every Council meeting well prepared and that you will get documentation to support your work....so that when you act, when you vote, you will do so in an informed manner.

This new year brings with it some difficult challenges but also some very positive initiatives.

- I am concerned for our hospital and therefore our community. While the hospital continues its fight to provide services and remain fiscally solvent, hard decisions have to be made regarding the reduction of services offered.
- As these discussions continue and decisions are made, I only ask that this community stand by North Adams Regional Hospital knowing that what they are experiencing is real and that while VERY difficult, a decision to reduce services for some.....may be the decision that preserves services for most.
- There are many things that come at me day-to-day....the most frustrating thing for me is the City budget and my quest to close the gaps, balance the budget and begin building reserves.
- We cannot continue chasing our tails, spending so much time and effort managing the books that we lose focus on the ONLY thing that will fix this problem and that is GROWTH.
- I continue with my pledge of strong fiscal integrity.
- Pertaining to growth, I will continue to do everything I can....working with anyone I can to promote growth through private sector capital investment. We have done a pretty good job but I have to do better....
- I am going to do whatever I can to preserve our business base and to help it grow. That could mean more aggressive public sector incentives tied to private sector investment. Things like “Special Tax Agreements” and the “sale of public buildings” with the reward being the creation of jobs and the strengthening of our tax base.
- We have identified many capital projects that we will be facing over the next 20 years, projects that are beginning to reach numbers as high as \$36 million dollars. This number does not include a public safety building, a solution to our transfer station issues, a new DPW facility, ADA improvements or further commitments to our airport.

My administration with this Council will be making very difficult decisions over the next several cycles as we prioritize projects and determine the best way to fund them.

The reality is that much of what we need to do...needs to be done sooner than later. And while we have the capacity to take on more debt we simply do not have the cash flow to pay.

Together....we will figure these things out.

But....back to that shining sun and those chirping birds

- Thanks to many of you here today....we will be building a new school with the ground breaking in the early spring and a completion date in the summer of 2015
- This quarter, the City will unveil its Comprehensive Master Plan....VISION 2030 – a plan that will be our roadmap for growth and sustainability. This plan will allow us too methodically and with purpose, work on everything from economic development to neighborhood revitalization to infrastructure to healthy living.
- Very soon, the Partnership for North Adams will unveil its exciting and visionary plan for growth in our corridor. This privately funded plan will allow us to consider major greening and infrastructure projects as well as ways to promote our City through branding and marketing....all working hand in hand with our VISION 2030 master plan
- Over the next six months, we will continue working with private investors and government partners to finalize the rebirth of Heritage State Park into the Greylock Marketplacea project that holds significant promise for the City. The revitalization and privatization of the park has been a priority of mine for two years.....and should be complete by summer of 2015
- With the Marketplace, we will see a new surge of visitors from Mt. Greylock, a new connectivity with MASS MoCA, a tourist rail experience and further design on the bike path coming this way from both Adams AND Williamstown
- I hope to have a GRAND Phase 2 announcement for the Marketplace in several months
- I have not lost sight of the Mohawk Theater and this project continues to be very complex and challenging. I have spoken recently with Senator Markey's office and I hope to begin conversations with other Federal and State leaders on how we can get a project funded and underway. Once again....I still believe the most sustainable model is a theater that fosters the arts through education while providing for significant community use and performances. MCLA remains our most viable partner in this project. I will re-engage in this project over the next few months.

- We have seen significant growth and new jobs in our Route 8 corridor with the investment of Crane Fine Stationary, Walmart, Ocean State Job Lots, Tractor Supply and we are anticipating further investment from Bond Auto and Cumberland Farms in the very near future.
- I continue to work with President Mary Grant and our friends at MCLA to find ways to further connect the campus to the community. Their presence in our downtown.....staff and student infusion in our City and schools.....and investment on and off campus continues to tell their story of commitment here in the City and well beyond.
- With significant policing, we have seen our crime numbers go down. We have had significant drug arrests and have arrested the major players responsible for the many break-ins in the City last year. These arrests in many cases have already led to convictions. While this success is great....we will keep up the pressure to assure that the city is as safe as possible.

So.....As I begin to work with many of you on our challenges and our dreams, I only ask that those sworn here today come to know and understand the issues and that my administration is at your disposal to provide you with any information you may need.

Please.....keep an open mind.....and let's not spin our wheels in politics but rather move steadily ahead through policy.

Each and every day, I come into City Hall and look at what I do in this way....I am the CEO of a \$36 million dollar business with just over 13,000 shareholders and while the day-to-day business of running the City can be complex.....

- policy takes precedence over politics
- sound business decisions override special interests

I trust that you will join me in these principles.

SO....Today....right now....as we move through this ceremony, we are beginning to plan for the days, weeks and months ahead.

Today....right now.....I marvel at all of you who have just been sworn.....and I acknowledge with great thanks, ALL who serve our City.

Today....right now....I feel a renewed sense of spirit....a renewed sense of pride....a renewed sense of commitment.....AND A RENEWED SENSE OF OWNERSHIP

Today....right now....I am confident that we are on the right path and that we have and will continue to see great things happen

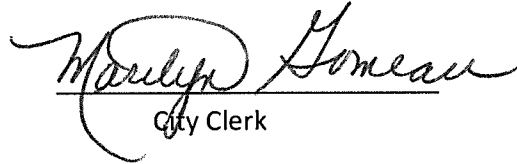

REGULAR MEETING OF THE CITY COUNCIL January 14, 2014

A meeting of the North Adams City Council was held at 7:30pm in City Council Chambers with the following present:

COUNCILORS PRESENT: Blackmer, Bona, Breen, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson.

A moment of silent prayer was observed remembering Louis Axt, Jr, former North Adams City Councilor, biology teacher at Drury High School and Assistant Superintendent of the North Adams Public Schools. Armand Perrault, former French language teacher at Drury High School. Joan Dumas, former employee of the North Adams School System and an election worker for the City.

The Pledge of Allegiance was recited.

The President called for anyone wishing to speak in Hearing of Visitors, hearing none the President called for the approval of the minutes of the December 23rd meeting.

On motion of Councilor Bona, duly seconded by Councilor Bullett it was VOTED: to approve the minutes as presented.

On motion of Councilor Bullett, duly seconded by Councilor Breen it was VOTED: to amend the minutes to read Councilor Bond as chairman of the Community Development Committee.

The President called for the approval of the minutes of the Organization of Government held on January 1st.

On motion of Councilor Merrigan, duly seconded by Councilor Wilkinson it was VOTED: to approve the minutes as presented.

Without objection the President moved the taxi application forward.

The President presented an application submitted by Heath Buffin, 65 River Street to drive taxi for Tunnel City Taxi.

On motion of Councilor Bullett, duly seconded by Councilor Bona it was VOTED: to grant the license.

11,345 The President presented Council Rules of Order for the year 2014, which were presented at the Organization of Government January 1st.

On motion of Councilor Breen, duly seconded by Councilor Bullett it was VOTED: to approve the Council Rules as presented.

11,346 The President presented Mayor's communication #1 regarding workshops for City Councilor's.

On motion of Councilor Breen, duly seconded by Councilor Bona it was VOTED: to file the communication.

The Mayor thought this is would be a good tool for all Councilor's especially the new Councilor's. The first workshop would be with department heads in January. The second one in February would be infrastructure. March would be the third on the budget process and in April the master plan.

Councilor's all had conflicting dates that would not work for them, Councilor Buddington suggested the Mayor put some dates out and a show of hands would indicate how many would be able to attend.

Councilor Bona wondered if new Councilor's would be able to tour some of the City's departments to see what the buildings and departments are dealing with.

The Mayor said his intent was to bring the department heads to the Councilor's.

Council President noted these workshops have to be posted in accordance with the Open Meeting Law, and there would be no discussion from the public. Councilor Merrigan urged residents interested in learning about City Government to attend even though there will be no public input.

The first workshop is scheduled for January 21st at 7:30pm.

11,347 The President presented Mayor's communication #2 regarding updates for ADA compliance.

The President asked for a motion to amend the paper number to read 11,276-2.

On motion of Councilor Breen, duly seconded by Councilor Lamb it was VOTED: to amend.

On motion of Councilors Breen, duly seconded by Councilor Wilkinson it was VOTEDL to file the communication.

The Mayor noted that although the new Councilor's were not familiar with ADA compliance it was what the City had to do to comply with the Department of Justice. Michael Canales, Administrative Officer presented Council with an update on what the City has done. Mr. Canales explained the Council had approved a borrowing order for \$250,000 so the work could be started on the green items. He noted the City is moving faster and at a lower cost than expected, allowing some of the yellow items which require more design and possible bidding may also be done. The red items, which includes the Public Safety building, prompted the complaint for the Department of Justice to do the audit.

Councilor Lamb asked what the time line for the Department of Justice was.

The Mayor explained the City has three years to comply, but the Department of Justice will work with municipalities showing progress, however the Mayor noted the Public Safety building needs to begin this year. Councilor Buddington said looking ahead would the public have input when the red items need to be addressed. Councilor Wilkinson asked if the estimated cost would be in the millions. Mr. Canales said it would be and the City needs to come up with a plan on how to fund it.

11,348 The President presented Mayor's communication #3 recommending the bonds for various departments for FY'14.

On motion of Councilor Breen, duly seconded by Councilor Lamb it was VOTED: to file the communication.

The Mayor explained this was state law and the amount of bonding was also determined by the state.

11,348 The President presented an Order establishing the bond for the City Treasurer/Tax Collector at \$250,000 for FY'14.

On motion of Councilor Lamb, duly seconded by Councilor Bullett it was VOTED: to adopt the Order.

The Order was adopted by yea and nay vote as follows; yea Councilor Blackmer, Bona, Breen, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson.

11,348-1 The President presented an Order establishing the bond for the Assistant City Treasurer at \$62,500 for FY'14.

On motion of Councilor Breen, duly seconded by Councilor Bona it was VOTED: to adopt the Order.

The Order was adopted by yea and nay vote as follows; yea Councilor Blackmer, Bona, Breen, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson.

11,348-2 The President presented an Order establishing the bond for the City Clerk at \$15,000 for FY'14.

On motion of Councilor Breen, duly seconded by Councilor Lamb it was VOTED: to adopt the Order.

The Order was adopted by yea and nay vote as follows; yea Councilor Blackmer, Bona, Breen, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson.

The President called for any Councilor Concerns, Councilor Bullett said the Friends of the Windsor Lake were holding their third annual snow shoeing on Sunday January 26th from 1:00pm to 4:00pm. Councilor Bullett also reminded residents to send in their annual census forms.

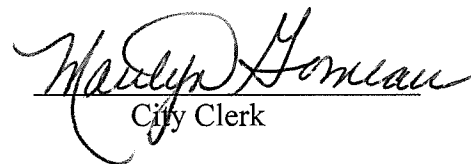

REGULAR MEETING OF THE CITY COUNCIL January 28, 2014

A meeting of the North Adams City Council was held at 7:30pm in City Council Chambers with the following present:

COUNCILORS PRESENT: Blackmer, Bona, Breen, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson.

A moment of silent prayer was observed.

The Pledge of Allegiance was recited.

The President called for the approval of the minutes of the January 14th meeting.

On motion of Councilor Merrigan, duly seconded by Councilor Lamb it was VOTED: to approve the minutes as presented.

11,349 Mayor's communication #4 recommending a transfer from Parking Meter Reserve Account to Capital Items.

Without objection the President placed the communication on file.

The Mayor noted he would like to amend the communication to read appropriation, not transfer.

On motion of Councilor Breen, duly seconded by Councilor Bullett it was VOTED: to amend the communication.

The Mayor explained this appropriation was the second payment of a three year lease on three Police cars and the Fire Chief vehicle. The interest rate is 6% and the lease can be bought out at any time, at the end of the lease the buyout is \$1.00 per vehicle.

11,349 The President presented an Order appropriating the sum of \$49,860.75 from Parking Meter Reserve Account to Unclassified, Capital Items; Police cars and Fire Chief Vehicle.

On motion of Councilor Breen, duly seconded by Councilor Lamb it was VOTED: to adopt the Order.

Councilor Lamb questioned after the three years, where does the parking meter money go to.

The Mayor said under ordinance the monies can be used for Public Safety.

Councilor Buddington questioned if this funding was solely from the Parking Meter Account.

Councilor Lamb asked if there was a projection of revenue from the parking meters.

The Mayor said the bulk of revenue comes from parking passes. The Mayor noted that this appropriation would leave about \$30,000 in the account. We are anticipating it will replenish itself to \$60,000 by fiscal year's end.

Mark Trottier, 131 Woodlawn Avenue asked if the 6% interest rate was on a short term loan, and was this loan done locally.

The Mayor noted it was done through the dealership.

The Order was adopted by yea and nay vote as follows; yea Councilor Blackmer, Bona, Breen, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson.

11,350 The President presented Mayor's communication #5 recommending the appointment of Jay Walsh to the Planning Board for a term to expire February 1, 2016.

On motion of Councilor Breen, duly seconded by Councilor Bona it was VOTED: to confirm the appointment.

Councilor Wilkinson noted it should be to fill the unexpired term. The Mayor said he was going to make that amendment, and thanked Councilor Wilkinson for 22 years of service. Councilor Wilkinson felt this was an excellent choice. Councilor Merrigan asked the Mayor if he would elaborate on Jay Walsh's qualification. The Mayor said Mr. Walsh has significant experience in agriculture, energy, sustainable community development and urban design. Councilor Moran and Councilor Buddington agreed Jay Walsh was an excellent choice.

11,345-1 The President presented a communication submitted by Council President regarding Council Rule #8.

On motion of Councilor Breen, duly seconded by Councilor Bona it was VOTED: to accept.

Several Councilor's pushed for the earlier deadline, allowing them more time to review their papers. Councilor Buddington said the extra time was important and extremely useful. Councilor Moran also expressed it was helpful to get the papers early, since he often leaves town on a Friday and does not return until Sunday night, which does not allow enough time to review the papers.

The Mayor said many times it is difficult for the administration to prepare the documents, noting a Monday holiday can complicate things.

Councilor Buddington noted the extra time was important and extremely useful; it does not leave much time to research because City Employees are not available on week-ends. Councilor Breen thought the delivery of packets by the police was not using the officers efficiently, she said that she was in favor of electronic delivery. Councilor Wilkinson speaking from experience, he prefers to pick his packet in the Clerk's office when they are ready. Councilor Bullett expressed that she does not like electronic delivery and she sees no problem with the way it is. Councilor Bona said he was okay with later, since if papers need more research it can always be referred to committee.

Council President reminded Councilor's it is your right and duty to do your own research.

Mark Trottier, 131 Woodlwan Ave said the agenda item had not been properly posted and questioned the Rules of Order, saying it was part of the City Charter. Council President responded saying the Rules of Order can be changed and accepted at the beginning of each term by the Council President.

On motion of Councilor Bona, duly seconded by Councilor Breen it was VOTED: to amend the rule.

The President called for a roll call vote on the amendment to Council Rule #8, yea Councilor Blackmer, Bona, Breen, Bullett, Lamb, Merrigan, Moran, Wilkinson, Nay Councilor Buddington.

The President reminded the Mayor to stick to the deadline.

The President presented an application submitted by Dominic Mondia, Jr., 157 East Quincy Street to drive taxi for Tunnel City Taxi.

On motion of Councilor Breen, duly seconded by Councilor Bullett it was VOTED: to grant the license.

The President presented an application submitted by Jonathan Miner, 335 State Street to drive taxi for Tunnel City Taxi.

On motion of Councilor Breen, duly seconded by Councilor Lamb it was VOTED: to grant the license.

The President called for anyone wishing to speak in Open Forum, Mark Trottier, 131 Woodlawn Avenue was in disagreement with several of the Council Rules.

The President called for any Councilor Concerns, Councilor Bona congratulated the Drury band for their recent performance. Councilor Bona supported the professional hockey league coming to North Adams. Councilor Bullett said there was going to be a second snowshoeing event on February 9th at Windsor Lake starting at 1:00pm. Councilor Breen also commented on the Black Bears coming to North Adams. Councilor Wilkinson noted that Council meetings could also be viewed on the NBCT web site.

Councilor Buddington noted that he would make sure information that residents were looking for would be on the web site. Councilor Lamb noted North Adams was one of the top places for vacation and MCLA was listed in the top 10 for Liberal Arts Colleges in Redbook, this is very positive for North Adams.

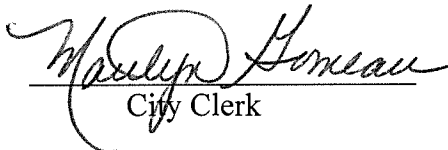
The Mayor also was in support of the Black Bear pro hockey team. The team is still in the talking stages for the use of the rink with the City and the State Department of Conservation and Recreation, which owns the facility. They require showers and locker rooms, among other things.

The Mayor warned Councilor's the City is in for a rough ride for this budget season. The Governor's budget calls for no increase in unrestricted local aid. Unless things change the City is going to be in a situation that none of us want to be in. The Mayor said "State Aid is the life blood for the City" and has been for years. With no further business to come before the Council a motion to adjourn was in order.

Connie Vecellio, former manager of the East School cafeteria and Food Service Program at McCann Technical High School. Samuel Fulginiti, father of Nancy Canales, Assistant City Clerk and grandfather of Administrative Officer Michael Canales. Kristine Fierro, sister of City Auditor David Fierro.

The Pledge of Allegiance was recited.

The President called for the approval of the minutes of the January 28th meeting.

On motion of Councilor Lamb, duly seconded by Councilor Wilkinson it was VOTED: to approve the minutes as presented.

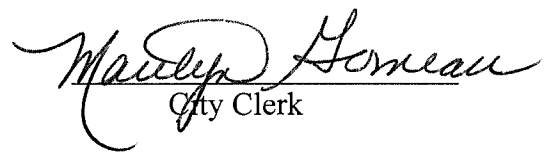
Councilor Bona would like to see this referred to the Public Safety Committee, there are also other licenses that come before Council for approval, and I would like to review them also.

STATE OF THE CITY ADDRESS

February 11, 2014

As I come into my fifth year in office, I am here tonight to give you my thoughts relative to our fine City for this year to come.

Over the past several cycles, we faced many fiscal challenges as we tried to strengthen our financial position. We have had modest success however our quest, working towards a truly balanced budget and strong reserves, continues to provide me and our finance TEAM considerable frustration.

My last four budgets have increased each year on average less than 1%. We have made cuts, consolidated departments, reduced staffing through attrition, cut health insurance costs through reform, and made significant and unfortunate cuts to our schools.

Reserves have been fully utilized to balance the budgets, taxes have been raised, water and sewer rates have increased, but not enough to offset reductions in unrestricted state and school aid coupled with increases in state assessments, utility costs, capital expenditures and rising salary and pension costs....just to name a few.

As we begin to build our FY2015 budget, I must be certain that this Council and residents understand that this will undoubtedly be the most difficult budget this City has seen in recent memory.

As you know, the Governor recently unveiled his FY2015 budget with no increase in the Unrestricted Local Aid. This is the lifeblood of municipalities.....especially those like us. Without yet getting into the numbers, that announcement will be the "inaction" that will immediately put our next budget significantly out of balance.

At the Mass Municipal conference a couple of weeks ago House Speaker DeLeo in his remarks to the membership recognized the Governors omission of increased funding, assuring us that the "Legislature would do better". But what is "better"? I guess only time will tell.

With State revenues pacing some 8% ahead of projections and state reserves now at some \$1.2 billion, it is very hard to understand why Unrestricted Local Aid was not increased.....substantially.

My past four years of tough fiscal policy....significant sacrifice by staff.....programmatic cuts and consolidations....while difficult proved to have kept this City's fiscal position in check.

Taking our deficit from \$2.6 million four years ago to some \$300K this cycle gave us a lot of satisfaction HOPING that we MIGHT have a balanced document this year. Couple all of this with our infrastructure woes and we have a lot of work to do....

I am hoping that the numbers will change as the Legislature and Senate with strong support from our Berkshire Delegation, will bring forward better revenue expectations. I will continue to keep this Council very well informed.

I am very happy to report:

- That the Hadley bridge will be completed by June 1st
- That the privatization of Heritage State Park continues to move ahead through discussion with the principals of the Greylock Marketplace.
- That our solar project on the site of the capped landfill and along the northerly edge of the Airport continues to move forward.
- That the Conte School renovation is out to bid and we hope to see construction begin within the next 60 days.
- That further development along the Rte. 8 corridor with Cumberland Farms and Bond Auto gives me hope for more commercial development in that area.

This year, we have applied for a grant to help craft a formal capital plan outlining the short, mid and long term needs of the City. This list will include everything from vehicles to building infrastructure to our water and sewer systems and will allow us to proactively plan projects and seek grants.

Public Safety will continue to be a priority as the City continues to deal with crime issues that are pervasive in more urban communities, not least of which are the crimes resulting from addiction. As a community, we need to embrace the reality that to simply lock up addicts is a very small part of the solution to a greater problem.

Opiate use that leads to heroin addiction is everywhere in our community, greater community, region, state and country. Anecdotally, I can say with great confidence that addiction and the underlying mental health issues that contribute to the addiction is one of the largest and fastest growing social issues in this country.

What are we doing about this in North Adams? First and foremost....more policing....more arrests....more convictions.

Last summer, we engaged with several local law enforcement agencies as well as the District Attorney to truly crack down on the drug activity in the City. This action brought about a significant number of arrests, confiscations and convictions. Both street and higher level dealers were arrested with several still awaiting trial. Significant amounts of heroin and marijuana was seized and to this day, these efforts are ongoing. Yet despite these efforts, the problem persists because addiction persists. It persists in our families and our neighborhoods and as I am responsible to this community for enforcement, I am also responsible for education.

Last year saw the creation of the Prescription Drug/Heroin Abuse Task Force, the Systems of Care Committee, and nb21.....all efforts that deal with prevention, education and eradication and the stigma surrounding mental health and addiction. I actively sit in on all three of these groups.

Through these efforts, conversations are FINALLY being had on traditionally hidden and sensitive subjects. Think about it....no one wakes up one day choosing a life of addiction....quite honestly I very strongly believe.....that addiction chooses them. Mental Health "illness" and the "disease" of addiction that are prevalent in every socio-economic class, age, race, and gender need to be seen and addressed as such, and as a community we need to discuss these issues and help create solutions.

I am very pleased to see our North Adams Chamber of Commerce getting off the ground in partnership with the Franklin County CDC and our Office of Tourism. This combined effort located on Main Street should be an invaluable resource to our every growing small business community.

I continue to work with our community partner MCLA, on a sustainable project that will breathe life into the Mohawk Theater. With continued engagement and commitment of state and federal governments for additional funding, I am very hopeful that we will be able to announce a solution. MCLA as a partner guarantees a project with long term sustainability providing daily use, revenue, management, programming and other attributes that will assure success.

We have significantly completed our Master Plan "Vision 2030". This process through the efforts and ideas of many is creating the roadmap that will allow the City to move forward. The plan addresses many issues concerning development, environment, neighborhoods, education, culture, recreation, healthy living and other topics vital to a healthy community. The final draft will be out for public comment very soon.

I am very excited to be a part of the Partnership for North Adams, a "think tank" of sorts that has been established to look at different sectors of our economy and develop ideas and solutions for growth and development. Many good things have and will continue to come from their efforts.

I am so encouraged by the numbers of young people who are getting involved in our community. From the new City Councilors, to board and commission members, to events volunteers, to those that serve various civic and community organizations, it is apparent that a new day is dawning in our City.

On the flip side, I have heard enough from those who want only pull down what is trying to be accomplished with a "woe is me" attitude. North Adams is a miniature version of our nation. The age of industrialism in America is over. Our traditional sources of authority are in decline. But America is the country of the future and we must be a City that looks to the future...

As a community, as a City, we should never forget our past and who we were....however we should not hold on to that past so tightly, that we diminish the hope of what we can become. Time after time, I run into people who say our community has changed.....and they say it at times with angst and resentment.

Living here all my life, I certainly do not disagree that our community has changed. What hasn't changed? Well the answer to that is simply this.....many of us have not changed....or simply do not want to.

The next several years will be critical and I want to send the message tonight in a very clear tone.....We need to collectively ask this question.....If there was no North Adams and we were to build one....what would it look like? What do we need? Well we have so many community assets to build on:

1. Our people
2. Our arts and cultural community
3. Our beautiful physical environment
4. A great hospital
5. An exceptional college
6. A world class museum
7. An airport
8. A growing business community
9. A good public school system
10. A Master Plan
11. The Partnership for North Adams

ALL ASSETS THAT ARE NECESSARY TO BUILD A COMMUNITY – and while we have them all....they are a bit disjointed yet....

How do we more effectively link them all to fully maximize their role and relevance in this “new” North Adams.

What we need to do is focus on our assets knowing that if they grow....our liabilities will shrink – We need to continue to capture the ideas and creativity of many and harness those thoughts and that energy in a productive way.

We have Amanda Chilson in our City who is leading the charge with her Mass in Motion program through the Community Coalition – this effort speaks volumes to the physical and emotional vibrancy in the City....will we all embrace her spirit?

We have Lois Daunis, Jess Dennis, Annie Rodgers and Carrie Crews in our City who are collectively representing three groups working very hard to educate our youth about the ills of substance abuse and beat down the stigma surrounding those in our community with mental health issues. Will we embrace their compassion?

We have Glenn Maloney and Spencer Moser in our City who fostered a partnership with MCLA and the City, twice a year mobilizing over 300 people for Community Days of Service. Will we embrace their hard work?

We have Mark Rondeau and his crew at the Friendship Center in our City providing food for those in need throughout North Adams and north Berkshire. Will we embrace their kindness?

We have a growing small business community who work each and every day to provide services, sell goods, create jobs and take risk....to serve us. Will we embrace their dreams?

We have Anne French in our school system who two weekends ago.....was given two days of notice.....and took her weekend to punch out a 20 page narrative and application for a \$200,000 grant from the Attorney General to bring a valid curriculum back into our schools that will deal specifically with substance abuse. Will we embrace her dedication?

We have a hospital staffed by our neighbors and friends that provide for the physical health of our community. As they try to keep us physically healthy, we know that the hospital is not fiscally healthy. Will we embrace our hospital and make it our first stop for medical care?

We have elected and appointed officials in this City who despite significant fiscal hardship and lack of resources, work each and every day to promote economic growth, healthy schools and community stability. Will this community embrace their combined efforts?

I am asking all here tonight....all those listening....all those who will read about this....all the residents of this City:

- To pick up the rope of hope and success with me and so many others.....and pull hard
- If you can't pull but like what we are trying to do then cheer us on....give us an “atta-boy”
- If you pull and you don't like where we are going....then quit pulling....for a while...BUT....pick up the rope again when it suits you
- If you have ideas for a new rope....let us know
- If you don't want anything to do with the rope....then please.....don't get in the way of those pulling....but continue to watch....because as we pull and pull and as things begin and continue to happen....you too may just want to begin to pull.

You know, if we wait for the government to do it....if we wait for others to do it....then it will never get done. The re-invention of this City is in our collective hands and on our collective backs....we will grow....or we will die....it truly IS that simple

This year, we will see:

1. The re-birth of our Heritage State Park into the Greylock Marketplace
2. A Scenic Rail experience
3. The Conte School Renovation
4. Continued investment by small business
5. Continued outreach to the private sector and our state and federal delegations for job development opportunities
6. Selective demolition of blight in targeted neighborhoods
7. A truly grand plan by a very dedicated local developer for the re-development of the Mohawk Building on Marshall Street
8. Re-engagement on the Mohawk Theater project
9. We hope....the opening of the Armory as a community center...and
10. Some greening projects

All things that will need many hands pulling on that rope.

I look forward to working with this council, the School Committee, our School Building Committee, and all of our boards and commissions. I very much appreciate the guidance of my neighboring town leaders and our local delegation. I truly value the wonderful employees of our City and school system, and I am very thankful for the patience and support of the people of this great city.

I will close with the same words as last year.....“The wheels of government grind slowly” and THAT THEY DO! But with continued support and patience, we will continue to grow and make “our” City, nestled here in the palm of God’s hand, a place of pride for all of us.

On motion of Councilor Breen, duly seconded by Councilor Wilkinson it was VOTED: to adopt the Order.

The Order was adopted by yea and nay vote as follows; yea Councilor Blackmer, Bona, Breen, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson. Nay none.

- 11,358** The President presented Mayor's communication #13 recommending the re-appointment of Alan Horbal to the Historical Commission for a term to expire January 2, 2017.

On motion of Councilor Wilkinson, duly seconded by Councilor Breen it was VOTED: to confirm the appointment.

- 11,359** The President presented Mayor's communication #14 recommending the re-appointment of Darrell English to the Historical Commission for a term to expire January 2, 2017.

On motion of Councilor Lamb, duly seconded by Councilor Breen it was VOTED: to confirm the appointment.

- 11,360** The President presented Mayor's communication #15 recommending the re-appointment of Paul W. Marino to the Historical Commission for a term to expire January 2, 2017.

On motion of Councilor Merrigan, duly seconded by Councilor Breen it was VOTED: to confirm the appointment.

- 11,361** The President presented Mayor's communication #16 requesting time to give an update on the City's fiscal future.

Without objection the President placed the communication on file.

The Mayor explained the City's fiscal woes should not be a surprise to anyone. It is not a secret; we have been talking about the fiscal crisis since December. There are no more rabbits to pull out of the hat. The city is looking to increase next year's budget \$720,000, with a gap of \$500,000 to close this year. The Mayor has

asked the Finance committee to hold three meetings to review how we are going to address the budget gap for this year and next. Several items need to be dealt with to close this year's budget; \$290,000 in overtime for Public Safety, \$150,000 over for Veterans Services, and \$30,000 to \$40,000 deficit in snow and ice account. The Mayor noted he has just completed very modest settlements with Police, Fire and DPW unions, which will come before Council once approved. The Mayor said using all of our reserves; the City should be able to close out the year. He noted the increase of \$720,000 for FY'15 will be very, very problematic with no reserves to depend on.

Councilor's Merrigan and Breen questions if other communities were facing the same problems. The Mayor said State aid is not keeping up, the City has fallen from 53% to about 45%. Local officials across the State, including myself have been lobbying the Legislature to increase local aid above the Governor's budget. Councilor Wilkinson questioned the Mayor if he was considering another prop 2 ½ override. The Mayor said it would not be out of the question.

11,362 The President presented a communication submitted by Councilor Wilkinson regarding the school lunch program in the North Adams School System.

On motion of Councilor Wilkinson, duly seconded by Councilor Buddington it was VOTED: to put the paper on the floor for discussion.

Councilor Wilkinson said he was very concerned about a new no credit policy in the North Adams School system. He feels that this new practice is discriminating. If a child's parent has not paid for their child's lunch then that child is being singled out and offered an "alternative lunch" instead of the hot lunch of the day, until the parents pay the balance of their bill. Councilor Wilkinson said the alternative lunch is two pieces of bread and a piece of meat, vegetable of the day, fruit and milk.

The Mayor noted that many children take the alternative lunch instead of the hot lunch.

Councilor Bona believes this is a School Committee issue, who is an elected board that has made a decision on how to handle unpaid balances. He does not feel this is something the Council should be dealing with.

Councilor Wilkinson disagreed with Councilor Bona saying when there is a problem in the City of North Adams there is no reason we can't ask questions.

Councilor Bona pointed out that his daughter takes two pieces of bread and meat for lunch every day and I believe it is called a "sandwich".

Councilors Breen, Merrigan, Buddington, and Lamb agreed with Councilor Bona that it is a School Committee issue, but they were glad Councilor Wilkinson brought this to Council's attention. This is a very complex issue and the School Committee and the Director of food service should be handling this in a way they find appropriate.

The Mayor noted as Chairman of the School Committee this issue has been discussed at length and it is not Council's role to override the decision of the School Committee.

Councilor Wilkinson felt that Councilors were missing the point; my point is children should not suffer because of neglect on the part of the parents.

Several Councilors were also concerned about the bullying that may occur because a child was singled out.

Councilor Bullett noted when her children were in school and she was unable to buy lunch, they took a bag lunch, which was a sandwich.

Mark Trottier, 131 Woodlawn Ave, Wayne Goodell, 546 Barbour Street and Roger Eurburn, 677 Ashland Street all agreed with Councilor Wilkinson.

Councilor Wilkinson withdrew his original motion.

On motion of Councilor Wilkinson, duly seconded by Councilor Merrigan it was VOTED: to file the communication.

11,363 The President presented an application submitted by Cumberland Farms, Inc. 100 Crossing Blvd, Framingham, MA for a Public Hearing for underground fuel storage located at 1366 Curran Highway.

Without objection the President set the Public Hearing for March 25th at 7:30pm.

The President presented an application for a renewal of a secondhand license submitted by Mary Ann George, 656 Ashland Street in the business name of "Maryann-tiques & Gifts", located at 615 Ashland Street.

On motion of Councilor Breen, duly seconded by Councilor Wilkinson it was VOTED: to grant the license.

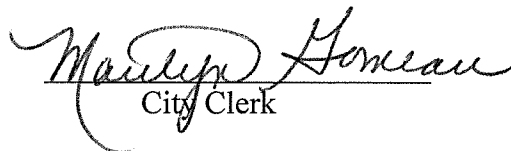

The Mayor delivered a proclamation declaring the month of March **AMERICAN RED CROSS MONTH**. The Mayor also thanked Mike Chalifoux and his crew for doing such a good job cleaning up our streets, especially the main corridors coming into the City.

With no further business to come before the Council a motion to adjourn was in order.

A meeting of the North Adams City Council was held at 7:30pm in City Council Chambers with the following present:

A moment of silent prayer was observed, remembering Mary Williams, employed by the North Adams School Department 1962-1993 and former member of the North Adams Retirement System. Paul Matrigali former Plumbing and Gas Inspector for the City, retiring after 49 years of service. Lawrence Moreau former City Councilor.

The Pledge of Allegiance was recited.

The President called for the approval of the minutes of the March 11th meeting.

On motion of Councilor Lamb, duly seconded by Councilor Merrigan it was VOTED: to approve the minutes as presented.

On motion of Councilor Wilkinson, duly seconded by Councilor Bullett it was VOTED: to amend the last sentence of Council paper 11,362 to read Wayne Goodell and not Wayne Wilkinson.

The President declared the Public Hearing Open regarding underground fuel storage for Cumberland Farms, located at 1366 Curran Highway. Representatives from Cumberland Farms explained they would have two 20,000 gallon tanks for regular gas, one 8,000 gallons for premium and one 8,000 gallons for diesel fuel. The tanks will be monitored 24/7.

Councilor Wilkinson questioned if they had all the proper permits. Council President said the application had all of its approval from the Fire Director.

Without objection the President placed the communication on file.

- 11,240-2** The President presented an Ordinance amending Chapter 2 Section 2-28(a) of the Revised Ordinances Schedule B the Compensation Plan-Police-Fire and Hourly Wage for FY'13.

On motion of Councilor Merrigan, duly seconded by Councilor Lamb it was VOTED: to pass to a second reading and publish as required by law.

Councilor Wilkinson asked how long the contract was for. The Mayor said fire was 5, three back, current and next fiscal year. Police is three years and DPW is two years. Councilor Wilkinson noted that it is actually 5%. The Mayor noted it is not more than 1% per year. Councilor Wilkinson asked if the contract included retro pay. The Mayor noted Fire was going back three and a half years, Police a year and a half and DPW this fiscal year. Councilor Wilkinson said the \$41,000 that was being transferred would not be enough to cover the total. I see it to be \$137,000 with retro. Michael Canales Administrator Officer said the \$41,000 was to cover FY'13, and \$96,400 would cover FY'14. Councilor Wilkinson said he had a problem agreeing to pay money we do not have. Councilor Lamb asked where the additional money would come from. The Mayor

explained with the end of year calculation, some will come from reserve account and unexpended items in the budget. Councilor Bona said it is all in how you perceive it, yes we are approving 5% , but in the last four years we have given 0% raises. I know it has been said how can we be giving raises, when in the private sector they are not. Councilor Bona said statistics show nationally the private sector is running about 3% raises. Councilor Wilkinson said he was just pointing it out for clarification. Councilor Moran thanked the Police, Fire and DPW for their service, and working without a contract. He expressed that he would like to see in the future they do not go that long without a contract.

Michael Canales said this property has been in limbo for many years. The Mayor noted the property has a right of way to the cemetery. Councilor Lamb asked what the monetary amount would be to the City. Michael Canales said they would pay all interest, taxes, and lawyers fees. Councilor Bona asked if this should have been caught sooner. Councilor Breen asked who has the title to the property. Mr. Canales said when the City was going to sell the parcels of land at auction that is when it was caught. This will allow the Kline family to sell the house located on West Main Street.

The Conte project was going to be state of the art and now the playground is going to have wood chips, many things are being scaled down because the project is coming in over budget. Roger Eurburn, 677 Ashland Street asked if anyone was good at grant writing to please contact him, there are a number of sources for grant money and I have no experience in grant writing.

The President called for any Councilor Concerns, several Councilors were very concerned about the recent news of the closing of the North Adams Regional Hospital. The Mayor is working very hard with the Governor, Senator Benjamin Downing and Representative Gailanne Cariddi to help save the hospital. John Meaney, general manager of the North Adams Ambulance Service assured everyone that the ambulance will

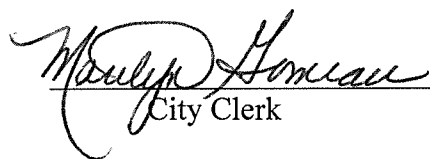

The Mayor read a proclamation declaring April as Child Awareness month.

Councilor Bullett gave a summary of the Finance Committee meeting held on March 19th.

Wayne Goodell, 564 Barbour Street thanked Councilor Bullett for the way she ran the finance committee meeting. Roger Eurburn, 677 Ashland Street noted on Saturday the Day of Service they will not be able to work at Hillside Cemetery because it is too wet and muddy. Kathy Dunn, of Williamstown a nurse who worked at the North Adams Hospital said she was hired on March 3rd and lost her job on March 28th. She will be unable to stay in the community and will be moving to Florida, but she was hoping she could stay to help resolve this problem. Ms. Dunn was amazed at the bonding this community has and hopes everyone will stay connected and attend the meetings held every Tuesday at the American Legion at 5:00pm. It is very important for the community to speak out to the politicians and let them know the community will continue to fight for the hospital. Robin Cimonetti of Clarksburg and Angie Linger of Pownal, nurses for many years at the hospital thanked the community and the Mayor for all their support and we need to continue to push forward. Tuesday April 15th two busses will be going to Boston to the Governor's Office to petition for a critical care facility in North Adams. Ann Clark-Kilman, pastor of the First Congregational Church said they have seen an increase in people coming for the free meals. The pastor was also concerned

about the young women and teens who will be missing the care of a lactation counselor after they leave the hospital. This service is very important to the new moms and infants. Amanda Chilson from Northern Berkshire Coalition reminded everyone about the fitness challenge that begins on May 1st.

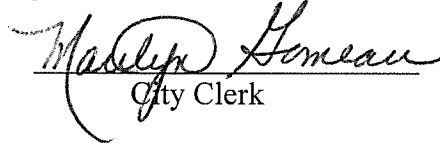

Councilor Bona also noted it would be too costly to put meters in the cars. Edward Morandi, 777 West Shaft Rd would like to see the school children get involved with our Sister City Tremosine. Tremosine has erected a welcome sign in Italy including North Adams and said it would be nice if North Adams could do something like that.

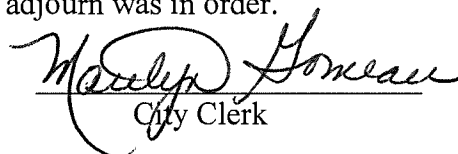

REGULAR MEETING OF THE CITY COUNCIL May 13, 2014

A meeting of the North Adams City Council was held at 7:30pm in City Council Chambers with the following present:

COUNCILORS PRESENT: Blackmer, Bona, Breen, Buddington, Bullett, Lamb, Merrigan, Moran.
Councilor Wilkinson absent.

A moment of silent prayer was observed remembering Beverly Williams, Teacher's Aide at Greylock School, Roger Lavigne, thirty year employee of the Cemetery Department, and Mae Fulginiti, mother of Assistant City Clerk Nancy Canales.

The Pledge of Allegiance was recited.

The President called for the approval of the minutes of the April 22nd meeting.

On motion of Councilor Lamb, duly seconded by Councilor Bullett it was VOTED: to approve the minutes as presented.

11,375 The President presented Mayor's communication #28 regarding the Scanlon Audit for FY'13.

Without objection the President placed the communication on file.

The Mayor stated that Thomas Scanlon principal of Scanlon & Associates would be giving a presentation outlining the audit done by his company for FY'13. The assessment shows lack of reserves and free cash. The audit found no findings and only had recommendations. Councilor Bona asked the Mayor to explain to the new Councilors exactly what the audit entails. The Mayor said that the power point would explain exactly who Scanlon & Associates are, what they do and what their findings are. Mr. Scanlon presented the power point presentation giving an overall view of the findings for FY'13. The Audit found a few procedural issues and improvement in several areas. The main issue he warned was the lack of reserves and use of account transfers. Mr. Scanlon said the city can go one of two ways, you cut the budget or go for some kind of exclusion. He cautioned that if the city goes for an override there has to be a plan in place and it has to be well thought out. Mr. Scanlon pointed out that the city should have an amount of between 3 percent and 5 percent of its budget in reserves, or about \$1.2 million. Councilor Moran after hearing the presentation remarked that the city is not lavish with spending but that it costs money to run the city. An override was tried and it failed so we did make cuts. People were upset about crime last summer, and now they're upset about the police getting a raise. Councilor Bullett stated that state funding has dropped each year. Mark Trottier, 131 Woodlawn Ave. asked about the leases that were shown on the report he knew of the lease for 3 police cars and 1 fire chief car which

needed a transfer to make payment but no mention in the transfer was made of a lease for a tractor. The tractor was a separate lease. Mr. Scanlon said that all leases for the year were shown together in one line item. Councilor Buddington was glad to see people are interested, study the information given out and ask questions. Wayne Goodell, 564 Barbour St. objected to an override noting the loss of hundreds of jobs because of the Hospital. Councilors Breen and Blackmer asked for a historical look at the use of reserves and free cash back at least a decade. The Mayor said that they will be given that information at the Finance Committee Meeting. The Mayor said the deficit is still big but has improved somewhat. The Mayor expects to present a draft budget to the council at its next meeting and asked Councilor Bullett for a meeting of the Finance Committee May 28th and 29th, with other dates the following week.

The President presented an application for a secondhand license in the business name of Sanford & Kid located at 160 Houghton Street submitted by Timothy Randall 180 Bracewell Ave.

On motion of Councilor Breen, duly seconded by Councilor Buddington it was VOTED: to grant the license.

The President called for anyone wishing to speak in Open Forum, Roger Urban 677 Ashland Street informed the Council that the Unity Youth Leadership Group had volunteered to help clean the Hillside Cemetery on May 17th, weather permitting. Any help anyone can give would be greatly appreciated. Mr. Urban also asked that anyone having graves at Southview Cemetery when they are cleaning around the graves need to take any trash to the area down near the buildings at the cemetery and not put it along the side of the roads, which was the usual practice.

Wayne Goodell, 564 Barbour St. was very concerned about the number of people unemployed in the city and the possibility of an override. Adam Tobin, 68 Meadow St. said that the Unity Leadership Project is having a Pizza Party Fund Raiser at the American Legion on May 29th. The kids will be making the pizzas; the money will benefit an orphanage in Haiti. Mr. Tobin also stated that he had been at Windsor Lake and there was a lot of trash and fishing line all over. He was hoping that he could bring a group up to the lake to clean. The Mayor said that any citizen wishing to help keep the city up, such as the Veterans who each week clean the trash along our road ways, are greatly appreciated. Mark Trottier, 131 Woodlawn Ave., asked Councilor Bullett when the Finance Committee would be meeting on the budget. She stated that as soon as she knows when the meetings will be they will be posted. Edward Morandi, 777 West Shaft Rd. asked that the memorial sign for Corporal Greene at the corner of Barbour St. and Greene Ave be replaced. It was first thought that the name had been misspelled but it was found that the sign had deteriorated. The Mayor said that new signs will be put up. Justyna Carlson, Chairwoman for the Historical Commission introduced Jennifer Berden of Gray & Pape, a consulting firm for historical resource management and preservation. The company will be documenting 100 properties to add to the initial historical survey done in 1978. The current survey has 320 properties and six historic districts. The survey is being done through a Massachusetts Historical Commission grant of \$20,000. Ms. Carlson wants the public to know they're out taking pictures of houses and may be standing with notebooks taking down notes about the architecture. Ms. Berden said they would be easy to spot with their fluorescent vests; they also will leave note cards explaining what they are doing.

The President called for any Councilor or Mayor's concerns, Councilor Breen said that Becky Miner of Zumba Fitness in the Berkshires held a dance on Main St. for the Relay for Life it was a lot of fun, well attended and raised \$13,000 dollars. She also wanted everyone to join the Mayor's Fitness Challenge. Councilor Merrigan said the Northern Berkshire Community Coalition will be holding a luncheon meeting at the Williams Inn and they will be honoring Becky Miner for all her community involvement. Councilor Lamb reminded everyone of the MCLA graduation this Saturday. He was also very concerned about how dirty the sidewalks are with sand from the winter making it hard to walk. He encouraged everyone to sweep their sidewalks. The Mayor said that residents may sweep the sand into the streets to be picked up by the sweeper but to pick up any glass or any

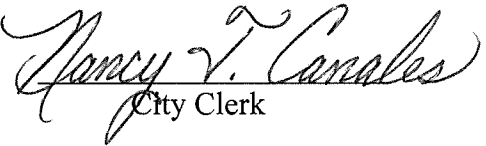
other debris. Councilor Bullett said that on Sunday, May 18th the Steel-Rail Half Marathon will be held. The run is a Bike Path Fundraiser. She was sorry to hear that the lake needed cleaning as they had a clean-up just a few weeks ago. Councilor Buddington is considering bringing a paper to the council about the Right to Farm in the city. The President suggested that if he does a paper on the subject to refer it to the General Government Committee for review. Councilor Bona wanted to thank National Grid for their great response to the electric outage we had last Friday. He also said that Edward Morandi and 17 other people would be traveling to our Sister City Tremosine soon. Mr. Morandi said that they will be meeting with the Mayor and Council while they are there and will be working on getting 5th, 6th and 7th graders to be e-mail pals with kids in North Adams. It was also suggested that if anyone had something that could be brought to Tremosine as a gift to that city they could contact Mr. Morandi. The President also congratulated the MCLA graduates and hoped that people in the city would welcome all the tourists that will be in town. Work will be done on Center St. and Holden St. and she hoped that there would be a sign put up for Holden St. when the project was done.

With no further business to come before the Council a motion to adjourn was in order.

A moment of silent prayer was observed remembering Rod Bunt, first Director of Tourism for the City of North Adams and was Director for several years of the annual Fall Foliage Festival Parade. Alice Laird, former cafeteria worker at Greylock Elementary School. Raymond Cimonetti, former highway/water department employee and supervisor of the landfill. Jack Gigliotti, former North Adams City Councilor.

The Pledge of Allegiance was recited.

The President called for the approval of the minutes of the May 22nd meeting.

On motion of Councilor Merrigan, duly seconded by Councilor Lamb it was VOTED: to approve the minutes as presented, with Councilor Wilkinson abstaining.

11,381 The President presented a communication submitted by Council President regarding Melissa Cairns class from the Drury High School.

Without objection the President placed the communication on file.

Elizabeth Bona and Andrea Blaisdell presented a vision creating their idea an app for the i-phones enabling people to navigate around the City. They would call it "Take a Napp". Mackenzie Wright and Alex Bernard presented an idea about a community volunteer program and would like to see younger people involved in volunteering. Hopefully if they started at a younger age it would be something they could carry throughout their lives. Allison Bergeron, teacher at Drury High School stood in for Melissa Cairns, due to an illness. Councilors were very impressed with the ideas the students presented, these students are our future. 11,377 The President presented Mayor's communication #30 requesting a "Home Rule Petition" for a Liquor license.

Without objection the President placed the communication on file.

11,377 The President presented an Order authorizing the Mayor to petition for Special Legislation concerning liquor license for Steeple City Liquors d/b/a V&V.

On motion of Councilor Bona, duly seconded by Councilor Breen it was VOTED: to refer to the Public Safety Committee and postpone to the meeting of July 8th.

The Mayor explained that under State Law the City is only allowed 3 liquor stores because of our population, it is one store for every 5,000 residents. The Mayor was concerned about setting a precedent, but also noted Mr. Ellis has made a significant investment in the downtown.

Several Councilors had concerns in regards to issuing another liquor license. Councilor Breen is pro business and feels that they should be given a chance to thrive in North Adams. Councilor Wilkinson said he is dead set against another liquor license. Councilor Moran challenges V&V to convince him of the need for a license.

David Whitney of Whitney's Beverage Shop noted his family has served the needs of this community for 76 years. He asked the Council to reject this petition and said the Mayor had promised to stand behind the decision of the license board.

Richard Sheehan owner of Ed's Variety said he has worked hard to support the community and if the City is handing out liquor licenses, he wanted one too.

Michele Butler of Cain Hibbard & Myers said that V&V had tried to obtain the license but found it was no longer available because of the results of the U. S. Census. The City's population is around 13,000.

11,377-1 The President presented an Order accepting Chapter 138, Section 15 of the MGL, Liquor license for Steeple City Liquor.

On motion of Councilor Bullett, duly seconded by Councilor Moran it was VOTED: to postpone to the meeting of July 8th.

11,378 The President presented Mayor's communication #31 recommending a revenue package.

Without objection the President placed the communication on file.

The Mayor explained this revenue package was to support the FY'15 budget. He is proposing a 10% increase to the water rates from \$3.50 to \$3.85 per cubic foot. Historically water rates increase every 2 to 3 years and they have not increased since FY'11. Sewer fees would increase 8%, from 42% of water to 50% of the water bill. The average increase by both fees for a 2 person household would be approximately \$35.00 and to a 4 person household it would be approximately \$66.00. Increase all parking violations and demand fees on excise bills from \$5.00 to \$15.00. This package would generate approximately \$426,500 annually.

Councilor Breen said she would not support the revenue package and was not in favor of increasing rates for the homeowners.

11,379 The President presented Mayor's communication #32 presenting the "Draft Budget" for FY'15.

Without objection the President placed the communication on file.

11,379 The President presented a "Draft Budget" appropriating the sum of \$37,740,793.00.

On motion of Councilor Buddington, duly seconded by Councilor Bullett it was VOTED: to refer to the Finance Committee.

Councilors all had several questions regarding the draft budget and the Mayor said that the finance committee will be having several meetings in the next couple of weeks and these questions can be addressed at that time. Councilors hoped that these meetings would be televised so the residents could have a chance to see exactly what the City is facing. Councilors encouraged residents that were in attendance to attend the finance committee meetings so their concerns could be addressed.

11,380 The President presented Mayor's communication #33 regarding a Resolution for a Common Backyards Grant Program.

On motion of Councilor Buddington, duly seconded by Councilor Breen it was VOTED: to refer to the General Government committee and postpone to the meeting of August 12th.

The President called for anyone wishing to speak in Open Forum, Roger Eurbin 677 Ashland Street thanked the veterans for participating in the Memorial Day Service on such a rainy day.

Michael Chailfoux, 54 Monroe Street was concerned again about the Veterans Outreach Center.

On motion of Councilor Merrigan, duly seconded by Councilor Lamb it was VOTED: to approve the minutes as presented.

11,379 The President presented a "Draft Budget" appropriating the sum of \$37,740,793.00, which was referred to the Finance Committee at the meeting of May 27th.

Councilor Bullett gave the report of the Finance Committee.

Councilor Breen entered the meeting at 7:38pm.

On motion of Councilor Wilkinson, duly seconded by Councilor Buddington it was VOTED: to accept the committee report as presented.

Councilor Bona noted that at the Finance Committee meetings, there were many good questions asked by Councilors and the public. Councilor Wilkinson noted he had made it clear the he was not in favor of the revenue package, but after sitting through all the finances meetings, it became very clear that there is no choice but to accept the revenue package.

The Mayor noted he was bringing the revenue package forward because he had no choice. It boils down to raising fees of face significant cuts. I want the community to understand that this revenue package combined with cuts and reductions will only get us through the upcoming fiscal year. Residents need to understand that this administration does not have a spending problem; the City has a revenue problem.

Without objection the President moved Council Paper 11,384.

- 11,384** The President presented a communication submitted by Councilor Bona regarding the recent trip residents took to our Sister City Tremosine.

Without objection the President placed the communication on file.

Edward Morandi, 777 West Shaft Road spoke on the warm welcome they received from our Sister City. He explained that the 5th, 6th and 7th grade children would like to do an e-mail exchange with our students. A J Bona, 179 North Street also went on the trip to Italy and he presented the Council with a replica sign that Tremosine has entering into their City.

- 11,378-a** The President presented Mayor's communication #31-a recommending an increase to Water, Sewer and Parking violations.

Without objection the President placed the communication on file.

- 4840-21** The President presented an Order amending Section 20 of the Water Rates, Rules and Regulations as most recently amended on June 22, 2010.

On motion of Councilor Merrigan, duly seconded by Councilor Buddington it was VOTED: to adopt the Order.

The Mayor explained the water rate will increase 10% per 100 cubic feet, from \$3.50 to \$3.85, which should generate \$161,800. Nonresidents; Williamstown will pay \$7.32 per 100 cubic feet, which is 90% above the residential rate. Clarksburg will pay \$6.63 per 100 cubic feet, which is 72% above the residential rate.

On motion of Councilor Lamb, duly seconded by Councilor Moran it was VOTED: to amend the Order to read beginning July 1, 2014.

Councilor Merrigan noted the increase is not huge to retain services. The increase does not just affect the home owners, but as a renter, when fees go up so does my rent.

Councilor Buddington said he would like to see the water and sewer departments switch to enterprise funding. The Mayor agreed that enterprise funding would be more beneficial and would be worth doing when the City is more financially stable.

On motion of Councilor Wilkinson, duly seconded by Councilor Breen it was VOTED: to confirm the appointment.

Councilor Wilkinson wondered if Ward 4 could be moved to St. Elizabeth, making it more cost effective. The Clerk said she would like nothing more than to do that, but Ward 4 is the biggest voting ward. There would be no savings in moving the ward, since you would still need an officer for each ward by State Law.

The Mayor said since St. Elizabeth does not meet the Federal Standards for ADA we will have to decide on moving because the center is not in compliance. Fixing the issues would be very extensive and expensive, so we will be looking into Colegrove Park Elementary School, which will be fully compliant and have adequate parking.

The Order was adopted by yeas and nays vote as follows; yeas Councilor Blackmer, Bona, Breen, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson. Nays none.

- 11,399** The President presented a communication submitted by Councilor Lamb regarding a local Historic District Commission.

On motion of Councilor Lamb, duly seconded by Councilor Merrigan it was VOTED: to refer to the Community Development Committee and postpone to the meeting of September 23rd.

Councilor Lamb would like to create a Local Historic District Committee that adequately fulfills the requirements of MGL to act as a Local Historic District Study body. This fits nicely with what the City is currently doing.

Justyna Carlson of the Historical Society and Commission said that Councilor Lamb has done his homework and the society is in full support of this.

- 11,400** The President presented a request from Dufour, Inc. 464 Curran Highway for a Public Hearing to install a 10,000 gallon aboveground Diesel Fuel.

Without objection the President set the Public Hearing for August 26th at 7:30pm.

The President presented an application submitted by Erik Shield, 419 Church Street to drive taxi for Michael McMillian, City Cab.

On motion of Councilor Lamb, duly seconded by Councilor Bona it was VOTED: to grant the license.

Councilor Bona requested that Council postpone until a later date. Councilor Bona noted there has been violations by City Cab and would like to wait on this until the Public Safety Committee can meet to address the issues.

Councilor Lamb withdrew his original motion and Councilor Bona made a motion to postpone to a later date until the committee can meet with Mr. McMillian on some of the concerns that have been raised against City Cab.

Councilor Wilkinson objected to the postponement, saying we should not hold up two people from making a living. He does not believe Council should not penalize the applicants because there is a problem with the owner. Councilor Wilkinson said if the violations were so egregious why is the company still operating and why has the Public Safety Committee not immediately met on the violations.

The Mayor explained he and Lt. David Sacco had spoken to the owner last week after reviewing the City Taxi Ordinances, but based on that meeting I do not see a lot that has changed. City Cab was approved for two cabs but three cabs have been operating. The Mayor said there have been complaints about smoking in the cabs, which is a violation of State Law and witnesses have seen unlicensed people driving the cabs.

Councilor Breen objected to the discussion of City Cab saying it is a violation of the owner's rights. Mr. McMillian should be notified he was going to be accused publicly by elected officials.

The President called for a roll call vote to postpone the license, on roll call the following responded: yea Councilor Bona, Moran. Nay Councilor Blackmer, Breen, Buddington, Bullett, Lamb, Merrigan, Wilkinson.

On motion of Councilor Wilkinson, duly seconded by Councilor Bullett it was VOTED: to grant the license, with Councilor Bona and Moran opposed.

The President called for anyone wishing to speak in Open Forum, Gus Jamallo from Gus's Barber Shop on Union Street was concerned about the large holes in front of his shop. He said he has called the City on several occasions and has not heard anything. Mr. Jamallo presented pictures to the Council for review.

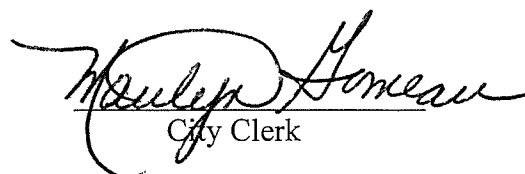

With no further business to come before the Council the President called for a motion to adjourn.

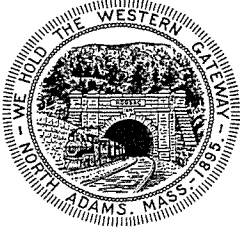

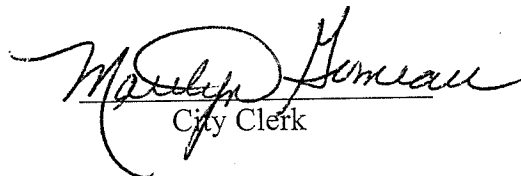

Councilor Moran asked the Mayor if he could explain the Historical Society decision to delay the demolition of the Houghton Street Mill houses. It seems Mr. Horbal had a change of heart, and wants to see these things around for another year. The Mayor said the commission did support demolition in April; personally the Mayor has been after these houses to come down for the last four years. Mr. Horbal of the Historical Commission obtained new information and invoked a one year delay. The houses have been removed from the CDBG cycle because of negotiations with the estate. The Mayor said delaying the demo could save the Community Development Block Grant considerable amount of money. The Commission plans to raise money to restore one building. Councilor Wilkinson asked what was so historical about these buildings. Councilor Bullett understands the perspective of historical buildings, however she questioned how this all came about. Councilor Bona was concerned that the Commission held a meeting in April, with 20 people attending advocating for demolition of these buildings. The Commission should hold another meeting which would allow neighbors to attend and not be limited to two minutes at the Council meeting. Councilor Bona noted it is a big project that the Commission is bringing forward and it should be a special meeting. Councilor Moran asked what would happen if the funding falls through, are all these building off the chopping block or can it be reconsidered. Council President cautioned the Council that they should not be debating the issue since it was not on the agenda. Council President would like the Commission to come to the next Council meeting to answer the questions Councilors have.

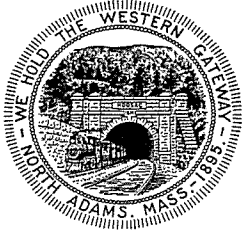

The Ordinance as amended was ordained by ye and nay vote as follows: ye Councilor Blackmer, Bona, Breen, Buddington, Bullett, Merrigan, Moran, Wilkinson. Nay none.

11,405 The President presented a communication submitted by Councilor Bona regarding discussion on Houghton Street Mill Houses, proposal and demolition.

On motion of Councilor Bona, duly seconded by Councilor Merrigan it was VOTED: to file the communication.

Councilor Bona submitted pictures of the houses on Houghton Street and noted he had attended the Historical Commission meeting in April when the decision was made to demolish the buildings. Several residents who are here this evening were also in attendance of that meeting. Councilor Wilkinson felt this discussion should be handled at a committee meeting. Councilor Buddington and Breen felt since there are many residents of the Houghton and North Street area, they should be allowed to discuss their concerns.

Justyna Carlson chairwoman of the Historical Society said the August meeting was publicly posted, just the same way the April meeting was concerning these buildings. It was not the intent of the commission to hide anything at this meeting. The agenda clearly stated they were revisiting the Mill Houses on Houghton Street. Alan Horbal of the Historical Commission said he did propose the demolition of these buildings, but it bothered him because these houses have been on the maps since 1870. Mr. Horbal said there would be two nice buildings with brick sidewalks and possibly gas lighting, but it will take time and we cannot go on the property until we establish a nonprofit and begin to solicit donations to restore two of the buildings. The corner store at Liberty and Houghton is expected to be demolished in the next few months by the estate.

Jeffrey Kemp, Houghton Street said he did attend the meeting in April and made a presentation to the Commission along with pictures detailing the reason the building should come down. He was dismayed that the commission had not invited him to the meeting. Linda Snow, 1 Raymond Court lives behind the buildings since 1960 and these buildings should have come down 30 years ago. John Lipa, 171 Houghton Street said his family has lived there since 1945 and invested a considerable sum of money to maintain the property and agrees they should be demolished. I do wonder what the City is going to do if they come down, take a look at Houghton Street where property has been taken down, no one maintains it. Mr. Lipa said it is not just the structures but the whole area is blighted. The City does not have the resources to maintain the land where properties have been torn down. Mr. Lipa said you can have the best museum in the world but it has to have a good entrance. Kathy Mancini, 69 Hathaway Street agrees they should come down, if for nothing else, safety reasons. These plans are a dream, not reality. Anthony Mirante, 34 North Street is the facility manager for MCLA for 30 years, said a carpenter is not an engineer and those buildings cannot be salvaged. I have lived on North Street since 1962 and I have watched those houses fall apart year after year. Michael Goodson, Liberty Street, bought his house eight years ago and he has a front row seat watching junkies and rodents going in and out of these buildings, it is an eyesore to the neighbors. Residents were upset over the backtracking by the commission since it was approved in April to raze the buildings.

The Mayor questioned why the Council was holding discussion; we are talking about properties that are not in this round of demolition, The Mayor asked what was the Council's intent.

Councilor Bullett said the plan sounds great but in the meantime the City needs to have a plan to secure these buildings. Councilor Bona said he is a creative person, but he just does not see the image for these properties. Councilor Breen would like to see the City put pressure on the estate to do something immediately and come back in two weeks with a report. Councilor Wilkinson said the City should take action immediately to secure this property, it should be a priority. He asked the Mayor to secure the buildings and send the bill to the estate. The Mayor agrees these buildings are troublesome, but felt the Historical Commission should be supported in their efforts to preserve a piece of history.

The President shared a correspondence she had received from the Department of Conversation and Recreation concerning acquisition of 275 acres + of forest land in the City of North Adams. The property abuts Clarksburg State Forest.

The President called for anyone wishing to speak in Open Forum, Jim Lipa, 171 Houghton Street reminded everyone they are still having meetings at the American Legion on Tuesday to discuss health care and the upcoming health care report.

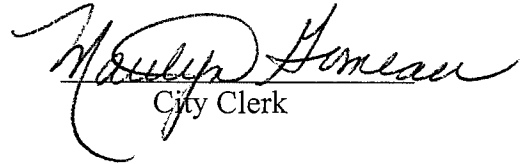

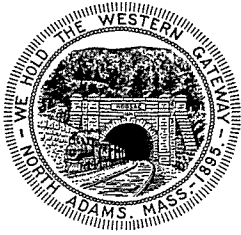

Without objection the President placed the communication on file.

The Mayor noted the work on the solar project has been in the works for four years. Due to the complexities of site location, permitting financing and many other things the project has had its ups and downs. The array will be located on our capped landfill and has cleared all local permitting including the DEP. Borrego Solar had presented a wonderful initiative that has the potential to save the City \$200,000 in utility cost in the first year.

Amy McDonough a representative from Borrego Solar gave a presentation on the project. Councilor Wilkinson was concerned if the construction would affect the transfer station and the large trucks going to the site.

Ms. McDonough said the site would be fenced in and the truck traffic would be about 2 to 3 trucks a day.

Councilor Buddington asked if a tornado was to occur, who would assume the liability. Ms. McDonough said it would be at the risk of the investor.

The Mayor thanked Amy McDonough and Ross Vivori for their hard work on this project.

The Mayor explained that MoCA has purchased the Leu property on the corner of Marshal and West Main Street. 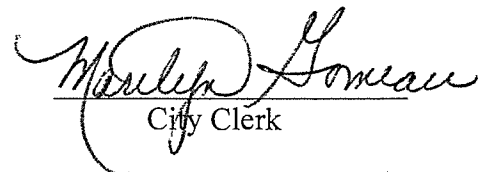

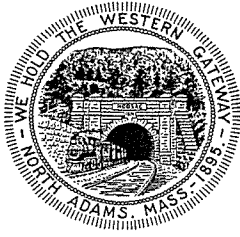

A meeting of the North Adams City Council was held at 7:30pm in City Council Chambers with the following present:

COUNCILORS PRESENT: Blackmer, Bona, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson.
Absent Councilor Breen.

A moment of silent prayer was observed.

The Pledge of allegiance was recited.

The President called for the approval of the minutes from the meeting of September 23, 2014

On motion of Councilor Wilkinson, duly seconded by Councilor Lamb it was VOTED: to accept the minutes as presented.

Without objection the President moved Council Paper #11,416 regarding a Resolution for the North Adams Hospital.

11,416 The President presented a communication submitted by Councilor Lamb regarding a resolution for North Adams Regional Hospital.

Without objection the President placed the communication on file.

Councilor Lamb said this resolution is on behalf of concerned citizens that meet weekly to discuss the closing of the North Adams Regional Hospital. The hospital closed in March when they declared bankruptcy. BMC has restored emergency and some imaging services. The state report concluded a full service hospital would be smaller and require Critical Access for full Medicare reimbursement.

11,416 The President presented a Resolution supporting the reopening of the former North Adams Regional Hospital as a full service hospital.

On motion of Councilor Lamb, duly seconded by Councilor Merrigan it was VOTED: to adopt the Resolution.

Councilor Merrigan said she felt it was a valuable symbolic gesture for the Council to support this resolution, it may not bring the hospital back, but it certainly sets the right tone. She appreciates how hard the group has

worked to fight for the hospital. Councilor Buddington said he recognizes the information given to us and they have done a responsible job in getting the information to us. Councilor Bona was a little concerned about the language, specifically unlawful. Has it been defined as unlawful or is this an opinion, does this mean criminal. Councilor Lamb explained that was the phrasing the Attorney General's Office used.

Michael Fadel, representative for the Massachusetts Nurses Association said the recent report did not favor returning the hospital to its former status, but did note there was a need in Northern Berkshire for a smaller inpatient care hospital. We believe through the regular meetings and the support of elected officials this has been kept front and center. If we can escalate it at this time there is no reason inpatient services can't return to North Adams. James Lipa, 171 Houghton Street urged City Officials to look at creative alternatives to make a full service hospital sustainable without relying on Critical Access designation. Mass MoCA would never have happened if they did not think outside the box. Milton Overlock, 52 Seminole Drive, Michael Wilbur, 11 Fuller Street and Ross Ziskind, West Shaft Road all expressed the need for a full service hospital.

On motion of Councilor Lamb, duly seconded by Councilor Merrigan it was VOTED: to adopt the Resolution.

The Resolution was adopted by yea and nay vote as follows; yea Councilor Blackmer, Bona, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson. Nay none.

The President called for a short recess.

The President called the meeting back to order.

11,382 The President presented a communication submitted by Councilor Buddington regarding farming, which was postponed at the meeting of October 14th.

Without objection the President placed the communication on file.

11,382-1 The President presented an Ordinance amending Chapter 2 of the Revised Ordinances of the City of North Adams entitled Administration by adding a new section.

On motion of Councilor Buddington, duly seconded by Councilor Merrigan it was VOTED: to refer to the City Solicitor and postpone to the meeting of October 28th.

11,404 The President presented a Resolution supporting the ban of Fracked Gas Pipeline and supporting sustainable energy in the Commonwealth of Massachusetts, which was referred to the Public Services Committee and postpone at the meeting of August 26th.

On motion Of Councilor Wilkinson, duly seconded by Councilor lamb, it was VOTED: to adopt the Resolution Councilor Moran gave the report of the Public Service Committee. The committee recommended a few minor changes in the wording. In the 6th paragraph delete and residents and insert in its place on behalf of the residents and in paragraph 7 delete and residents and insert in its place on behalf of the residents. Sub section 2 add new after /or any.

On motion of Councilor Lamb, duly seconded by Councilor Buddington it was VOTED: to accept the committee report as presented.

Councilor Bona said he had very mixed opinions on this matter, and would like to have a better understanding of this Resolution.

Rachel Branch, 999 Massachusetts Avenue an advocate against the pipeline, stated it is a public safety issue, a public health issue and it's about saving our planet. Roger Eurbin, 677 Ashland Street noted it was a safety issue shipping natural gas by train. We have hundreds of tank cars coming through here.

Councilor Bullett said she too was uncomfortable with voting on the resolution without having more answers.

The Resolution, as amended, was adopted by yea and nay vote as follows; yea Councilor Buddington, Lamb, Merrigan, Moran, Wilkinson. Nay Councilor Bona, Bullett. Councilor Blackmer abstained.

11,212-1a The President presented Mayor's communication #45A regarding the lease for the former landfill, for the Solar Project.

Without objection the President placed the communication on file.

The Mayor noted everything has been permitted, negotiated and Borrego is out for financing at this time. This is the last piece and we should see construction soon. The City is leasing the land for \$12,000 a year, we are hoping for about \$200,000 in energy savings.

Councilor Wilkinson said he had some concerns with the lease, but felt the project would benefit the City. Councilor Moran felt it was a great opportunity to see what a project like this can do for the City and utilize land that was nothing, even if the savings is \$2.00 the first year it is great use of the land. Councilor Bona wonder if it was possible to install a solar array on the City's old water treatment plant.

The Mayor noted that area was more complicated because of large sewer lines and water pipes are buried underneath. We are looking at the possibility of panels at the airport and also Reservoir Road. The Mayor believes this will be one of the largest solar arrays in the State.

On motion of Councilor Lamb, duly seconded by Councilor Buddington it was VOTED: to endorse the Comprehensive Plan.

- 11,426** The President presented Mayor's communication #60 recommending the re-appointment of Michael Leary to the Redevelopment Authority for a term to expire June 1, 2018.

On motion of Councilor Lamb, duly seconded by Councilor Bullett it was VOTED: to confirm.

Councilor Wilkinson was curious why the expiration date was June 1st and not November 25th; are they hold overs?

The Mayor said they are hold overs, but the Ordinance is specific to the terms.

Councilor Bona said that the Redevelopment Authority was established in 1970; is that something that will always be with us? The Mayor said it was established during Urban Renewal to help businesses become established. It is healthy to have. Councilor Wilkinson noted that according to the law, it is a requirement. The Planning Board and the Redevelopment Authority are very different from each other.

- 11,427** The President presented Mayor's communication #61 recommending the re-appointment of Paul Hopkins to the Redevelopment Authority for a term to expire June 1, 2019.

On motion of Councilor Wilkinson, duly seconded by Councilor Buddington it was VOTED: to confirm the appointment.

- 8717-34** The President presented Mayor's communication #62 requesting a Public Hearing for the purpose of establishing the percentages of the local tax levy to be borne by the various classes of real property.

Without objection the President set the Public Hearing for December 9th at 7:30pm.

- 11,428** The President presented Mayor's communication #63 regarding MASS MoCA Phase III project.

Without objection the President placed the communication on file.

The Mayor asked Joseph Thompson, Executive Director of MASS MoCA to give a brief overview of the recent announcement of the \$25 million in State funding.

Joseph Thompson gave a presentation of the future plans for MoCA. Mr. Thompson noted that phase began in 1999, between 2002 and 2011 phase II was completed. Now with the money from the State we can begin phase III and hope it will be completed by 2017, building 7 will double its space.

Councilor Bona asked if Wilco was locked in for the coming year. Mr. Thompson said they would be back in June 2015.

11,081-2 The President presented Mayor's communication #64 regarding an addendum to the Inter Municipal Agreement for Veteran's Services.

Without objection the President placed the communication on file.

11,081-2 The President presented an Order authorizing the Mayor to add an addendum to the Inter Municipal Agreement for Veteran's Services to include the Town of Savoy.

On motion of Councilor Wilkinson, duly seconded by Councilor Lamb it was VOTED: to adopt the Order.

The Order, as amended, was adopted by yea and nay vote as follows; yea Councilor Blackmer, Bona, Buddington, Bullett, Lamb, Moran, Wilkinson. Nay none.

11,429 The President called for the report of the Public Service Committee submitted by Councilor Moran, Chairman.

Councilor Moran gave an overview of the City's infrastructure, noting the high cost of repairing and replacing the bulk of those needs, including water, sewer, roads and transfer station. Mr. Lescarbeau said that 30% of the yearly overtime roughly \$30,000 was spent on cleaning residential sewer lateral. This service is above and beyond what the City is required to do. The Mayor and the DPW would like the Council to back the original City regulation and no longer provide this service effective December 1, 2014.

Councilor Wilkinson asked the Mayor to explain what the lateral is. The Mayor said the lateral is from the pipe from the street to your home. Councilor Wilkinson said, we already have an regulation in place and we are now going to adhere to it. The Mayor said yes.

On motion of Councilor Wilkinson, duly seconded by Councilor Lamb it was VOTED: to accept the report as presented.

The President presented an application submitted by Richard W. Bostwick, 813 West Shaft Road to drive taxi for Tunnel City.

On motion of Councilor Lamb, duly seconded by Councilor Wilkinson it was VOTED: to grant the license.

The President presented an application submitted by Nicholle Cote, 34 Aztec Drive to drive taxi for Tunnel City.

On motion of Councilor Wilkinson, duly seconded by Councilor Lamb it was VOTED: to grant the license.

The President called for anyone wishing to speak in Open Forum, Elizabeth Manns, 425 North Houghton Street, Clarksburg asked about the status of the letter that was going to be sent to BMC regarding the forum with the

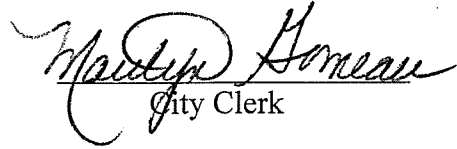

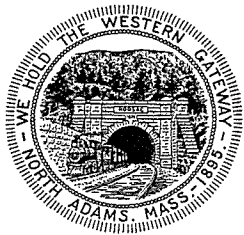

REGULAR MEETING OF THE CITY COUNCIL December 9, 2014

A meeting of the North Adams City Council was held at 7:30pm in City Council Chambers with the following present:

COUNCILORS PRESENT: Blackmer, Bona, Breen, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson.

A moment of silent prayer was observed remembering Walter Davis, long time Police Officer and Detective for the City of North Adams and Andrew Gigliotti, former industrial arts teacher at Drury High School. The Pledge of allegiance was recited.

The President called for the approval of the minutes from the meeting of November 25, 2014

On motion of Councilor Wilkinson, duly seconded by Councilor Lamb it was VOTED: to accept the minutes as presented.

PUBLIC HEARING

The President opened the Public Hearing regarding setting the percentages of local tax levy to be borne by the various classes of real property.

The Mayor explained that the FY 2015 tax levy will be \$15,019,976.00, an increase in levy of 4.05% which represents the legislated 2.5% increase plus new growth of \$225,012.00. The Mayor recommended that the City maintain the CIP shift at 1.71. Residential will go from \$15.92 to \$16.71, approximately \$115.00 annual increase on a single family home valued at \$136,200. The CIP will go from \$34.54 to \$36.07. The Mayor noted that by establishing the CIP shift we would be assuring our community that we will be able to provide services at acceptable levels. Raising the shift to the maximum 1.75 would mean about \$30.00 on the average tax bill.

Mark Trottier, 122 Woodlawn Avenue, was against the tax split noting that \$30.00 may not be a lot to some people, but to most residents they will have to make a decision on whether to buy medicine, or food. Robert Cardimino, 173 East Quincy Street was also against the shift to residential.

The President on several occasions had to remind speakers that they were veering off the subject on the shifts in attempt to debate the issue with the Mayor.

Councilor Breen said she was not voting in favor of the proposed shift to residential. The Mayor said reducing commercial helps bring in businesses, but she strongly disagreed with the Mayor. You are placing a heavy burden on the homeowners.

The Mayor objected to Councilor Breen's statements saying that he is very concerned about the tax effect on both the commercial and residential.

Councilor Breen felt the Mayor was showing favoritism toward business, noting MoCA and the incentive offered to Crane. She would like the Mayor to speak to Mr. Thompson about a Pilot payment. The Mayor took offense to Councilor Breen's statement, stating that Crane brought jobs to our community and invested a large amount of money into the company.

Councilor Wilkinson agreed with Councilor Breen saying the District Court and Social Security pay a high amount in rent to the museum, but they are tax exempt. He said this was not the time for this discussion but it was certainly something we should review.

Councilor Bona said most businesses in the City are small family owned and raising the taxes would affect them, not just the big business.

Councilor Moran noted he felt the spilt was a symbolic gesture to the businesses that have stayed in our City. If you just continue cutting, our community will continue to go downhill and the City will never be able to attract new businesses, and people will leave the area to go elsewhere.

The President declared the Public Hearing closed.

8717-34 The President presented Mayor's communication #62-a requesting the approval of the tax classification for FY'15.

Without objection the President placed the communication on file.

8717-34 The President presented an Order establishing the percentages of tax levy for the various classes of property for FY'15.

On motion of Councilor Wilkinson, duly seconded by Councilor Merrigan it was VOTED: to adopt the Order.

The Order was adopted by yea and nay vote as follows; yea Councilor Blackmer, Bona, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson. Nay Councilor Breen.

11,377-a The President presented Mayor's communication #30-a requesting the withdrawal of Council Paper #11,377 and Council Paper 11,377-1.

The President placed the communication on file.

The Mayor said the reason for withdrawing the papers is the business has acquired a liquor license from an existing business.

11,377 The President presented an Order authorizing the Mayor to petition for Special Legislation concerning a liquor license for Steeple City Liquors, which was postponed at the meeting of September 23rd.

On motion of Councilor Lamb, duly seconded by Councilor Buddington it was VOTED: to withdraw the paper at the Mayor's request.

On roll call the following responded; yea Councilor Blackmer, Bona, Breen, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson, Nay none.

- 11,377-1** The President presented an Order accepting Chapter 138, Section 15 of the Massachusetts General Laws; Liquor License, Steeple City Liquor, which was postponed at the meeting of September 23rd.

On motion of Councilor Lamb, duly seconded by Councilor Buddington it was VOTED: to withdraw the paper at the Mayor's request.

The Order was adopted by yea and nay vote as follows; yea Councilor Blackmer, Bona, Breen, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson. Nay none.

- 11,212-2** The President presented Mayor's communication #65 regarding Solar Power.

Without objection the President placed the communication on file.

Michael Canales noted that this would allow Borrego Solar to purchase credit on two solar arrays outside the City. These credits would offset about \$80,000 in annual electrical costs over the next 20 years. The projects are expected to cover energy costs to all City public buildings.

- 11,212-2** The President presented an Order authorizing the Mayor to enter into a Power Purchase Agreement with Plymouth Solar 1, LLC.

On motion of Councilor Lamb, duly seconded by Councilor Merrigan it was VOTED: to adopt the Order.

The Order was adopted by yea and nay vote as follows; yea Councilor Blackmer, Bona, Breen, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson. Nay none.

- 11,212-3** The President presented an Order authorizing the Mayor to enter into a Power Purchase Agreement with Westminister CC Solar 1, LLC.

On motion of Councilor Lamb, duly seconded by Councilor Breen it was VOTED: to adopt the Order.

The Order was adopted by yea and nay vote as follows; yea Councilor Blackmer, Bona, Breen, Buddington, Bullett, Lamb, Merrigan, Moran, Wilkinson. Nay none.

- 11,382-1** The President presented an Ordinance amending Chapter 2 of the Revised Ordinances of the City of North Adams entitled Administration by adding a new section, which was referred to the General Government Committee and postpone at the meeting of October 28th.

Councilor Merrigan said the Committee did not meet on the issue.

On motion of Councilor Merrigan, duly seconded by Councilor Bona it was VOTED: to postpone to the meeting of January 13th, 2015.

11,407 The President presented an Ordinance amending Chapter 2 of the Revised Ordinances of the City of North Adams by adding a new section. Arts Commission, which was referred to the General Government Committee and postpone at the meeting of September 23rd.

On motion of Councilor Merrigan, duly seconded by Councilor Breen it was VOTED: to postpone to the meeting of January 13th, 2015.

11,430 The President presented the report of the Finance Committee submitted by Councilor Bullett.

Councilor Bullett gave the report regarding the proposed utilization of the \$750,000 from the State. She noted that Michael Canales presented an overview of the tax classification. Mr. Canales noted State aid has decreased from 67% to 42% over the past several cycles. With the decrease in property values and decrease in State aid, the Mayor will be requesting a Prop 2 1/2 override.

On motion of Councilor Lamb, duly seconded by Councilor Buddington it was VOTED: to accept the Committee report.

Councilor Breen debated with the Mayor about a Prop 2 1/2 override which was reflected in the minutes of the finance committee.

Councilor Bullett took offense to the actions of Councilor Breen regarding the report, acknowledging the report may not have been verbatim, the report was an overview of the meeting.

Councilor Bona said that is why it is important to attend committee meetings so you get the inform first hand.

11,431 The President presented a communication submitted by Councilor Bullett regarding a presentation from Molly Prindle class project.

Molly Prindle, Caroline Bruno and Tom Murphy seniors from Williams College gave a presentation on way to improve access to local trails.

The President called for anyone wishing to speak in Open Forum, Robert Moulton, Massachusetts Avenue was very disturbed about the recent proposal to lower the standards for sports in our school system. He feels sports are not an entitlement, students should earn it.

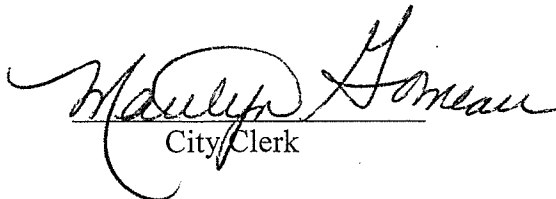

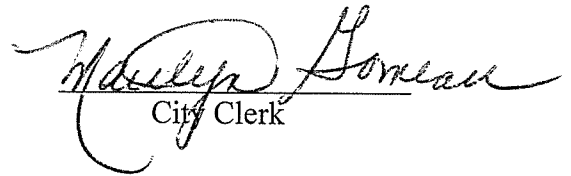
