Councilor Boucher placed the name of Councilor Lamb in nomination, seconded by Councilor Bona.

With no further nominations, all were in favor of Councilor Lamb.
The Clerk declared Councilor Lamb as Council President.

The Clerk administered the oath of office to Council President elect Lamb.

The President takes the Chair.

The President calls for nominations for Council Vice-President.

Councilor Bona nominated Councilor Bullett for Council Vice-President, seconded by Councilor Merrigan

The President called upon the Clerk to administer the oath of office to the Mayor-elect.

His honor, the Mayor delivers his inaugural address.

The President announced this concludes the organization of government for 2016 and calls for a motion to adjourn.


On motion of Councilor Boucher, duly seconded by Councilor Bona it was VOTED to adjourn.

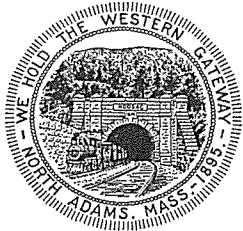

A meeting of the North Adams City Council was held at 7:30pm in City Council Chambers with the following present:

A moment of silent prayer was observed, remembering Stanley Owczarski, "Mr. Volunteer", among the many organizations he served were: the Friendship Food Pantry, Northern Berkshire YMCA, National Ski Patrol, Big Brother Program, annual Rock and Rut Mountain Bike Festival. He was a Certified Red Cross CPR Instructor and volunteered at Sullivan School.

On motion of Councilor Buddington, duly seconded by Councilor Moran it was VOTED: to grant the license.



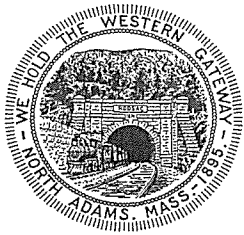



A meeting of the North Adams City Council was held at 7:30pm in City Council Chambers with the following present:

COUNCILORS PRESENT: Blackmer, Boucher, Bona, Buddington, Bullett, Lamb, Merrigan, Moran, Moulton.

A moment of silent prayer was observed.

The President called for the approval of the minutes from the meeting of January 26, 2016.

On motion of Councilor Blackmer, duly seconded by Councilor Boucher it was VOTED: to accept the minutes as presented.

The President presented Council Rules of Order which were referred to the General Government Committee at the meeting of January 12th.

On motion of Councilor Merrigan, duly seconded by Councilor Blackmer it was VOTED: to postpone to the meeting of February 23rd.

11,497 The President presented Mayor's communication #5 regarding a lease agreement with Child Care of the Berkshire.

Without objection the President placed the communication on file.

The Mayor noted that Child Care of the Berkshire has been a tenant of the former Haskins School building for more than 34 years. During this time CCB has kept the facility bright, clean and up to date making it a place where children and parents feel welcome and nurtured. Over time they have greatly improved accessibility and safety for the children. Ann Nemetz Carlson, President and CEO of CCB are committed to providing excellent child care. Through private grants she has made many changes to improve the facility. The City has a short term lease with CCB whereby CCB provided maintenance and improvements while the City retained responsibility for the buildings larger capital items. CCB has applied for a larger grant through the USDA that will enable them to do significant building improvements. In order to qualify they need to have site control of the building, which means that they need a long term lease. To help them and maintain their services here in the City.

- 11,498** An Order authorizing the Mayor to execute a lease between the City of North Adams and Child Care of the Berkshire.

On motion of Councilor Blackmer, duly seconded by Councilor Moulton it was VOTED: to adopt the Order.

Ann Nemetz Carlson, President of CCB said with this grant they will bring the century old building up to code, including handicapped accessibility along with an elevator, new windows and a heating system.

Councilors were all in agreement that Child Care of the Berkshire is a big asset to the community. Councilor Moulton was a little concerned about the length of the lease, he feels that 25 years is a longtime.

The Order was adopted by yea and nay vote as follows; yea Councilor Blackmer, Bona, Boucher, Buddington, Bullett, Lamb, Merrigan, Moran, Moulton. Nay none.

On motion of Councilor Lamb, duly seconded by Councilor Blackmer it was VOTED: to form the ad hoc committee and postpone the meeting of April 12th.



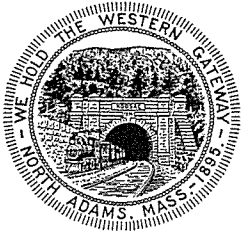

A meeting of the North Adams City Council was held at 7:30pm in City Council Chambers with the following present:

COUNCILORS PRESENT: Blackmer, Boucher, Bona, Buddington, Bullett, Lamb, Merrigan, Moran, Moulton.

A moment of silent prayer was observed.

The President called for the approval of the minutes from the meeting of February 9, 2016.

On motion of Councilor Blackmer, duly seconded by Councilor Boucher it was VOTED: to accept the minutes as presented.

The President presented the report of the General Government Committee regarding the Council Rules of Order.

Councilor Merrigan gave the report of the committee noted there was a wide range of discussion about the proposed change. The committee reviewed rule 7 and 10, both which concerned public participation at the Council meetings. The most significant change would be in moving Open Forum to the beginning of the meeting. The proposed Hearing of Visitors at the beginning of the meeting would eliminate the public input on agenda items when presented. The data from the Bureau of Substance Abuse Services said the number of people seeking treatment for addiction of any kind has increased by 47%. There is a huge need for clinical stabilization detox for 24 hours and education for inpatients. Sarah said the best chance for recovery is if BMC meets the needs of our community. Nykole Roach also spoke about the importance of opening a facility at BMC North for substance abuse. Several Councilors were concerned about the percentages of North Adams residents seeking treatment for substance abuse. They questioned how North Adams percentages skyrocketed so much. Ms. Roach said it was because of economic distress and the lack of job opportunities in the community. Councilor Blackmer said that southern Berkshire faced a similar epidemic and various community groups came together to fight the problem and they did not rely solely on the hospital. Councilor Blackmer said it was a very interesting report and appreciates the work but I think sometimes information can be skewed to what you want it to represent. She noted that this was conducted by a group that has advocated for additional health care services at BMC in North Adams.

Henry Jaeschke of 62 Chase Ave was concerned about the frequent offenders when it is short term. It seems there should be more education about detox. A.J. Cote of Adams said he has lost several friends to drugs and what is needed is a cultural change and an economic revitalization. We lack health care and BMC should be held accountable.

11,524 The President presented a communication submitted by Councilor Moulton regarding signage on the lower half of Route 2.

On motion of Councilor Moulton, duly seconded by Councilor Blackmer it was VOTED: to refer to the Traffic Committee and postponed at the meeting of June 14th.



Vice President Bullett in the Chair

On Roll Call the following responded: Councilors Blackmer, Bona, Boucher, Bullett, Moran, Moulton. Councilor Buddington, Lamb, Merrigan absent.

A moment of silent prayer was observed.
The Pledge of Allegiance was recited.

The President said that we would begin our tour of the DPW buildings and return back to Council Chambers for discussion.

Councilor Merrigan entered the meeting at 5:33pm.

Councilors were given a tour of the Park & Recreation building, the land adjacent to the skating rink which would give the City more cemetery lots, the cemetery building, the salt shed on Ashland Street and finally the City Yard.

Tim Lescarbeau, Michael Canales and Ross Vivori were all in attendance. Mr. Lescarbeau noted the Park & Recreation shed was not too bad, but there was water damage to the building because of leaks in the roof. The Mayor said they would need to remove part of the building for the new water park. Next Mr. Lescarbeau showed them the piece of land the runs along the back of the Hodges Cross Road building and is adjacent to the cemetery, which can be used for more lots. The next stop was the cemetery building and they saw the rotting taking place in that building. Mr. Lescarbeau noted it cost more to heat this building than City Hall. The second smaller building will stay to store some of the equipment used at the cemetery. The salt shed on Ashland Street is also unsafe and there is a lot of water damage to the building. The large dump truck that delivers the salt and sand cannot back into the building because the opening is too small and the sand has to be pushed from the outside in. Mr. Lescarbeau pointed out the expensive machinery that has to be left outside and causes it too rust. Last stop was the City Yard which showed extensive water damage, no ventilation and very unsafe conditions for the workers. Mr. Lescarbeau said that where the offices are, was the old pump house built in 1874.

When the tour ended the Council went back to Council Chambers to continue the meeting.

11,539 The President presented an order authorizing the Mayor to enter into a purchase and sale agreement with 59 Hodges Cross Road, LLC., which was postponed at the meeting of August 23rd.

On motion of Councilor Bona, duly seconded by Councilor Boucher it was VOTED: to adopt the Order.

The Mayor thanked Councilors and the public who attended the tour of the buildings.

Councilor Bona said he had a list of questions he had put together based on his questions and those he had seen on social media. Councilor Bona asked the President if they could just have the Mayor address the questions he had listed. Council President said that would be appropriate.

What would happen to the current DPW buildings?

Is current DPW property contaminated and would city be required to clean?

Could MCLA buy DPW property? Pros and cons

Is it in a flood zone? If so, how does that effect insurance, and does additional protection need to be built?

Does the state have grants to refurbish present buildings?

Wouldn't it create a lot more industrial traffic next to school?

What is the estimated income from 2400 new cemetery plots?

What is the estimated income from solar facility to be installed?

Is property contaminates and if so cost to clean up?.

Would this income go toward reducing the debt of the property purchase?

Can the city afford it at this time?

What are the city's alternatives?

Has the city tried to market the proposed property to business that could bring much needed jobs to the city?

How would the DPW deal with the distance from the west end? Mowing and other equipment often times have been driving across town to fill up, wasting time and money. This could be worsened due to the farther location. Can a refueling vehicle or substation be part of the solution?

Is the DPW truly the highest priority? Police and fire buildings need to be updated as well

Can sales of the 2400 projected lots be used to directly pay off debt on DPW building instead of going in general fund? Maybe an enterprise fund?

What would cost of new building same size be?

Could public safety building be built on current DPW lot?

Will DPW staff occur overtime during moving, and/or will this affect scheduled projects from being completed until future date.

Worst case scenario, how much would this effect annual average tax bill?

The proposed property abutting Southview Cemetery was part of Southview Cemetery till the mid-sixties.

Why are we "purchasing property" when we have the right as a city to return the land back to the Southview Cemetery usable acreage at "0" cost regardless of purchasing the building?

Why are we offering asking price? Didn't they buy it at around \$600K? Where are the \$400k of improvements?

Are there any back taxes owed on the building? If so how is that being handled with the proposed purchase?

The Mayor addressed all the questions outlined for him. A large concern was about contamination which the Mayor said a recent environmental study was done and they did not find any contamination but it is being reviewed by Tighe & Bond, the purchase is contingent on the outcome. The Mayor estimated it would have an \$80,000 a year impact on the budget, that is from the \$55,000 in payments, the loss of \$58,000 in property taxes and a gain of \$32,000 from the planned solar array site. The average tax bill could be increased by \$10.00. The solar company already has an agreement with Berkshire Anodizing and that agreement would slide over to the City. Michael Canales said it would pay \$23,000 a year in lieu of taxes and an additional \$9,000 in the leasing of the land, over the next 20 years.

The Mayor said the additional land for Southview Cemetery could mean possibly 3,000 more grave sites, at a cost of \$500.00.

Councilors are all in agreement that something has to be done about the dilapidated structures, but the concern is the amount of money that would have to be borrowed; \$995,000 for the 85,000 square foot building and the 30 acres, \$107,000 for the immediate needs of the DPW, which they can do and about \$350,000 for interior work to transform the building into the needs of the DPW.

The Mayor said it was a good deal because it would have cost about \$2.7 million three years ago to build a new building. Mr. Lescarbeau said the anodizing plant is in good condition and would serve the City well, the bones of the building are good, as in any building you're going to have to do something with them. Mr. Lescarbeau noted that 3 years ago the cost to rebuild a new building was \$2.7 million.

Councilor Moulton felt it would be better to have a private operation in there bringing jobs. Councilor Blackmer said she was not ready to approve such a large purchase unless negotiations are attempted.

Mark Trottier, Woodlawn Avenue and Alice Candi of Corinth Street objected to the purchase of the building noting the cost was too high. Peter Breen of Charlene Street made a point that the City already has rights to the piece of property by the cemetery.

The City Solicitor is going to check back on the deed that Mr. Breen is referring to.



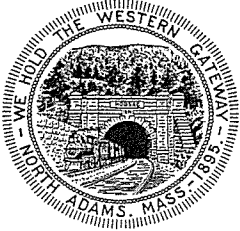

He noted that they would have to install overhead doors for the trucks and a large overhead door in the back of the building where the salt and sand would be stored. Mr. Lescarbeau also noted they would be putting in a road around the building.

Nate Girard from Greylock Realty and John Bordeau were also in attendance to answer questions. They noted the building was built in 1969 and a new roof was done in 2012.



On motion of Councilor Bona, duly seconded by Councilor Boucher it was VOTED: to adopt the Order.

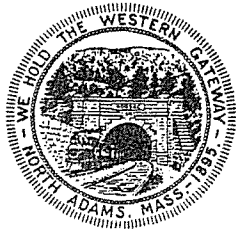

Councilor Bona said Councilor Bullett hit the nail on the head when she said it is really a safety issue, noting the City has many employees working in very unsafe conditions.

Councilor Moran read a letter from Jason Moran, member of the Conversation Commission, a former member of the Colegrove Building Committee and the Colegrove Finance Sub-Committee. He said as a person in the construction industry and someone currently responsible for construction of a cold storage building to be completed in the fall that has a 12,000 square foot footprint at a price of 1.5 million, the proposed total price of this project and the work required to outfit for a use of a DPW facility appears to be a great deal for the City of North Adams. I do support proceeding to the next level in purchasing this property for the DPW use.





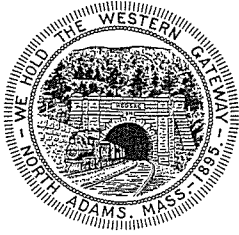

The President called for Hearing of Visitors, Mr. Cardimino, 173 East Quincy Street wants to see a robo call go out informing residents of the break-ins, and drugs in the City. He said if the Mayor does not do that he will go around the City with a sign letting people know what is going on in the City. Carolyn Clark and Merle Knight of Temple Street spoke on the crimes that have been occurring at their home and the police have been of no help to them.

The Mayor said it could be considered if the proposal was good and the Council agreed. He feels that is very unlikely and there are serious concerns that the damage could become catastrophic.

William Meranti, the City Building Inspector said the church is not in danger of collapsing, but they are concerned that the weather will put more pressure on the weakened buttresses. The building is otherwise in good shape, no signs of water damage or cracks in the foundation. In 2008 the steeple had painting done and the roof was repaired. Mr. Mirante said the freeze-thaw cycle in an unheated building is taking a toll on the paint and plaster which is showing signs of decay. He said the damage was discovered in early spring, which was caused by the theft of the copper gutters and it is unknown when the theft had occurred.

Councilors were concerned that if the gutters were replaced it would only make it a target again to theft. They wonder how the City would ensure this did not happen again.

Mr. Meranti said the gutters would be galvanized or PVC and not worth much to someone who wants to steal them.

11,545 The President presented a communication submitted by the Planning Board requesting a Joint Public Hearing regarding a Zoning Ordinance for Solar Energy System.

Without objection the President set the Public Hearing for October 25th at 7:30pm.



A moment of silence was observed remembering Theresa Bellini who taught business and was Chairwoman of the Business Department at McCann Technical School, and Administrative Assistant to the superintendent. Louis Zocchi, long time North Adams Police Officer. Raymond Burdick, first Chairman of the Northern Berkshire Department Corporation.

The President called for Hearing of Visitors, Jack Savage, 77 Yale Street was concerned about the solar site, the mountains are a vital resource to the City and we are destroying them by allowing solar. Michael Chalifoux, 54 Monroe Street urged the Council to vote no on the borrowing order for the DPW building, saying it is not worth a million dollars. Mr. Cardimino, 173 East Quincy Street complained about the City Clerk after visiting her office during the day.

The President called for the approval of the minutes from the meeting of October 11th.

On motion of Councilor Buddington, duly seconded by Councilor Moulton it was VOTED: to accept the minutes as presented.

The President declared the Public Hearing Open regarding a new Zoning Ordinance for Solar Energy.

Chairman Leary turned the hearing over to Michael Canales, Administrative Officer for the City. Mr. Canales said the ordinance had been review by legal counsel.

from different locations. They submitted drawings to show us what they felt it would look like, and the board was happy with those drawings.

Planning Board member Bond left the Public Hearing at 8:15pm.

Councilor Moulton and Council President Lamb questioned if there was any recourse or enforcement.

Mr. Canales and Chairman Leary believed the Building Inspector could enforce the conditions of a special permit. Mr. Canales noted the importance of this Ordinance which would ensure that rights and obligations were spelled out. The Planning Board can only require site plan approval to be sure the project meets existing building codes and setbacks. This Ordinance would give the Planning Board the tools needed to deal with people coming forward with solar projects.

Jack Savage, 77 Yale Street said he does not know how this was allowed in the first place, saying he could see the clear-cut area while driving his car near the college. It is more visible since the leaves are gone from the trees.

Michael Chalifoux, 54 Monroe Street said solar was just a scam and the damage is already done. "Where did the government fail us" was his question.

Mr. Canales said that permission to clear cut on the mountain top did not fall under the Planning Board or the City.

Councilor Blackmer was concerned about the RU-1 zones because it involves the whole City.

Councilor Buddington wanted a better definition of farmland to ensure it was properly protected.

The President declared the Public Hearing Closed.

11,552 The President presented a communication submitted by Councilor Bona regarding a presentation from the Berkshire County Education Task Force Planning Study.


Without objection the President placed the communication on file.

REGULAR MEETING OF THE CITY COUNCIL December 13, 2016

A meeting of the North Adams City Council was held at 7:30pm in City Council Chambers with the following present:

COUNCILORS PRESENT: Blackmer, Bona, Boucher, Buddington, Bullett, Lamb, Merrigan, Moran, Moulton.

A moment of silence was observed remembering Ronald Goss, member of the first faculty at McCann Vocational Technical High School in 1962 and taught there for 18 years. He coached both football and baseball and became its first Athletic Director. Joseph Cariddi, Post Commander of the North Adams and Berkshire County American Legion. Chairman of the "Be Our Guest" Christmas Day dinner for 39 years. Served on the Veterans Committee for the North Adams Memorial Day and Veterans Day celebration for many years.

The President called for Hearing of Visitors, Mark Trottier, 131 Woodlawn Avenue was concerned about the water problem in the schools, especially at the new school. There are notes for the children not to drink the water and the little kindergarten children cannot read those signs. The Mayor responded that they are aware of the situation and it is being addressed. The pipes are being flushed, but it does take time for them to clear out.

The President called for the approval of the minutes from the meeting of November 22nd.

On motion of Councilor Buddington, duly seconded by Councilor Moulton it was VOTED: to accept the minutes as presented. Councilor Bullett abstained because she was absent from that meeting.

8717-35 The President presented Mayor's communication #50 recommending a Public Hearing for the Tax Levy for FY'17, which was set for December 13th.

The President declared the **PUBLIC HEARING OPEN**

The Mayor explained that based on factor assumptions, the FY'17 tax levy will be \$16,139,266 an increase in levy of 2.58% over FY'16. The Mayor recommends maintaining CIP shift at 1.71%. The increase in rates (per \$1000 valuation) is as follows:

Residential from \$17.39 to \$17.70 (approximately \$83.00 annual increase on a single family home valued at \$136,900).

CIP from \$37.93 to \$38.54

Councilor Boucher asked what the impact would be if the City went with a shift of 1.75, which would put more of the tax on businesses.

The Mayor said it would reduce the average taxpayer's bill about \$40.00 and put more pressure on small businesses. He noted our commercial tax rate is bordering on the excessive and we need to keep an eye on that.

Councilor Blackmer pointed out that small business also pay personal property tax on their equipment and inventory.

Councilor Boucher said he did not like to see the taxes rise but it is necessary in order to keep the services that are needed. Residents get upset when something is not right, if you want that high level of service we receive, then we have to move forward with this.

The Mayor said he does not like coming in with increases, but the City has had seven years of backward budgets, normal costs continue to increase and we are gaining, but since 2009 the City has lost \$27million in State Aid. The region is seeing an increase in housing sales, new growth and higher home valuations. This gives the City some breathing room.

Ross Vivori, City Assessor said sale and prices in the region are rising.

Robert Cardimino, 173 East Quincy Street does not believe the values on housing are going up.

The President declared the **PUBLIC HEARING CLOSED**

Without objection the President moved Council paper #11,553 forward.

11,553 The President presented Mayor's communication #51 regarding a program with our city youth called "Running with The Law".

Without objection the President placed the communication on file.

The Mayor said that Jim Holmes has been working with the local police officers developing this program. Senator Downing offered citations for the officers involved and had the students to present them to the officers.

After the first growing season, mowing may not be used between May 1 and August 1, in order to protect pollinator forage and ground-nesting birds.

Councilor Moulton felt this was making North Adams a "Sanctuary City". Councilors were in agreement with the resolution, but felt some of the language needed to be reviewed.

On motion of Councilor Blackmer, duly seconded by Councilor Boucher it was VOTED: to postpone to the first meeting of January.



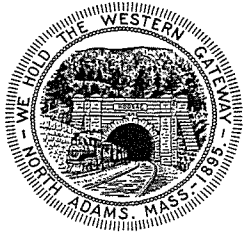

Robert Lyons of Lyman Street was in opposition to the resolution stating there may be a loss of federal funding.


Several Councilors expressed that they were in agreement with the resolution, but felt it needed further review and would like to see it referred to the Community Development Committee for more public input.
