A resolution to transfer responsibility of a 2010 Chevy Tahoe SUV from the Sheriff's Office to the Clerk's Office

WHEREAS, the Okanogan County Sheriff's Office has a 2010 Chevy Tahoe vehicle that is deemed unsuitable for the uses of the department; and

WHEREAS, the Okanogan County Superior Court Clerk has a need for use of a county vehicle for the transaction of business between the different court locations; and

WHEREAS, Both the Sheriff and the Clerk's Office budgets are within the County's Current Expense fund; and

WHEREAS, responsibility for the Chevy Tahoe vehicle asset will need to be transferred from the Sheriff to the Clerk;

NOW, THEREFORE, BE IT RESOLVED by the Board of Okanogan County Commissioners that the 2010 Chevy Tahoe with VIN No.1GNUKAE07AR127715 be transferred from the Sheriff's Office to the Superior Court Clerk's office and hereby directs each department to make the necessary departmental ownership changes in Eden for asset identification and to inform the Risk Manager of the change for insurance purposes.


